E. Certificates of Appropriateness:

1. Discussion and possible action regarding CA-25-26-2, request by the City of Oklahoma City on behalf of the owner, Roderick Taft, for a certificate of appropriateness for replacement of ten wood windows with custom aluminum-clad wood windows on the principal dwelling at 921 NE 17th Street in the Lincoln Terrace East Historic District:

Stephanie Barbour-Cooper moved to approve item E.1, which involves replacing ten deteriorated wood windows with aluminum clad wood double hung windows with simulated divided light that replicates the divided light patterns of the original historic windows. Carla Splaingard seconded the motion. The following votes were recorded, and the motion passed:

2. Discussion and possible action regarding CA-25-26-6, request by Dayna Wagester for a certificate of appropriateness for replacement of 29 vinyl windows with custom wood windows on the principal dwelling at 948 NE 17th Street in the Lincoln Terrace East Historic District:

Rachel Smith moved to approve item E.2, the replacement of windows, which requires the new windows to match the divided light patterns of the original historic windows on the house. Stephanie Barbour-Cooper seconded the motion. The votes were recorded, and the motion was approved.

- b. Installation of fascia trim board for the attachment of gutters on the principal dwelling.
- c. Conversion of the addition on the east side of the principal dwelling into a covered, unenclosed porch.
- d. Demolition of the detached garage due to dilapidation.
- e. Construction of a detached garage.
