RV Dealers, currently licensed by the OMVC, adding new line-makes of Motor Homes or adding new RV Towables

It is unlawful to sell or advertise or any new Motor Homes or RV Towables for which no license is held. Sanctions such as fines or denial of license may be imposed for non-compliance.

Very Important! The Manufacturer/Distributor of the vehicles which you plan to sell, must already be licensed by this Commission. Have you checked to see if they are licensed?

CAREFULLY FOLLOW THE CHECKLIST BELOW TO MAKE A COMPLETE APPLICATION:

 1.	DEALER APPLICATION FORM : Form must be legible, complete, signed and notarized. IF WE CAN'T READ IT, WE WILL RETURN IT. TYPE OR PRINT LEGIBLY. Answer all questions.
2.	FINANCIAL INFORMATION : Submit a Company Balance Sheet . Do not submit personal Financial information. The Balance Sheet <u>must be certified</u> by an officer of the company, and <u>current within the last 60 days</u> . A blank form is included in this packet for your convenience or you may submit your own, but make sure it is signed and certified that it is accurate.
 3.	<u>MANUFACTURER/DISTRIBUTOR(S)</u> : Provide list of names, addresses, phone numbers and contact persons for the manufacturers and/or distributors for whose products you seek to add.
4.	DEALER AGREEMENT(S): Application may be submitted and considered by the Board without these document(s). The Board can choose to approve the application "contingent upon" receipt of the Dealer Agreement(s). Keep in mind the actual franchise license(s) will not be issued until the Dealer Agreement(s) are received.
5.	FEES: There are <i>two separate fee structures</i> ; one for Motor Homes and another for Towables, as follows: Motor Homes: \$300 per manufacturer line-make Example: Winnebago Minnie Winnie, Tour & View are 3 separate line-makes; license fee is \$900.00 RV Towables: \$300 per manufacturer represented Example: Dealer can sell all types and models of RV Towables manufactured by Winnebago; license fee is \$300.00. Payment options are Credit Card or E-check. Credit Card fees: \$2 per transaction plus 2.25% merchant fee. E-check fee: \$1.00 per transaction. License Fees are non-refundable unless application is denied.
6.	<u>DEADLINE</u> : Applications are considered by the Board on the second Tuesday of each month ONLY. The deadline to submit an application packet is the Monday <i>eight days prior</i> to the Commission Meeting. NO EXCEPTIONS!
