## MINUTES OF A MEETING OF THE OKLAHOMA NEW MOTOR VEHICLE COMMISSION

In conformity with the Oklahoma Open Meeting Act, advance notice of this special meeting was transmitted to the Oklahoma Secretary of State on August 1st, 2024. Public notice of this meeting, together with the agenda, was posted in prominent public view on the front door of the Northwest Office Center, 4334 NW Expressway, Oklahoma City, on August 4th, 2024 prior to 10am, and, announcement of the Board meeting and agenda were posted on the ONMVC website <u>https://oklahoma.gov/onmvc.html</u> on August 4<sup>th</sup>, 2024 prior to 10am.

The Oklahoma New Motor Vehicle Commission met in a Special Meeting at 10:00 am, on August 5, 2024. Chair Curtis Hayes called the meeting to order. A roll call was held; members present were Eric Stuteville, Jared Glover, Cassie McGlothlin, Jim Norton, Jeff Johnson, Jackie McClintock, Jeromey Clayton and Curtis Hayes. Commissioner Seth Wadley was absent.

The Chair announced that there were enough members present to constitute a quorum. Also present were Brad Bailey, Executive Director, Marilyn Maxwell, Deputy Executive Director, Sandra Balzer, Assistant Attorney General via teleconference and Peter Hodges and Tonya Pogue of the Oklahoma Auto Dealers Association.

## Discussion and Action for Opening Official Rulemaking Record and for Adopting Emergency Rules Regarding the Implementation of New Temporary License Plates & Procedures for Registration of Temporary License Plate Vendors

The Director presented proposed emergency rules amending ONMVC, Chapter 20, Temporary License Plate Rules Subchapters 1 and 3 governing the design, form, substance, and content, dealer record keeping responsibilities, location and visibility of redesigned temporary license plates. Furthermore, the proposed emergency rules will add Subchapters 5 through 11 governing the registration, operation, software, security requirements, enforcement provisions and fees required of authorized Temporary License Plate Vendors. The Director also presented a sample copy of the Temporary License Plate Vendor Initial Application for review and comment by the Board.

After review and discussion by the Board, a motion was made by Jared Glover, seconded by Jim Norton to open the official rule making record and adopt the proposed emergency rules for Chapter 20, Temporary License Plate, as amended. The Chair called for a roll call vote; votes were as follows:

Motion passed unanimously.

Next item on the agenda, was the discussion of the use of tools such as Office of Foreign Assets Control and Financial Crimes Enforcement Network searches and other methods such as criminal background checks to provide additional information when considering the various ONMVC licenses and registrations.
