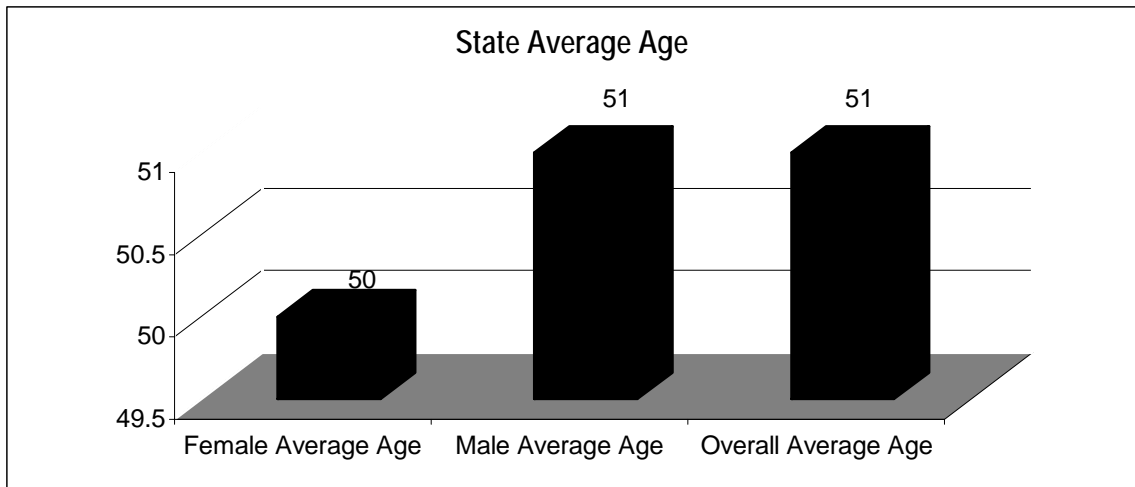

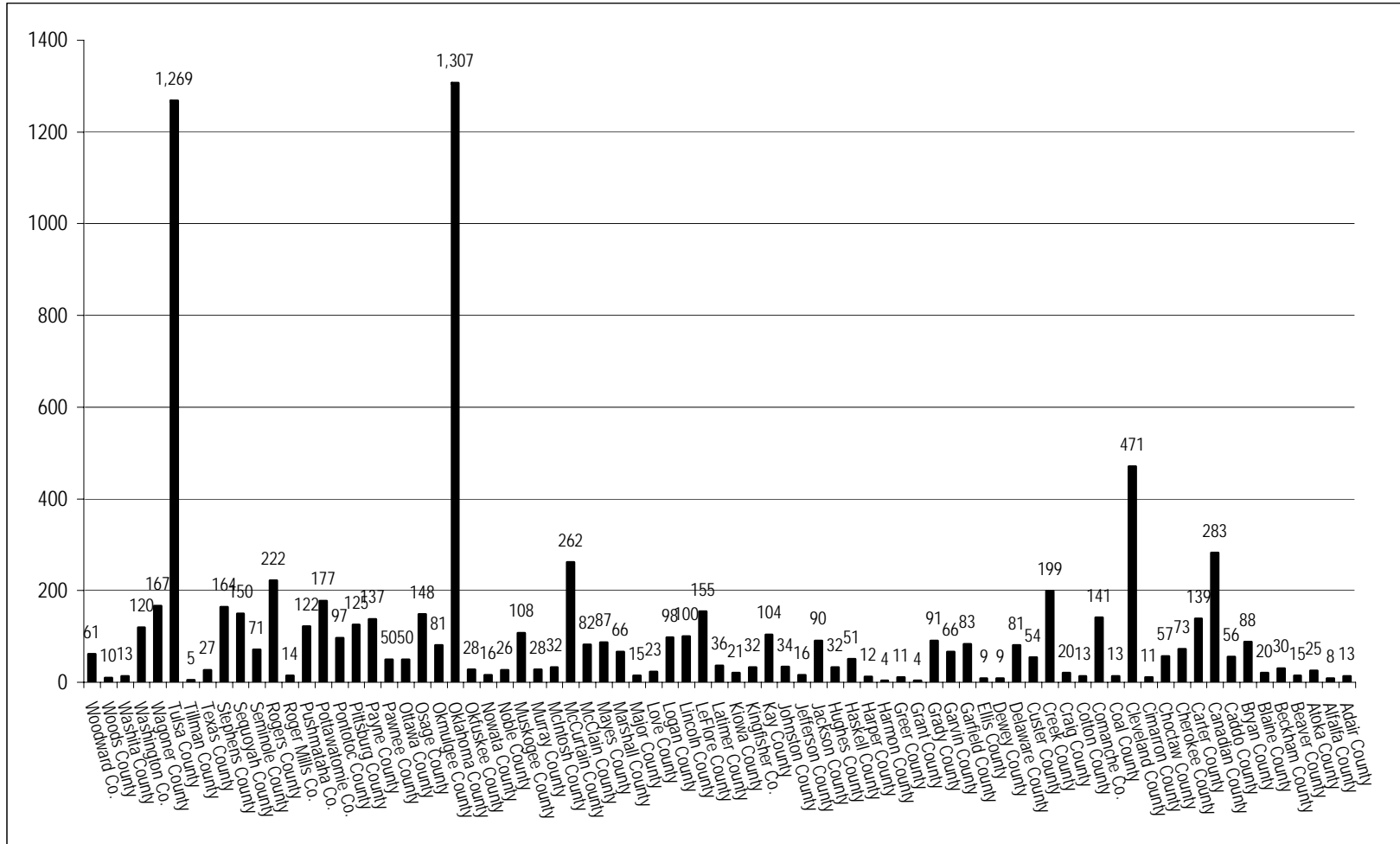

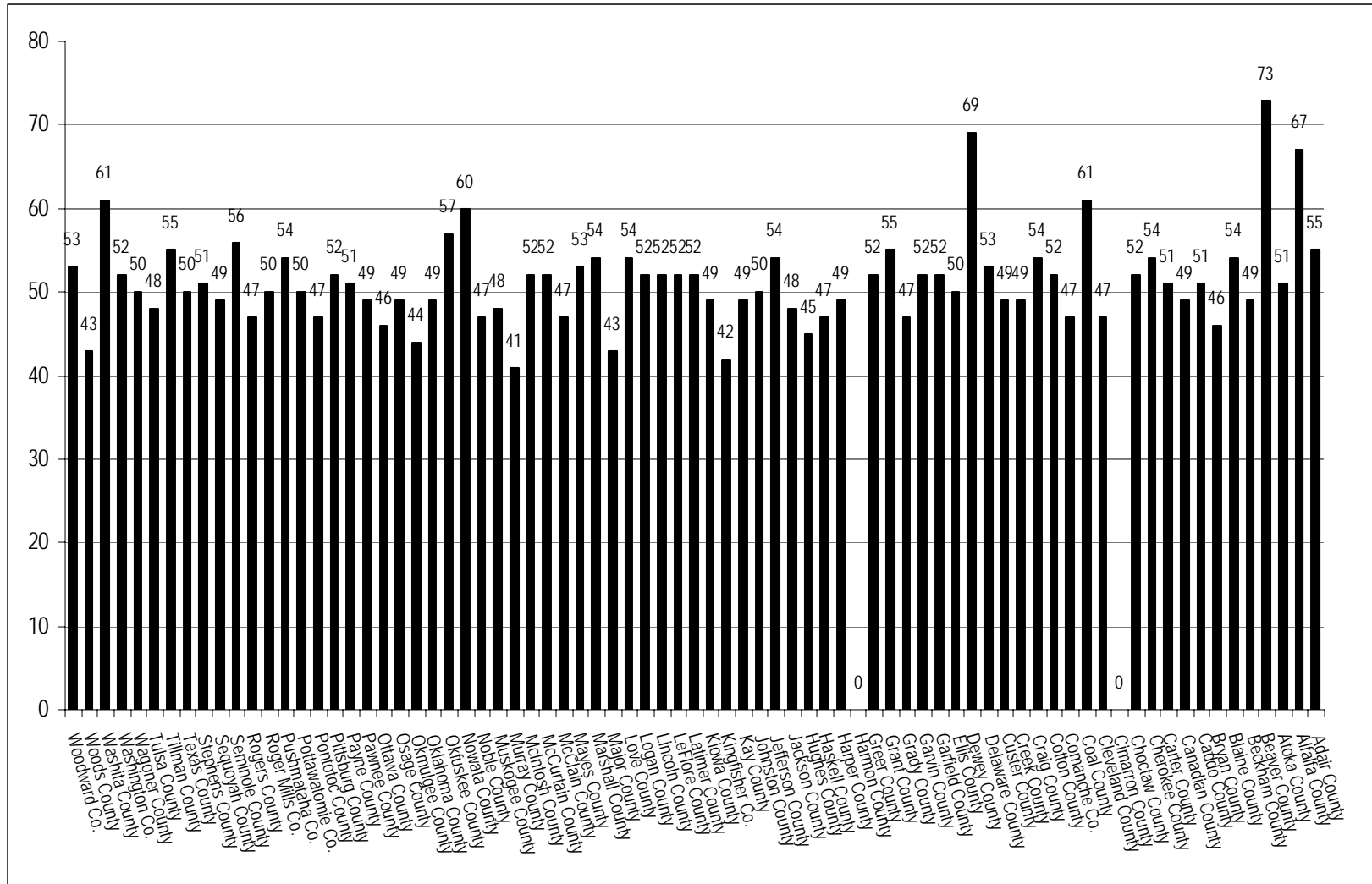

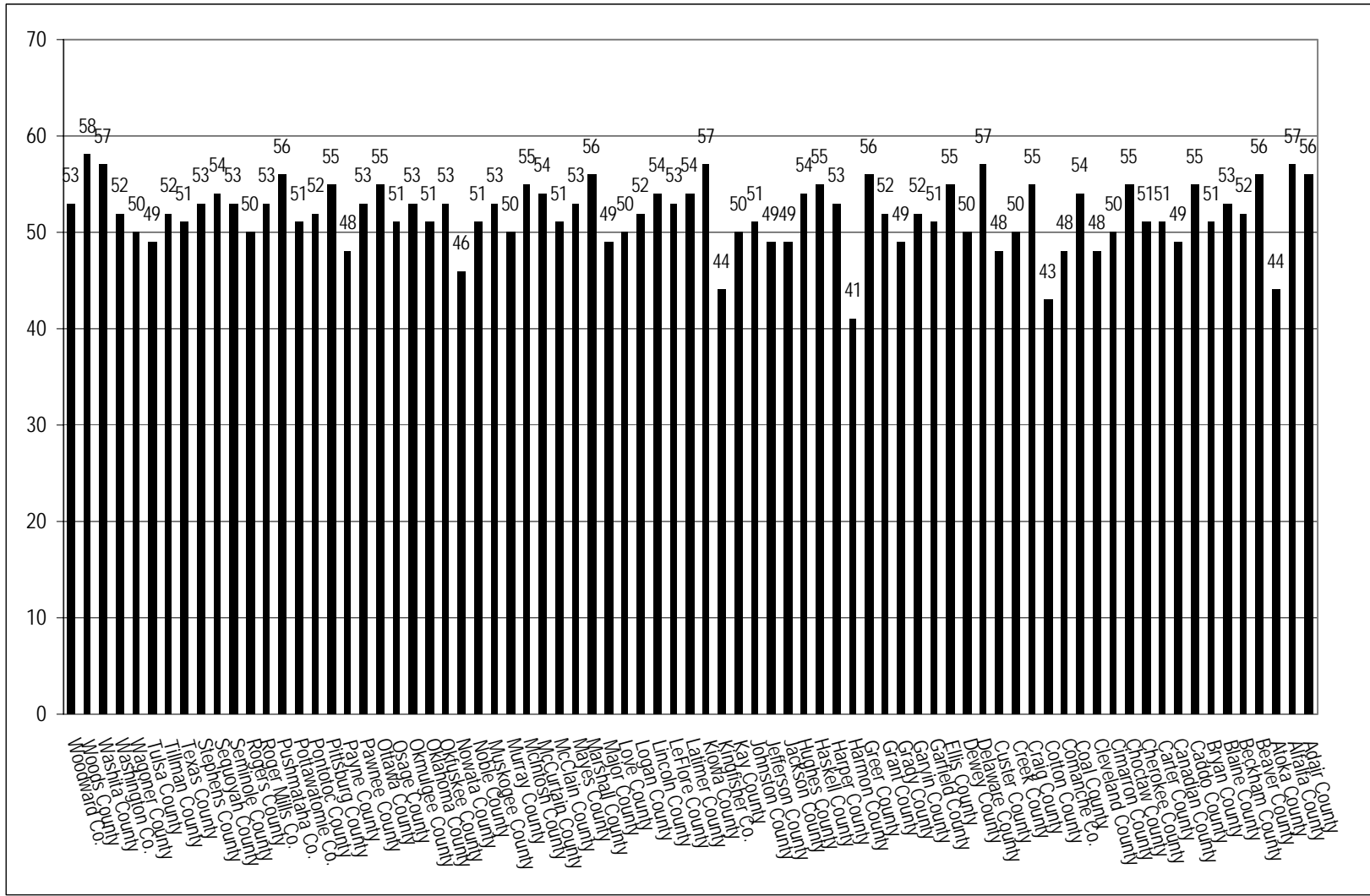
APPROVED BY COUNTY - TOTAL NUMBER



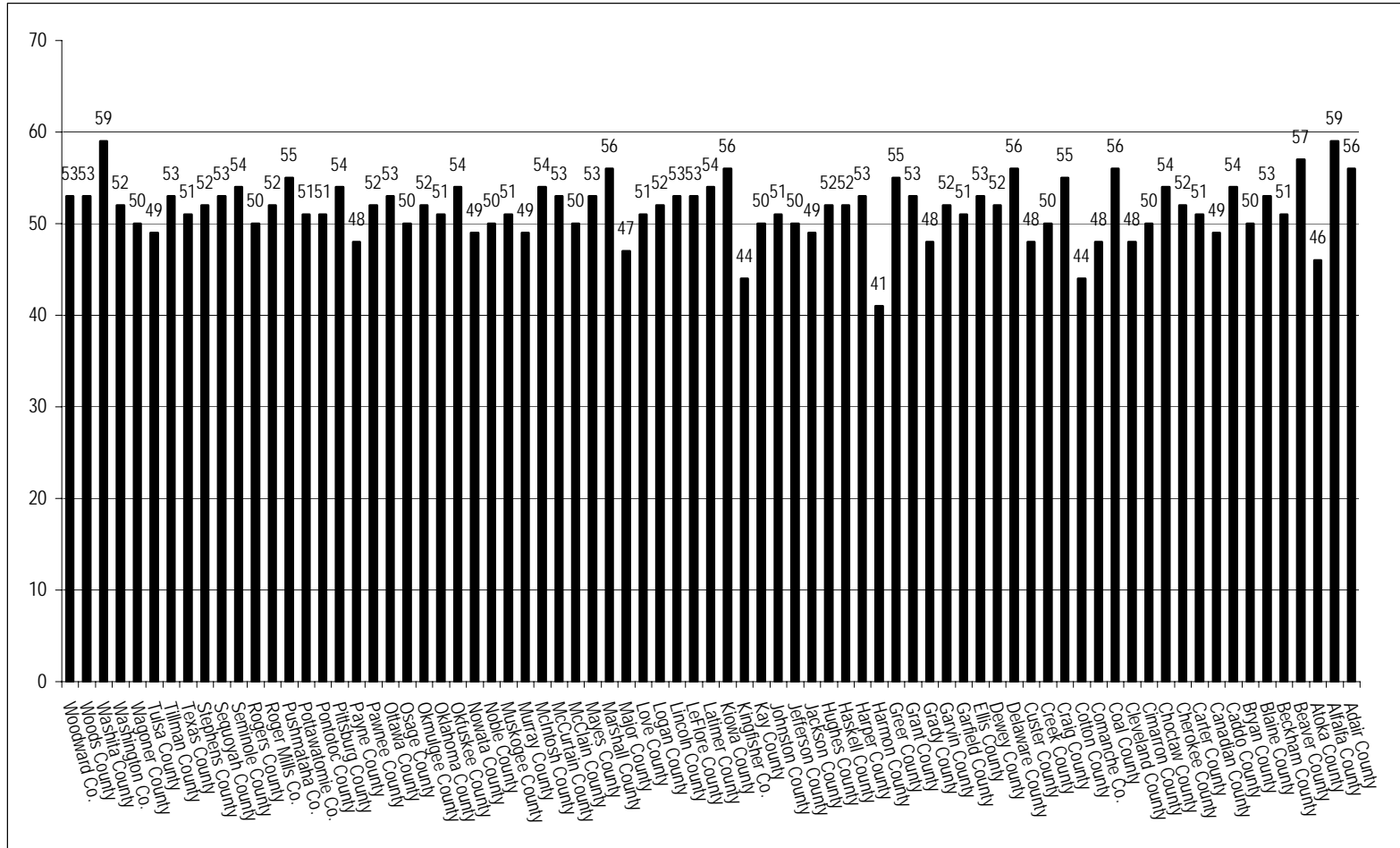
AVERAGE FEMALE AGE APPROVED - BY COUNTY

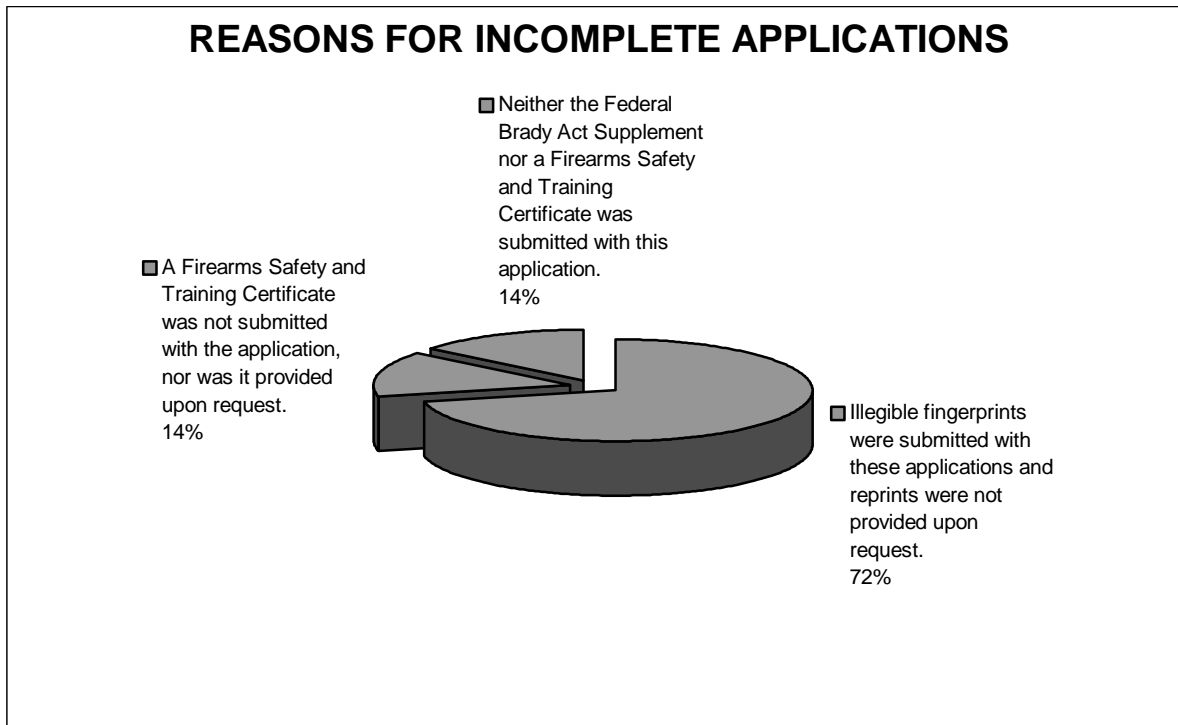

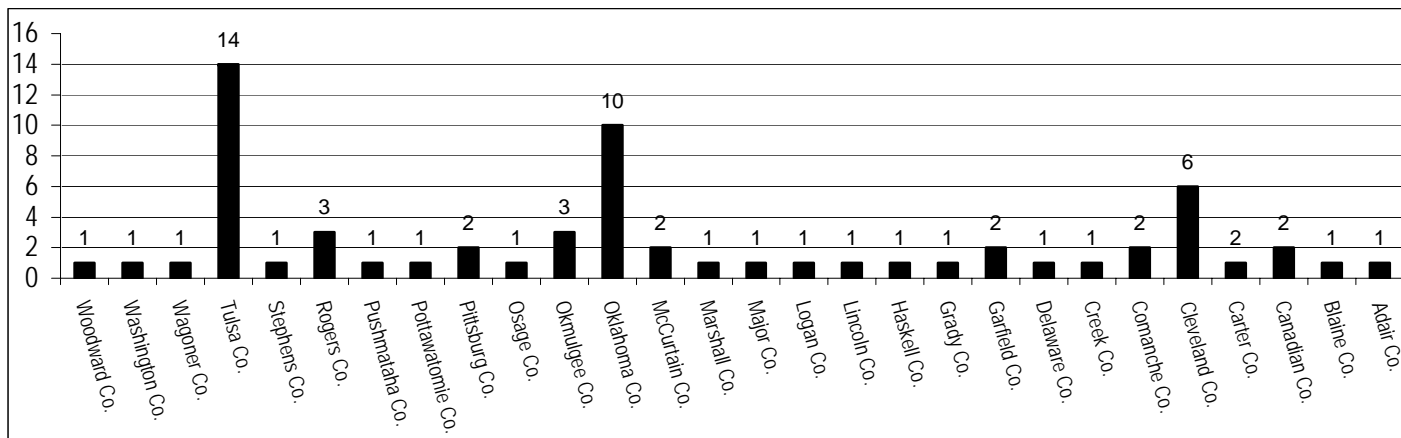

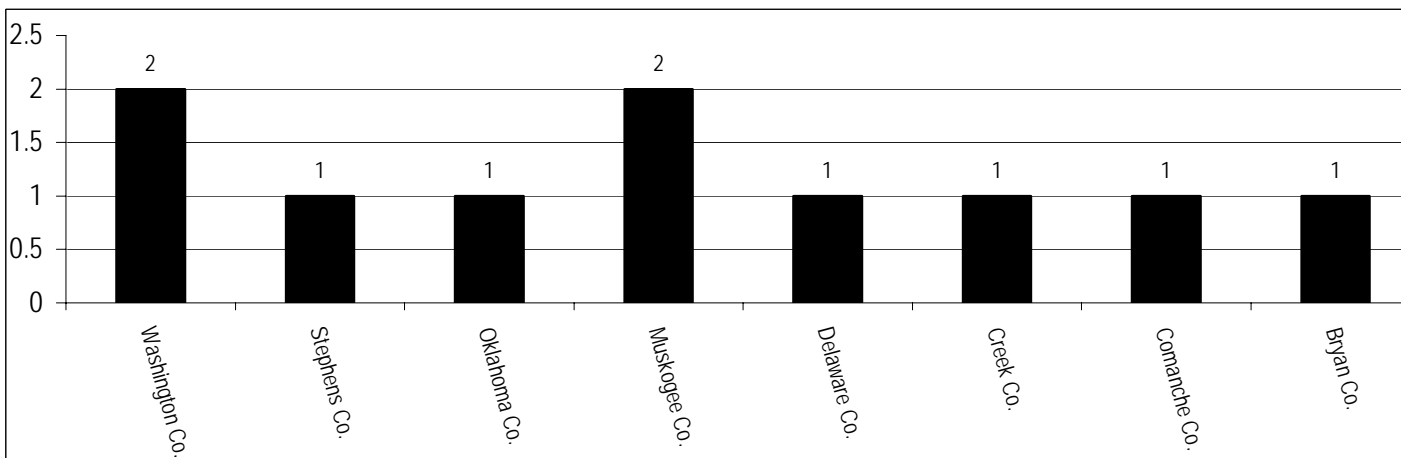
