SIGNED BILL INCLUDING SDA LAW BOOK SECTION IMPACTED	CHANGES MADE EFFECTIVE NOVEMBER 1, 2025
HB1095 TITLE 21 O.S. §1277 – UNLAWFUL CARRY IN CERTAIN PLACES	"Municipal Carry Act" Addresses how and when a municipal judge, elected official of a municipality or municipal employee in possession of a valid handgun license may carry a firearm.
HB 2104 TITLE 21 O.S. §1278 – UNLAWFUL INTENT TO CARRY	Made violating sections of this statute a Class B4 felony.
HB 2104 TITLE 21 O.S. §1283 – CONVICTED FELONS AND DELIQUENTS	Clarified offense classification.
HB 2104 TITLE 21 O.S. §1287 – USE OF FIREARM WHILE COMMITTING A FELONY	Clarified offense classification.
HB 2104 TITLE 21 O.S. §1289.16 – FELONY POINTING FIREARMS	Clarified offense classification.
<b>HB 2104</b> TITLE 21 O.S. §1289.17 – PENALTIES FOR 1289.16	Clarified offense classification.
HB 2104 TITLE 21 O.S. §1289.17A – FELONY DISCHARGING FIREARMS	Clarified offense classification.
<b>HB 2104</b> TITLE 21 O.S. §1289.18 – DEFINITIONS	Clarified offense classification.

HB 2104 TITLE 21 O.S. §1290.21 – REPLACEMENT LICENSE	Clarified offense classification.
HB 2818 TITLE 21 O.S. §1279 – MISDEMEANOR POINTING A FIREARM	Removes the administrative violation for individuals with a handgun license.
HB 2818 TITLE 21 O.S. §1280 – MISDEMEANOR POINTING A FIREARM	Modifies the penalty for conviction of misdemeanor pointing a firearm.
HB 2818 TITLE 21 O.S. §1289.16 – FELONY POINTING FIREARMS	Modified language to include lawfully pointing a deadly weapon in certain situations
HB 2818 TITLE 21 O.S. §1289.25 – PHYSICAL OR DEADLY FORCE	Changes title to "Physical or Deadly Force" Added "occupied premises" throughout statute. Updated verbiage. Added subsection regarding defensive display of a firearm.
SB 541 TITLE 57 O.S. §571 – VIOLENT CRIME DEFINITIONS	Added "subsequent offense of domestic assault and battery" and "domestic abuse against a pregnant woman with knowledge of the pregnancy" as violent crimes.
SB 742 TITLE 21 O.S. §1277 – UNLAWFUL CARRY IN CERTAIN PLACES	Added Judges of the Court of Civil Appeals, Court of Criminal Appeals, and Justices of the Supreme Court.
