1. CALL TO ORDER & ESTABLISH QUORUM

LeRoy E. Young, D.O., *President*, called the meeting to order at 2:00 p.m. and announced that a quorum of members physically present was established.

2. HEARING DOCKET – Individual Proceedings / Disciplinary Actions

Donna Hill, D.O.

Dr. Young called the matter of Donna Hill, D.O. to order and recognized Special Prosecutor for the Board, Roma McElwee, J.D. The Hearing proceeded. The State relied on the previously entered six (6) Exhibits. The board's Investigator, John Mobley, testified about the patients' who could not locate Dr. Hill to get copies of their Medical Records. Dr. Hill appeared in person without counsel and entered testimony.

The Hearing concluded.

Ms. Templeton moved to go into Executive Session.
Dr. Carter seconded the motion.

Dr. Young called for the votes on the motion and a roll call.

Dr. Pettigrew moved that Dr. Hill's license remain suspended at least until she is able to obtain assessments on her mental cognitive stability by a psychologist and an assessment by a psychiatrist. The staff is to assist her. The Board specifically reserves the ability to order further testing on medical skills and medical record keeping standards. Dr. Hill is reminded that when suspended there must be some mechanism to allow patients to get their records or referrals.
Dr. Langerman seconded the motion.

Dr. Young called for the votes on the motion and a roll call.

David Quy, D.O.

Dr. Young called the matter of David Quy, D.O. to order and recognized Special Prosecutor for the Board, Roma McElwee, J.D. A Notice and Emergency Order to Appear and Show Cause Hearing proceeded. Ms. McElwee announced that Notice to Dr. Quy was attempted.

The Hearing concluded.

Ms. Templeton moved to go into Executive Session.

Ms. Templeton moved that based on the evidence presented the license of David Quy is to be immediately suspended pending a hearing on the merits.
