This matter comes on for consideration before the Oklahoma State Board of Osteopathic Examiners ("Board") at a regular meeting of the Board on March 16, 2023. Kaylee Davis-Maddy, J.D., counsel for Lisa Baracker, D.O. ("Dr. Baracker") appeared via Teams. Dr. Baracker was not required to appear.

The Board, after reviewing Dr. Baracker's previous orders and being fully advised, enters this Third Interim Order.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED by the Board that Dr. Baracker's license to practice osteopathic medicine remains in effect and is subject to the following terms and conditions:



COMPLAINT

The Prosecutor for the State Board of Osteopathic Examiners (the "Board"), J. Patrick Quillian, states as follows:

- 1. Dr. Trung Nam Nguyen, D.O., is the holder of a license to practice as an osteopathic physician in the State of Oklahoma, license number 3683. Dr. Nguyen primarily practices in family medicine via telehealth and received his license as an osteopathic physician in Oklahoma from the Board on July 9, 2018. Dr. Nguyen is licensed as an osteopathic physician in numerous other states, including Kentucky, Alabama, and Texas. Dr. Nguyen currently resides in Texas.
- 2. Dr. Nguyen is in violation of the Oklahoma Osteopathic Medicine Act (the "Aet"), Tit. 59 O.S. § 637(A)(2) and (A)(6) which states:
 - A. The State Board of Osteopathic Examiners may ... suspend or revoke any license issued or reinstated by the Board upon proof that the applicant or holder of such a license:
 - Has engaged in ... unethical conduct or unprofessional conduct, as determined by the Board, in the performance of the functions or duties of an osteopathic physician

- 6. Has had the authority to engage in the activities regulated by the Board revoked, suspended, restricted, modified or limited, or has been reprimanded, warned or censured, probated or otherwise disciplined by any other state or federal agency whether or not voluntarily agreed to by the physician[.]
- 3. On March 8, 2023, "in lieu of the issuance of a Complaint and Emergency Order of Restriction [,]" Dr. Nguyen voluntarily entered into an agreed order (the "Kentucky Order") with the Commonwealth of Kentucky Board of Medical Licensure (the "Kentucky Board"). The Order contained stipulations of fact indicating that Dr. Nguyen's patient charts were "below the minimum standards" for prescribing.
- 4. The Order also contained "Stipulated Conclusions of Law", which, *inter alia*, found that Dr. Nguyen violated Kentucky physician regulations and, thus, there were grounds for action to be taken on his Kentucky license to practice osteopathic medicine.
- 5. The Kentucky Order stated that "[t]he license to practice osteopathy within the Commonwealth of Kentucky held by Truong Nam Nguyen, D.O. is RESTRICTED/LIMITED FOR AN INDFINITE PERIOD OF TIME" and ordered that Dr. Nguyen "SHALL NOT prescribe, dispense, administer, or otherwise professionally utilize controlled substances unless and until approved to do so by the Panel" (emphasis in original).
- 6. The Alabama State Board of Medical Examiners (the "Alabama Board") proceeded against Dr. Nguyen's Alabama osteopathic medical license based upon the Kentucky Order, which resulted in Dr. Nguyen voluntarily

surrendering his Alabama license to administer and prescribe controlled substances on April 27, 2023.

- 7. On May 9, 2023, Dr. Nguyen voluntarily surrendered his DEA Drug Registration to prescribe controlled substances in the State of Alabama.
- 8. On June 9, 2023, Dr. Nguyen executed a Waiver Order before the Texas Medical Board which requires him to comply with the Kentucky Order, and if he fails to do so, he agrees that it would constitute a basis for disciplinary action by the Texas Medical Board.
- 9. Dr. Nguyen has violated the Act by 1) engaging in unethical or unprofessional conduct in the performance of his duties as an osteopathic physician (to wit: issuing prescriptions for CDS without proper documentation); and 2) having his authority to distribute controlled substances limited by the Kentucky Board, the Alabama Board, the DEA, and the Texas Medical Board.

COMPLAINT

The Prosecutor for the Oklahoma State Board of Osteopathic Examiners (the "Board"), J. Patrick Quillian, states as follows:

- 1. Dr. Matthew Ray Whittaker, D.O., is the holder of a license to practice as an osteopathic physician in the State of Oklahoma, license number 7054. Dr. Whittaker received his license to practice as an osteopathic physician in Oklahoma from the Board on July 1, 2020, and primarily practices in emergency medicine.
- 2. Dr. Whittaker is in violation of the Oklahoma Osteopathic Medicine Act (the "Act"), Tit. 59 O.S. § 637(A)(2), (A)(2)(f), and (A)(4) which state:
 - A. The State Board of Osteopathic Examiners may ... suspend or revoke any license issued or reinstated by the Board upon proof that the applicant or holder of such a license:

2. Has engaged in the use or employment of ... unethical conduct or unprofessional conduct, as may be determined by the Board, in the performance of the functions or duties of an

osteopathic physician, including but not limited to the following:

. . .

f. acting in a manner which results in final disciplinary action by any ... hospital or medical staff of such hospital in this or any other state ... if the action was in any way related to professional conduct, professional competence, malpractice or any violation of the Oklahoma Osteopathic Medicine Act, [or]

- 4. Has engaged in repeated acts of negligence, malpractice or incompetence[.]
- 3. Dr. Whittaker began his residency in emergency medicine at Integris Health ("Integris") on July 1, 2019. On September 4, 2019, Integris placed Dr. Whittaker on a remediation plan due to concerns regarding competency and professionalism. After Dr. Whittaker violated the remediation plan multiple times, Integris staff placed Dr. Whittaker on a twelve (12) month probation plan. Throughout this time, Integris staff had concerns related to Dr. Whittaker's "medical knowledge, patient care, interpersonal and communication skills, and professionalism."
- 4. Dr. Whittaker resigned from the residency program at Integris on July 13, 2021, after learning that the hospital would not be renewing his contract. Dr. Whittaker was a post-graduate level II at the time.
- 5. Since Dr. Whittaker left Integris, he has worked as a locum tenens contractor under a Texas Emergency License to practice medicine, which expires August 30, 2023.

- 6. Dr. Whittaker disclosed his resignation from the residency program to the Board in his 2023 renewal, explaining to Board staff that he had been subject to unfair treatment and bias by the program's faculty and staff.
- 7. Dr. Whittaker has violated the Act by: 1) engaging in unprofessional conduct as an osteopathic physician during his residency program at Integris; 2) acting in a manner that resulted in final disciplinary action by Integris related to his professional conduct and competence; and (3) engaging in repeated acts of malpractice and incompetence during his residency at Integris.

ORDER TO TABLE APPLICATION PENDING COMPLETION OF CONDITIONS

This matter came on for consideration before the Oklahoma State Board of Osteopathic Examiners ("Board") at the regular meeting of the Board of June 15, 2023. Applicant Dr. Christopher Gaskins, DO appeared in person.

This Order is pursuant to the Oklahoma Osteopathic Medicine Act, 59 O.S. 2021, §620 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. §250 et seq.

The Board, after reviewing the application file, hearing sworn testimony and being fully advised specifically finds the following Findings of Fact and Conclusions of Law to be proven by clear and convincing evidence.

FINDINGS OF FACT

- 1. Dr. Gaskins held Oklahoma Osteopathic Medical License No. 7670 and now seeks renewal of that license.
- 2. That Dr. Gaskins originally received training license in July, 2022 but resigned from his training program on or around January 3, 2023.

- 3. That Dr. Gaskins sought and received treatment for anxiety and that treatment continues with daily medication now supervised by his primary care physician Dr. Leslie Edelman.
- 4. That a review of records indicates Dr. Gaskins never completed one-year rotating internship and specifically did not complete rotations in pediatrics or in OB/GYN.
- 5. That Dr. Gaskins would require training license to complete rotating internship in pediatrics and OB/GYN at an ACGME approved program.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear this matter pursuant to the Oklahoma Osteopathic Medicine Act, 59 O.S. 2021, §620 et seq., rules for the Board 510 OAC §1-1 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. §250 et seq.

<u>ORDER</u>

IT IS THEREFORE ORDERED by the Board that Dr. Gaskins' Oklahoma Osteopathic Medical License No. 7670 be tabled pending his successful completion of the following conditions.

- 1. That Dr. Gaskins successfully complete rotating internship in the fields of pediatrics and OB/GYN at an ACGME approved institution acceptable to the staff of the Oklahoma Board of Osteopathic Examiners.
- 2. That upon successful completion of those two rotating internships, then Dr. Gaskins' Oklahoma Osteopathic License No. 7670 may be reinstated by operation of the Board staff.

- 3. That Dr. Gaskins be issued training license instanter for the specific purpose of completing the two rotating internships named above.
- 4. That Dr. Gaskins shall bear the financial costs of any expenses incurred from this Order.
- 5. That Dr. Gaskins shall ensure all records and reports of his rotating internships in pediatrics and OB/GYN be provided directly to the Board staff.
- 6. This Order is a public record and therefore subject to the Oklahoma Open Records Act. Further, this Order may be reportable to the National Practitioner Data Bank ("NPDB") pursuant to federal law, including but not limited to, 45 C.F.R. Part 60.

ORDER TO TABLE APPLICATION

This matter came on for consideration before the Oklahoma State Board of Osteopathic Examiners ("Board") at the regular meeting of the Board of June 15, 2023. Applicant Dr. Megan Melott Moss, DO appeared in person.

This Order is pursuant to the Oklahoma Osteopathic Medicine Act, 59 O.S. 2021, §620 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. §250 et seq.

The Board, after reviewing Dr. Moss's application for Oklahoma osteopathic medical license and hearing sworn testimony finds the following Findings of Fact and Conclusion of Law proven by clear and convincing evidence.

FINDINGS OF FACT

- 1. Dr. Moss is an applicant for an Oklahoma osteopathic medical license.
- 2. Dr. Moss was in medical school from approximately August, 2014 to May, 2021 and was in an approved PGY1 Program June, 2021 to June 30, 2022.
- 3. That Dr. Moss was placed on performance improvement plan with deficiencies in approximately April, 2022. Later upgraded to probation by vote of the Clinical Competing Committee on December 16, 2022.

- 4. Dr. Moss also had health problems and multiple surgeries that delayed her educational progress.
- 5. Evidence showed that the applicant did not complete a rotating internship to include surgery and OB/GYN and under Oklahoma law the applicant had to complete the rotating internship or successfully enter a pediatric residency at an ACGME approved residency program.

CONCLUSIONS OF LAW

The Board, after reviewing Dr. Ajumobi's application for renewal of license and hearing sworn testimony finds the following Findings of Fact and Conclusion of Law proven by clear and convincing evidence.

FINDINGS OF FACT

- 1. Dr. Taiwo Ajumobi is an applicant to renew Oklahoma osteopathic medical license No. 7524.
- 2. That the applicant began PGY1 in July 1, 2020 and her PGY1 was extended for six months. Applicant completed PGY1 in December, 2021, and she was promoted to PGY2. During PGY2 she was placed on academic probation in

June, 2022 and she was dismissed from the residency program on August 1, 2022, and filed a grievance in regard to his dismissal but the grievance was denied.

- 3. Evidence showed she did not complete residency to include OB/GYN, adult medicine, and surgery.
- 4. That under Oklahoma law the applicant must successfully complete rotating internship to include OB/GYN, adult medicine, and surgery or present evidence of successful acceptance in a residency at an ACGME approved residency program.
