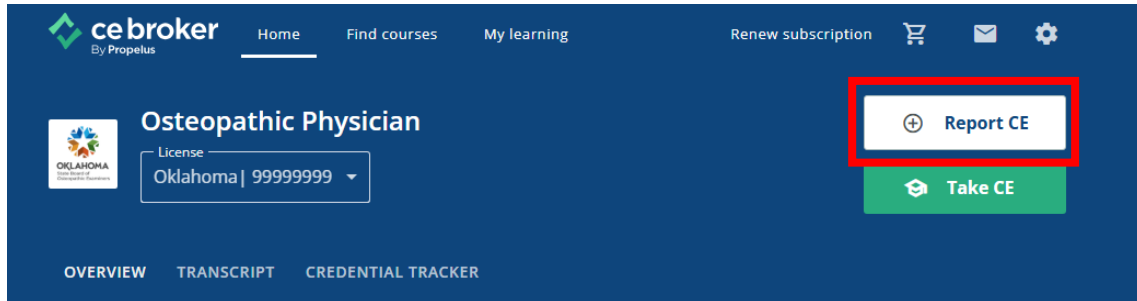


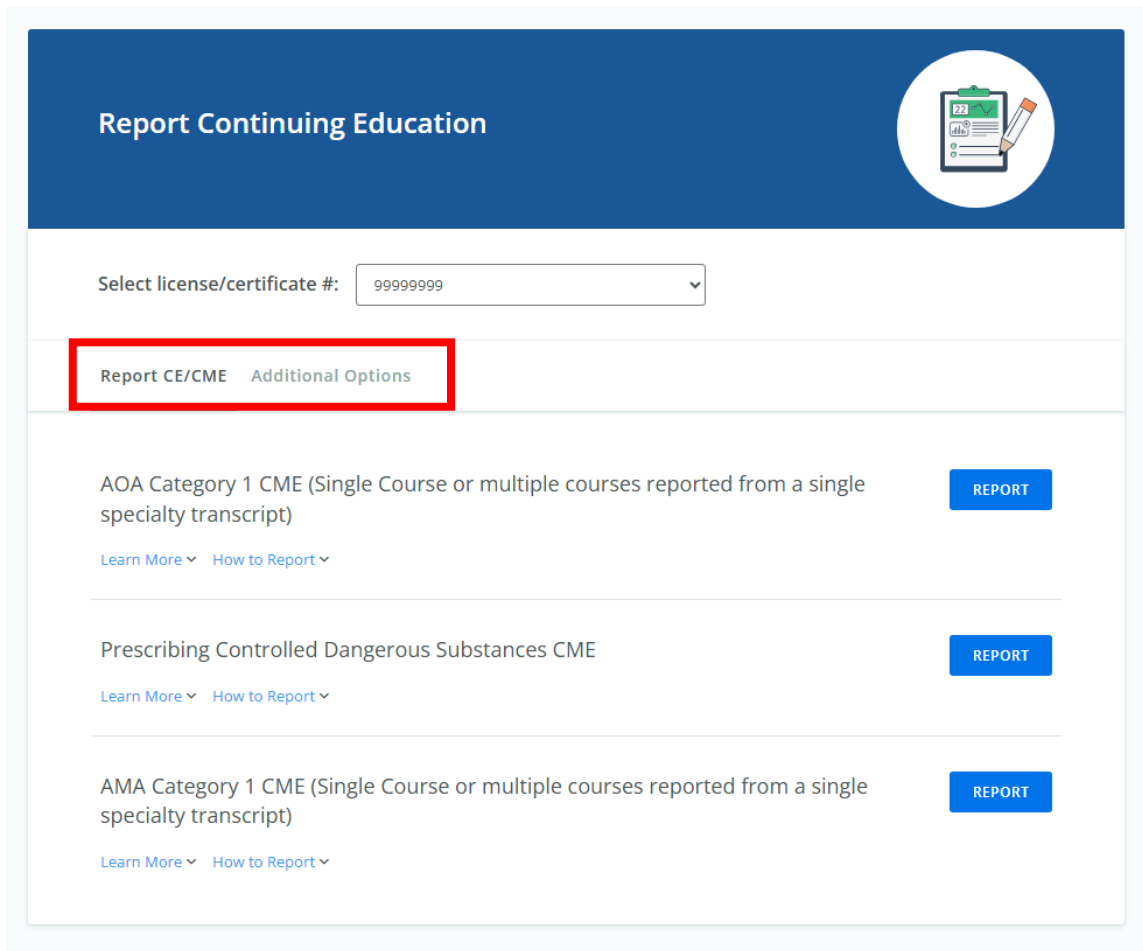
How to Self-Report Continuing Medical Education Hours or Exceptions to CE Broker

Use this guide to report any CME you have completed that has not been reported on your behalf for the CME cycle.

Upon logging in, select “Report CE” at the top right.



Once here, you can proceed with reporting CME hours or select “Additional Options” to report an exception.




If Additional Options is selected, you may report an exception to the 1 hour of Proper Prescribing or Residency/Fellowship exception to hours for the CME cycle. These selections must be made for each CME cycle they apply to.
