SUBJECT: Statutory Waiver Concerning Cooperative Agreements for Alternative Education

The following schools are requesting a statutory waiver of 70 O.S. 1210.568, which requires them to enter into a cooperative agreement with another school district if enrollment in their alternative education program is less than ten (10) students. Approval is recommended.

Section 915. Alternative Education Programs - Statewide System.

A. Beginning with the first semester of the 1996-1997 school year, the State Board of Education shall implement a statewide system of alternative education programs which shall be phased-in within seven (7) years. The statewide system shall include but not be limited to Alternative Approaches grant programs, funded pursuant to Section 1210.561 of this title, and alternative academies or alternative programs implemented pursuant to this section.

B. Beginning with the first semester of the 2002-2003 school year, all school districts of this state shall provide alternative education programs that conform to the requirements of statutes and rules applicable to alternative education. A program shall:

1. Allow class sizes and student/teacher ratios which are conducive to effective learning for at-risk students;
2. Incorporate appropriate structure, curriculum, and interaction and reinforcement strategies designed to provide effective instruction;
3. Include an intake and screening process to determine eligibility of students;
4. Demonstrate that teaching faculty are appropriately licensed or certified teachers;
5. Demonstrate that teaching faculty have been selected on the basis of a record of successful work with at-risk students or personal and educational factors that qualify them for work with at-risk students;
6. Reflect appropriate collaborative efforts with state agencies and local agencies serving youth;
7. Provide courses that meet the academic curricula standards adopted by the State Board of Education and additional remedial courses;
8. Offer individualized instruction;
9. State clear and measurable program goals and objectives;
10. Include counseling and social services components with the provision that providers of services are not required to be certified as school counselors;
11. Require a plan leading to graduation be developed for each student in the program which will allow the student to participate in graduation exercises for the school district after meeting the requirements of the school district as specified in the individual graduation plan for that student; provided, for students who enter the ninth grade in or prior to the 2007-08 school year, the plan shall specifically address whether the student is required to meet the graduation requirements established in Section 11-103.6 of this title;
12. Offer life skills instruction;
13. Provide opportunities for arts education to students, including Artists in Residence programs coordinated with the Oklahoma Arts Council;
14. Provide a proposed annual budget;
15. Include an evaluation component including an annual written self-evaluation;
16. Be appropriately designed to serve middle school, junior high school and secondary school students in grades six through twelve who are most at risk of not completing a high school education for a reason other than that identified in Section 13-101 of this title; and
17. Allow students in the alternative education program, who otherwise meet all of the participation requirements, to participate in vocational programs and extracurricular activities, including but not limited to athletics, band, and clubs.

C. The alternative education program of a school district shall be operational and serving students by September 15 of each school year.

D. Each alternative education program of a school district shall receive funding based on the combined number of dropouts and students within the district who have been referred to a county juvenile service unit, a county juvenile bureau or who have been committed to the custody of the Office of Juvenile Affairs. Each alternative education program shall receive incentive funding as follows:

1. For the first year of operation, One Thousand Dollars (\$1,000.00) per student;

2. For the second year of operation, Seven Hundred Fifty Dollars (\$750.00) per student; and
3. For the third year of operation and each year thereafter, Seven Hundred Dollars (\$700.00) per student.

Statewide alternative education funding shall not be used to supplant existing school district resources or to support programs that do not meet all the criteria for the statewide alternative education system. No alternative education program shall receive less than a total of Ten Thousand Dollars (\$10,000.00) per school year.

E. By September 15 of each school year, all statewide alternative education funds received and expended for students participating in an alternative education program shall be reported to the State Department of Education by major object codes and by program classifications pursuant to the Oklahoma Cost Accounting System as adopted by the State Board of Education pursuant to Section 5-135 of this title.

F. Elementary school districts, as defined in Section 5-103 of this title, may request a waiver from the State Board of Education from the requirements of this section to implement and provide an alternative education program. Any elementary school district that has not received funding pursuant to the provisions of subsection D of this section shall be automatically granted a waiver. If a school district is granted a waiver, no statewide alternative education funding shall be allocated to the district.

G. 1. The State Board of Education shall contract for technical assistance for operation of an Alternative Education Technical Assistance Center. The technical assistance provider shall be an entity located in Oklahoma that has been officially recognized by the United States Department of Education to assess and facilitate dissemination of validated educational programs in Oklahoma. The technical assistance provider shall have priority, if its operations are deemed satisfactory by the State Board of Education and if funds are available, for annual renewal of the contract.

2. The duties of the technical assistance provider shall include, but shall not be limited to:
 - a. providing initial and ongoing training of personnel who will educate at-risk populations through alternative education programs,
 - b. providing technical assistance to school districts to enhance the probability of success of their alternative education programs,
 - c. evaluating state-funded alternative education programs,
 - d. reporting to the State Board of Education the evaluation results of state-funded alternative education programs, and
 - e. providing in-depth program analysis and evaluation of state-funded alternative education programs.
3. The State Board of Education shall not provide funding to an alternative education program that does not receive a recommendation for continued funding in the evaluation provided for in this subsection. Provided, any school district not receiving such a recommendation for continued funding may request a hearing before the Board with a review of the evaluation prior to the Board's final determination.

H. All alternative education programs shall be subject to statutes and rules applicable to alternative education, including any exemptions from statutory or regulatory requirements authorized by statutes or rule.

I. An alternative education program may be offered by an individual school district or may be offered jointly by school districts that have formed interlocal cooperative agreements pursuant to Section 5-117b of this title. Any school district submitting a plan for an alternative education program serving fewer than ten students shall enter into a cooperative agreement with another school district to jointly provide the program unless the program has been granted a waiver from this requirement by the State Board of Education.

J. Any materials or equipment purchased by a school district with revenue received for students participating in an alternative education program shall be used only in or directly for the alternative education program offered by the district or any subsequent alternative education program offered to students enrolled in that district. Such materials and equipment shall be made available exclusively to alternative education students during the hours that the alternative education program is operating; provided, the material or equipment may be used for other purposes when the alternative education program is not operating.

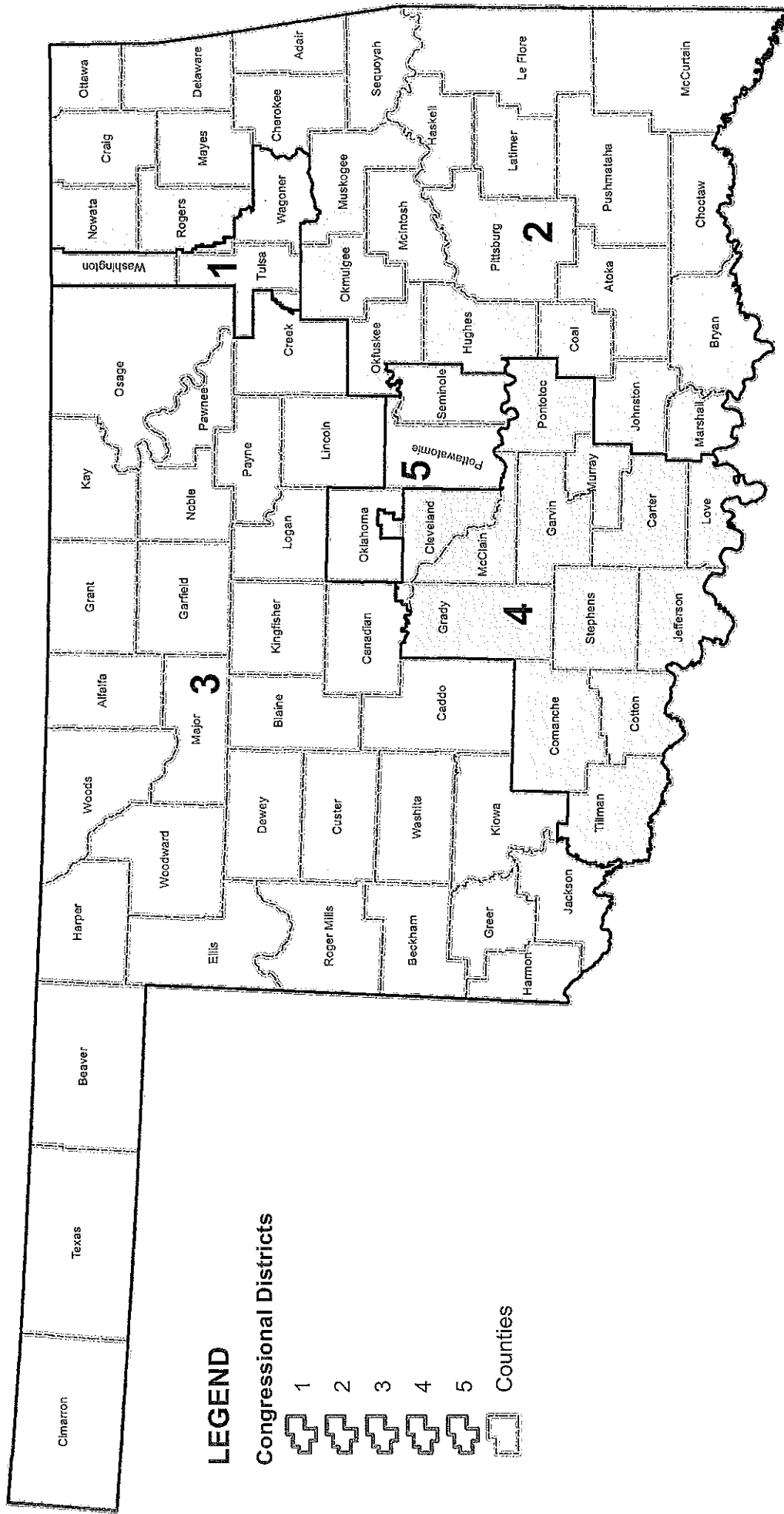
K. Upon implementation of this subsection as provided for in subsection M of this section and contingent upon the provision of appropriated funds designated for such purpose, all school districts in the state providing alternative education programs as required in subsection B of this section shall expand the programs to include middle-school-grade students. The program shall conform to the requirements of subsection B of this section.

L. Upon implementation of this subsection as provided for in subsection M of this section and contingent upon the provision of appropriated funds designated for such purpose, each urban school district identified by the State Department of Education as having a high population of elementary grade students who are at-risk and in need of alternative education shall provide elementary level alternative education programs. The State Department of Education shall establish requirements for the programs. For purposes of this section, "urban school district" means a school district with an average daily membership of thirty thousand (30,000) or more.

M. Implementation of subsections K and L of this section shall be delayed until the current expenditure per pupil in average daily attendance in public elementary and secondary schools in unadjusted dollars for the 1998-99 school year or any school year thereafter for Oklahoma, as reported by the National Center for Education Statistics annually in the Digest of Education Statistics, reaches at least ninety percent (90%) of the regional average expenditure for that same year, and funds are provided. For purposes of this subsection, the regional average expenditure shall consist of the current expenditure per pupil in average daily attendance in public elementary and secondary schools in unadjusted dollars for each of the following states: Arkansas, Colorado, Kansas, Missouri, New Mexico, Oklahoma, and Texas, averaged together. By January 1 of each year, the State Board of Education shall report whether or not the ninety-percent expenditure level has been reached based on information reported annually in the Digest of Education Statistics by the National Center for Education Statistics. Subsections K and L of this section shall be implemented on July 1 after the first January 1 report verifies that the ninety-percent expenditure level has been reached and funds have been provided for the specific purposes of this section.

Oklahoma Congressional Districts Elections

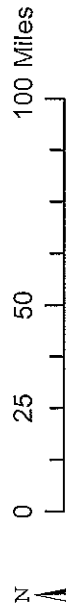


LEGEND

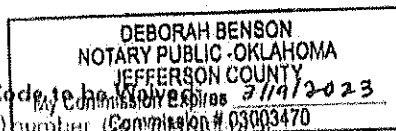

NAME OF WAIVER

A. Reason for the waiver/deregulation request (be specific).

Ringling Schools is requesting Statutory Waiver 70 O.S. § 1210.568 in order to provide alternative education programming of less than ten students on campus, rather than as a part of a cooperative. It is our belief that students will be able to spend more time in alternative classes by receiving direct instruction on our campus than in the cooperative setting. Students will benefit from the extra instruction time that would typically be spent in transport from home to the cooperative program site. Other benefits of providing an alternative education program in the district include better access to vocational and extracurricular programming at the district level as well as better access career tech programming due to time and location.

B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students and learning achievement.

Students will arrive on campus and will check in to alternative education classes immediately without the need for transportation time to and from a cooperative school. This will allow for approximately one to two hours of additional class time, therefore students will benefit from more direct instruction and access to materials than would typically be provided. Also, with smaller student to teacher ratios, students will benefit from additional one to one assistance which will increase their education achievement.

C. Educational impact to the district: Results of the Statutory Waiver/Deregulation, i.e., effect on student performance levels, impact of plan on other sites in the district.

Students will be able to complete a greater number of class credits with a higher level of proficiency as will be demonstrated on end of year testing and transcripts. It will allow a greater number of students to participate in extracurricular and vocational programs.

The separation of this school district from the cooperative will allow space for other students that may be on the waiting list for alternative educational programs. It will also reduce the difficulties that arise from differing school and break schedules and transportation issues.

D. Timeline: Please submit class schedule, calendars, assessment forms and other attachments as necessary, or described in instructions.
A waiver/deregulation can be granted for up to 3 years. (Please see instructions for additional requirements)

This Statutory Waiver is being requested for the 2020-2021 school year. The class schedule will follow the school calendar for Ringling Public Schools.

E. Any financial impact to the District (positive or negative) for the proposed waiver/deregulation.

The waiver will have a positive financial impact to the District by allowing monies to spent with the cooperative program to be used within our district to provide alternative education.

F. Describe method of assessment or evaluation of effectiveness of the plan.

A comparison study will be completed regarding student class completion, attendance, end of year testing, and grades to determine if students' educational progress was significantly improved due to changes implemented in the alternative education program.





- A. Reason for the Waiver request. Please include distance from your alternative education site to the closest possible district to coop with, what alternative means will have to be employed if your waiver was to be denied, and what percentage of your student population will benefit from the waiver if approved.

In the past few years we have had a co-op with Blackwell Public Schools. This district is 10 miles from our campus. None of the students we have sent to Blackwell have completed the program. Difficulties arise with transportation means. We feel that this is setting students up to fail. Tonkawa has a credit recovery program in place that is working well for our students. Courses are being completed and high-risk students are going to graduate this year.

- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement.

We are offering courses online with supervision of a classroom teacher and the counselor. Student attendance rates are improved over the attendance rates through the co-op. Students are kept with their peers they have attended school with since grade school. They get to be a part of their home campus.

- C. Have you participated in an alternative education coop previously? Have you been awarded this waiver before and what was the educational impact to the district: Results of the Statutory Waiver, i.e., effect on student performance levels, impact of plan on other sites in the district. We were in a cooperative agreement with Blackwell Public School. We have never graduated a student who attended the co-op. Students assigned to the co-op have had poor attendance. The co-op has not had a positive impact on education for Tonkawa students.

We are not offering an alternative education program as there are no participants.

- E. Any financial impact to the District (positive or negative) for the proposed waiver/deregulation? If positive please describe where the available would be reallocated.

The loss of alternative education funds has not affected Tonkawa because in the past our dollars have gone to Blackwell Public Schools.

Our plan is working for this district.

We are applying for a deregulation for our Alternative Education Program. The reason for our request is the difficulty that we have keeping ten students in the program at all times. We have considered other options, but housing our alternative students is the only viable option at this time. We have a teacher on staff and to cooperate with Ponca City High School would cost Tonkawa Schools about \$75,000 compared to \$18,000 or \$36,000 depending on approval of the waiver. I have discussed the possibility of serving our alternative students through Pioneer Career Tech in Ponca City. We send students to Pioneer Tech every day and Career Tech makes the most sense as a solution for our number problem and their number problem. Hopefully someday that will become a reality. Until then the best way for us to serve our alternative students is on our campus with fewer than ten students.

- A. Reason for the Waiver request. Please include distance from your alternative education site to the closest possible district to coop with, what alternative means will have to be employed if your waiver was to be denied, and what percentage of your student population will benefit from the waiver if approved.
Frontier School is re-establishing their own alternative education program after having been part of a coop with Perry School for the previous two years. Frontier School is 20 miles from Perry School. If the waiver is denied, Frontier School would have to make arrangements for their student(s) to be transported to Perry School. Perry School may limit the number of students that Frontier School could send to them. If the waiver is approved, the alternative education students could be served at Frontier School.
- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement.
Frontier School will provide alternative education students a minimum of four hours and twelve minutes of courses. The students would not be losing 40 minutes each day of instructional time by commuting to Perry School. A waiver has not been awarded to Frontier for deregulation of cooping with another school. Frontier students would be attending classes among peers that they are familiar with.
- C. Have you participated in an alternative education coop previously? Have you been awarded this waiver before and what was the educational impact to the district: Results of the Statutory Waiver, i.e., effect on student performance levels, impact of plan on other sites in the district.
Frontier School participated with Perry School in a coop. Frontier has not been awarded this waiver before.

- D. Timeline: Please submit class schedule, calendars, assessment forms and other attachments as necessary.

Mustang Academy will have a class schedule of 8:20 AM to 3:05 PM. The academy will attend all the same days of the school calendar as Frontier School. The academy will require an application be filled out to attend the program.

- E. Any financial impact to the District (positive or negative) for the proposed waiver/deregulation? If positive please describe where the available would be reallocated.

There will be a savings to the school in transportation expenses, but a full-time teacher will need to be on staff to accommodate the Mustang Academy program. The expense of having a teacher on staff will exceed the savings of transportation.

- F. Describe method of assessment or evaluation of effectiveness of the plan both for staff and students, I.E., TLE, ACT scores, graduation rates, RSA, School Report Card, etc.

The teacher will be properly certified to teach the students. The students will be required to take the ACT exam and the graduation rate will be maintained.

Students will be afforded the opportunity to stay in their home school and not have to be transported to a cooping school.

Tipton public schools is requesting this waiver because we do not have at least 10 students in our alternative education center and it was not open for the required amount of time. We have cooped before and the nearest Alternative Center is 20 miles away and rarely had open slots for all of our at risk students. We have had our own alternative center for the past 17 years. This year we decided to use our alternative program for credit recovery for students who did not receive credits from being virtual learning during the pandemic, which included our students who would have been in the alternative center. We had 10 students take part in the credit recover program during this year but credit recovery was only offered during three hours during the day. It is for this reason.

- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement.

Tipton being a small rural school we strive to make the decisions that best suit our students. Allowing those students to "make up" courses they did not finish or did not pass served our population well. By the end of the year all of those students that participated in our credit recovery program will be on schedule to graduate within their cohort year. The past few years have been a learning experience about the needs of our students. The administration, counselor, parents, board, students and community have embraced the difficulty of the past few years in educating our children the best way possible. We have made critical decisions and learned from each one of them. This credit recovery program worked well for what was needed at the time. We were still able to meet the individual needs of each of our at risk students. Our plan for next year is to resume the alternative program as it has been in the past years.

- C. Have you participated in an alternative education coop previously? Have you been awarded this waiver before and what was the educational impact to the district: Results of the Statutory Waiver, i.e., effect on student performance levels, impact of plan on other sites in the district.

We have been a part of a coop in the past. We have not been awarded this waiver before. The whole reason we began our alternative program 17 years ago was to better serve the needs of our at risk and most vulnerable students. Since we started our own program our graduation rate among those at risk students has almost been 100%. I cannot say that from when we were part of a coop. It is critical for our students to be able to stay on our campus and share time with our other students during breakfast, lunch, elective classes, extra-curricular classes and for those who choose it Career Tech classes.

For this year our credit recovery program served students during the first hour of the day and the last two hours of the day. It was part of the regular school program and class schedule for Tipton Public Schools.

There has been no financial impact to the District at this time.


To Whom It May Concern,

I am sending a late waiver request for our Alternative Education Center because I was unaware that our students in alternative education were not labeled correctly in our student information system and the way we decided to do our alternative education this year was not adequate for an alternative center.

We decided what would be best for our alternative education center would be to do a credit recovery for all those students. These were students that chose the virtual learning platform and did not receive full credit or any credit for last years classes during virtual learning. We had 10 students total that needed credit recovery from being virtual and not meeting our guidelines for credit. 1 additional student has since used the open transfer rule and is now part of our credit recover program. This student did not have any credits from being a virtual student from EPIC. They have all been in credit recovery during this year and by then of the year will have made up for those credits lost, except for the student we added in January. The students in our credit recovery program needed at least two credits to be made up. We offered credit recovery during the last two hours of the day.

We are requesting a waiver for not having the required number of hours for alternative school. We are also requesting a waiver for having less than the number of students for an alternative center program. We did have 11 students being part of the program but not all during the entire year. Some have finished the program and have moved into the regular classroom for elective courses. I know this is not the typical alternative education center but for this year it was what our students needed.

As we entered school year 2020-21, we moved our alternative class into our virtual academy. Our experience during last school year was by doing this many of our students did not adjust well to this type of instruction. During the current year, we are moving many of those students back into our previous alternative setting where they experience the support they need. However, as we identify these at-risk students we ask for a waiver until our numbers are above the threshold that is required by statute. Our closest neighboring school is approximately 20 miles away.

- B. List alternate strategies/plans which the district/site proposes, and how this plan will best serve the students of your district, i.e., a description of the educational benefits to the students, graduation rate if a waiver has been awarded prior to this year, and learning achievement.

We currently have an alternative class during the evening hours 3:45 PM until 8 PM. This program has been successful over the years allowing our school to offer a alternative to young mothers who do not have childcare during the traditional school day, students that must hold a regular job for income during the traditional day and more recently for students who are leery of being in the traditional setting because of COVID, among other reasons. We are able to operate on this adapted schedule due to a waiver by the State Department of Education.

We have not requested this type of waiver before.




