STATE DEPARTMENT OF EDUCATION ACTION ITEMS:

Discussion and possible action on the following deregulation applications, statutory waivers, and exemptions for the 2025-2026 school year pursuant to 70 O.S. § 3-104; Oklahoma Administrative Code ("OAC") 210:35-1-4:

6. Emergency (Provisional) Teacher Certification

Discussion and possible action on requests for exceptions to the State Board of Education teacher certification regulations to permit emergency (provisional) certificates. 70 O.S. § 6-187(G):

Under 70 O.S. § 6-187(G), "nothing in the Oklahoma Teacher Preparation Act shall restrict the right of the State Board of Education to issue an emergency or provisional certificate." However, prior to requesting an emergency or provisional certificate, the schools district is required to "document substantial efforts to employ a teacher who holds a provisional or standard certificate." *Id.* If the district is unable to do so, the district must then "document efforts to employ an individual with a provisional or standard certificate in another area" that also has "academic preparation in the field of need." *Id.* In other words, only after exhausting both of these options is a district permitted to request an emergency or provisional certification.

7. Library-Media Specialist Certification Exemption

Discussion and possible action on requests for approval for exemption from library-media certification requirements pursuant to **70 O.S.** § **3-126**, for the 2025-2026 school year:

Districts seeking a waiver under this section want to hire a Library-Media Specialist who has not yet completed their certification requirements. These schools will use a certified teacher as their Library-Media Specialist while that person is pursuing full Library-Media certification. Each school sends a form that must be completed detailing their reason for the request, plan for an alternative should the request be denied, timeline, and financial impact to the school.

8. Library-Media Services Waiver

Discussion and possible action on requests for library-media services exemptions pursuant to **OAC 210:35-5-71; OAC 210:35-7-61; OAC 210-35-9-71** for the 2025-2026 school year:

Districts seeking this waiver are asking to reduce their library-media center hours. Under the Administrative Code, each school is required to offer a specific number of hours that the library/media center is open to students. However, some schools do not have sufficient enrollment numbers to justify a full-time librarian at every site. When this happens, the school district requests an exemption to the number of hours the library/media center must remain open. Much like with the Library-Media Services waiver (number 4, above), the district fills out a form detailing the reason for the request, alternative strategies in the event the request is not approved, impact to student learning, etc. **NOTE**: Under OAC 210:35-3(b)(5)(B), districts may request a waiver for up to three years. However, the Board has the authority to approve the waiver for only one year.

9. Federal Late Claims

Discussion and possible action on payment of a joint federal program claim pursuant to **OAC 210:25-3-7(12).**

Under Oklahoma Administrative Code, school districts must submit expenditure forms requesting reimbursement against any federal program of the Department of Education on or before August 1. If a school submits a claim after August 1, that school must receive approval from the State Board of Education for the payment.

10. Flexibility of Allocated Textbook Funds

Discussion and possible action on requests a waiver for flexibility in the use of allocated textbook funds pursuant to 70 O.S. § 16-114a.

A school district flexibility in the use of state-appropriated allocated pursuant to this section for textbooks shall be required to demonstrate to the Board that the textbook and instructional materials used by the district for the subject areas being considered in the textbook adoption cycle are current and appropriate for student learning. A school district that has received textbook funding flexibility approval from the Board may elect to spend any money allocated for any relevant purpose related to the support and maintenance of the school district as determined by the board of education of that district.

11. Accreditation Warnings

Discussion and possible action on issuing accreditation warnings to the following schools pursuant to **OAC 210:35-3-201:**

Accreditation warnings are issued to schools that have had the same accreditation deficiency reported for two years in a row. It could also be that they have had multiple deficiencies that are major issues for issues for school functioning. If a school remains on the list "Accredited with Warning" list for multiple years, then the school can be **moved to probation. After two years on probation, a school can lose its accreditation.** Districts are required to submit corrective action plans, and the OSDE Regional Accreditation Officers ("RAOs") work with schools to correct accreditation deficiencies.

12. Private School Accreditation

Discussion and possible action on accreditation approval for the following private schools pursuant to 70 O.S. § 3-104(A)(7) and OAC 210:35-33-1.

Private schools may seek accreditation through an approved private school accrediting association or through OSDE. Private schools wishing to receive OSDE accreditation must be approved by the State Board of Education.

- (1) Basecamp Hybrid School
- (2) Funks Learning Lab
- (3) Hope Christian Academy
- (4) The Hive Learning Lab

*Note: Funks Learning Lab, Hope Christian Academy, and The Hive Lab have been operating but, due to a procedural oversight, were not previously approved. We are requesting Board approval as a procedural matter only, and not for any issues with their operation/accreditation.

13. Math and Literacy Screeners

Request for approval of literacy screeners pursuant to 70 O.S. §§ 1210.508C(A) and (B) and 70 O.S. § 1210.520(A) and math screener pursuant to 70 O.S. § 1210.907

By statute, screening instruments must be approved by the State Board of Education. The Strong Readers Act requires both a universal screener and a dyslexia screener. These are being presented to the Board for approval. Additionally, under the Math Achievement and Proficiency Act, the Board must approve policies for dyscalculia screening. These are being presented for Board approval.
