The Beacon School request approval to participate in the Lindsey Nicole Henry Scholarship for Students with Disabilities program. They are accredited through Cognia and recognized by the Oklahoma Private School Accreditation Commission charged by the Oklahoma State Department of Education with overseeing educational quality of accredited private schools in the state.

The Beacon School provides comprehensive support for students through Academic Progress Plans and Behavior Progress Plans, particularly for those traditionally on IEPs or 504 Plans. The school conducts in-house assessments for all students to identify their needs and determine necessary accommodations. Based on these assessments, the school facilitates services by inviting privately paid professionals, such as dyslexia tutors and speech therapists, to provide specialized support within the school environment.

The Lindsey Nicole Henry (LNH) Scholarship Act requires participating schools to be physical, brick-and-mortar institutions in Oklahoma and meet certain approval criteria. Schools must provide documentation to show they comply, which will be reviewed by the Oklahoma State Department of Education (OSDE). This documentation is often found in the school's policies or handbook. Please prepare a PDF for each item listed below to email with your application.

The OSDE will approve a private school for the scholarship program if it meets the following criteria:

- 1. The private school must demonstrate fiscal soundness by having been in operation for one (1) year or providing the OSDE with a statement by a certified public accountant confirming that the private school is insured and the owner or owners have sufficient capital or credit to operate the school for the upcoming year by serving the number of students anticipated with expected revenues from tuition and other sources that may be reasonably expected. In lieu of a statement, a surety bond or letter of credit for the amount equal to the scholarship funds for any quarter may be filed with the Oklahoma State Department of Education. *Proof of compliance required. Save in a PDF, and label it Criteria 1.*
- 2. The private school must comply with the antidiscrimination provision of 42 U.S.C. § 2000d.

- 3. The private school must employ or contract with teachers who hold baccalaureate or higher degrees, or have at least three (3) years of teaching experience in public instruction in subjects taught. Proof of compliance required. A statement or excerpt from the school polices or handbook stating the educational requirement for the teaching staff is acceptable documentation. Save in a PDF, and label it Criteria 3.

Professional Qualifications

Instructional Staff shall have a minimum of a Bachelor of Arts or a Bachelor of Science Degree from a recognized college or university. The requirement may be waived by the Board in the case of part-time teachers, Specials teachers, or those working on their degree while teaching.

Instructional Staff shall have had (or are willing to pursue) continuing education courses specifically pertaining to creative Christian education.
