

AMENDED ORDER DECLARING ANNEXATION

Whereas, on the 8th day of November 2022, concurrent resolutions for the annexation of all of the Terral Public Schools (34C003), of Jefferson County, Oklahoma, to the Ryan Public Schools (34I001), of Jefferson County, Oklahoma, were delivered to the Oklahoma State Department of Education and;

Whereas, the State Superintendent of Public Instruction, published a call for an election for approval of such annexation by the eligible school district electors, which said election was given as prescribed by law, and;


Whereas, said annexation was approved at an election held on January 10, 2023, by a majority of the school district electors eligible to vote, and voting at said election, the vote being 89 for approval and 15 against approval of said annexation.

Whereas, all of the Terral Public Schools property, facilities, assets, liabilities, debt, and equipment, etc., know or unknown, will become the property of the Ryan Public Schools on the effective date of this annexation.

THE EFFECTIVE DATE OF SAID ANNEXATION IS TO BE JUNE 30, 2023.


