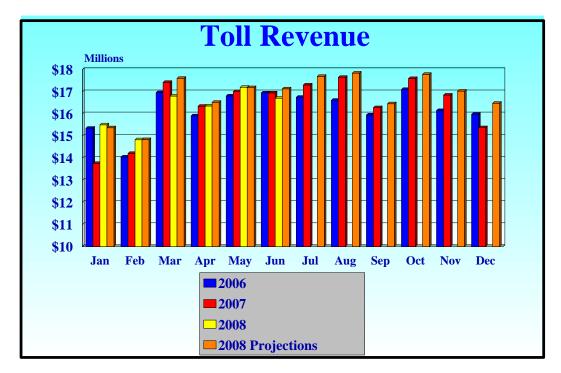

### Dear Oklahoma Turnpike Authority Bondholders:

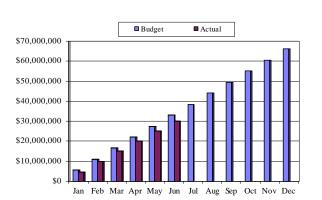
With the continued rise in fuel prices, second quarter net toll revenues came in just over \$50.2 million, reporting flat when compared to the same quarter last year. Revenues for Memorial Day weekend were 1% lower when compared to revenues for Memorial Day weekend 2007. Year-to-date toll revenues as of June 30, 2008 surpassed \$97.3 million reflecting a 1.8% increase over the prior year, but falling short of budgeted projections by 1.3%. Toll transactions were up 2.9% when compared to the second quarter of 2007. It appears that summer travelers may be staying closer to home, as mileage driven was significantly lower than the prior year for all non-commuter turnpikes. The urban John Kilpatrick and Creek Turnpikes reported an increase in revenue growth for the second quarter of 2008 with a 3.5% and 3.3% increase in net toll revenues, respectively, when compared to the same period last year. Transaction growth rates in the second quarter grew 5.1% on both the John Kilpatrick and Creek Turnpikes over the same period last year.

Year-to-date revenue fund operating expenses for 2008 have been held to 8.9% under the annualized operating budget. Efforts continue by all divisions to monitor costs. Senior and total debt service ratios are attaining budgeted results, with total debt service coverage exceeding minimum trust requirements on a rolling twelvemonth basis by approximately 14%.

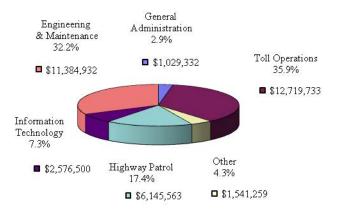


**Chart 1: Three-Year Comparison of Toll Revenues**

Second Quarter Highlights:

- As part of OTA's commitment to provide quality roadways for its patrons, pavement and bridge rehabilitation projects continue throughout the Turnpike System. In the second quarter, pavement rehabilitation projects on the Indian Nation and Muskogee Turnpikes were finalized. On the Turner Turnpike, a bridge reconstruction and pavement rehabilitation project was completed, as well as, a ramp pavement rehabilitation project. On the Will Rogers Turnpike, pavement rehabilitation at the Vinita interchange was finalized. In addition, several engineering design proposals have been solicited and contracts awarded in the second quarter.
- In June, an agreement was approved by the Authority to provide clearinghouse services for *PIKEPASS* Airport Parking Transactions at the Tulsa International Airport. This agreement is for a 5-year period with options to renew for 5-year consecutive terms. The Information Technology (IT) Division is working on the design and development of this airport parking garage application.
- During April, the Controller Division staff finalized the preparation of the 2007 Comprehensive Annual Financial Report (CAFR) and distributed the report in compliance with the trust-required deadlines. Controller Division staff performed all design work for the 2007 CAFR in-house, providing a significant cost savings to OTA. This 2007 CAFR was submitted to the Government Finance Officers Association of the United States and Canada (GFOA) to apply for the Certificate of Achievement Award for Excellence in Financial Reporting. During June, the Controller Division management staff attended the GFOA annual conference. The GFOA conference offers the most up-to-date information and education of the latest trends and financial reporting requirements affecting state and local governments. In addition, the conference provides an opportunity to interact and consult with other public finance officers from across the continent.
- The Information Technology Division, working with the Controller Division, began the development of automated reconciliation procedures in the cEnterprise system that would create efficiencies for the Controller Division's reconciliation process of patron *PIKEPASS* account activity. It is anticipated these changes will be fully implemented during the summer months. In addition, the IT Division is nearing completion on the online placement of all H. E. Bailey Turnpike right-of-way files, as well as, making strides on the design and installation of the online *PIKEPASS* application process.

- A member of the Toll Division management staff visited the Pennsylvania Turnpike Commission to research new equipment. In April, several members of the management staff attended the International Bridge, Tunnel and Turnpike Association (IBTTA) meeting in Orlando, Florida. IBTTA conferences offer attendees the opportunity to discuss new technology, products and procedures with other transportation related organizations from around the world. Additionally, the Toll Operations Managers participated in a Federal Highway Administration online conference, which focused on safety issues. This conference presented current safety practices of other tolling authorities for toll collectors and offered suggestions for enhancing safety.
- As of June 30, 2008, the total number of active *PIKEPASS* tags increased to 882,639 or 8.3% over the number of active *PIKEPASS* tags at June 30, 2007. Total active *PIKEPASS* accounts totaled 502,020, an increase of 14.2% over that of the prior year. *PIKEPASS* patrons continued to take advantage of the *PIKEPASS* volume discount program with approximately \$734,000 in discounts issued to frequent patrons of the System during the second quarter of 2008.
- During the second quarter of 2008, the OTA's Maintenance Division, supplementing labor through supervised inmates and contractors, completed various System repairs. With combined efforts, approximately 1.1 million linear feet of joints and cracks were sealed. In addition, the Maintenance Division repaired and improved approximately 59,000 linear feet of fence, and maintained approximately 10,000 acres of vegetation management.
- The Oklahoma Highway Patrol troopers continued their efforts to achieve safe patron travel through several enforcement programs. In the second quarter of 2008, OHP troopers made 30,327 violator contacts and assisted 2,656 motorists.
