#### Dear Oklahoma Turnpike Authority Bondholders:

During the fourth quarter of 2022, the OTA continued expanding PlatePay, its cashless tolling process, to the remaining tolling locations on the Cimarron Turnpike. Cashless tolling improves safety, traffic flow and reduces equipment maintenance costs by removing equipment that is required to support cash transactions. Conversion of the Cherokee and Creek Turnpikes are anticipated during the first quarter of 2023. PlatePay revenue represents 9.0% of net toll revenue for the fourth quarter of 2022.

For the fourth quarter of 2022, net toll revenues declined over the prior year fourth quarter. Net toll revenues for the fourth quarter of 2022 reported at \$93.1 million, a decrease compared to \$95.8 million when compared to the same period last year. Fourth quarter toll transactions were approximately 51.1 million, a decrease from the prior year 51.8 million transactions. Heavy truck traffic increased by 7.0% over the same period last year, although passenger traffic did experience a decline in the fourth quarter. The Gilcrease Expressway, which opened to the public in mid-November 2022, reported over \$0.3 million in toll revenue and total transactions of approximately 0.4 million.

Year-to-date revenue fund operating expenses reported at \$108.4 million, operating at 10.4% under the 2022 operating budget. Senior and total debt service ratios remain in compliance with the minimum trust requirements. Total debt service coverage exceeds minimum trust requirements on a rolling twelve-month basis by approximately 164%.

**Chart 1: Two-Year Comparison of Toll Revenues** 

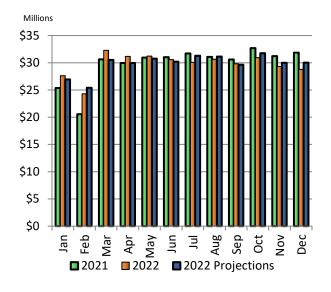


Chart 2: 2022 Revenues - Actual vs. Projections (Cumulative)

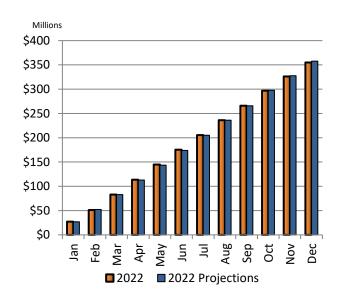


Chart 3: 2022 Operating Expenses – Actual vs. Budget Revenue Fund Only (Cumulative)

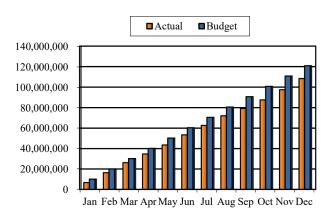
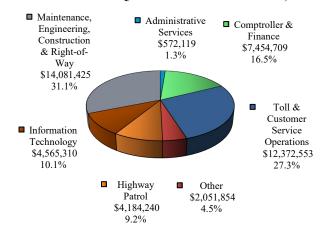


Chart 4: Operating Expenses by Division-All Funds For the Quarter Ended December 31, 2022



#### Fourth Quarter Highlights:

- The Authority adopted the calendar year 2023 Annual Budget in December. The 2023 Annual Budget includes a total of \$137.8 million for the Operating and Maintenance Budget. Consistent with the current and prior years, division managers will monitor spending levels and make necessary efforts to keep costs at or below budgeted levels. The 2023 Annual Budget also includes estimated expenditures for the Capital Plan of \$161.4 million. Additionally, the required Reserve Maintenance deposits for 2023 in the amount of \$41.1 million have been certified by the Consulting Engineer.
- Construction activity continued on the Turner Turnpike at SH-66 with the on-going construction of a new westbound fly-over bridge. This project is the last in the Driving Forward program and was approximately 47% complete at the end of the fourth quarter. The OTA continued its Capital Plan reinvestment with rehabilitation and reconstruction projects across the System. Pavement rehabilitation continued along the Will Rogers Turnpike and reconstruction of a county bridge over the Will Rogers Turnpike continued near Vinita. Additionally, reconstruction of the interchange of the Cimarron Turnpike and SH-99 includes the removal of previous cash tolling structures. Cable barrier installation remains ongoing on the Indian Nation Turnpike.
- The OTA's cashless conversions continued across portions of the Turnpike System. The Cimarron Turnpike
  became fully cashless in December 2022. The Creek and Cherokee Turnpikes are anticipated to become fully
  cashless in the first quarter of 2023. The OTA anticipates a conversion of the remainder of the Turnpike System
  to cashless tolling by the end of 2024.
- The Gilcrease Expressway Turnpike opened to the public on November 14, 2022. Completion of final punch
  list items is expected in March 2023. This project began in January 2020 and consists of approximately five
  miles of new alignment, including a new bridge crossing at the Arkansas River. This new alignment opened as
  a cashless facility.
- Design for the ACCESS Oklahoma: Advancing and Connecting Communities and Economies Safely Statewide (ACCESS) is underway, with numerous projects nearing the 30% plan stage.
- Design work continued for several other Capital Plans projects across the System. These projects include
  pavement rehabilitation, bridge rehabilitation, dowel bar retrofit and diamond-grind (resurfacing), center
  median cable barrier, interchange modifications, a service plaza redevelopment, and numerous cashless tolling
  conversion projects across the System. Ten projects are scheduled to be advertised and let to construction in the
  first quarter of 2023.

- In the fourth quarter, the Maintenance Division, supplementing labor through supervised inmates and contractors, completed various other System repairs. With combined efforts, approximately 348,000 linear feet of joints and cracks were sealed and nearly 1,400 square yards of drainage repairs were completed. The Maintenance Division also performed brush and weed control and maintained approximately 6,600 acres of vegetation management.
- As of December 31, 2022, the total number of active PIKEPASS tags exceeded 2.3 million, an increase of 7.5% when compared to the same time last year. This increase is partially attributable to the number of PlatePay customers who have transitioned to new PIKEPASS customers. PIKEPASS patrons continued to take advantage of the PIKEPASS volume discount program with approximately \$1.5 million in discounts issued to frequent patrons of the System during the fourth quarter of 2022. The Customer Service Division continued to assist customers with questions regarding interoperable transactions, PlatePay issues and other general information.
- The OHP troopers continued their efforts to achieve safe patron travel through several enforcement programs. In the fourth quarter of 2022, OHP troopers made approximately 13,000 violator contacts and assisted over 2,500 motorists.
