Oklahoma Turnpike Authority And PayNearMe Enable Cash Payment of PIKEPASS Tolls at Retail Stores

Cash payments through PayNearMe will post to PIKEPASS accounts 5-7 days faster than mailed payments

SUNNYVALE, Calif. and OKLAHOMA CITY – Nov. 21, 2016 – Through Oklahoma Turnpike Authority (OTA)’s partnership with electronic cash transaction network [PayNearMe](http://paynearme.com), nearly 1.5 million users of the PIKEPASS electronic tolling transponder can now replenish their account balance using cash at nearly 12,000 U.S. stores. Participating stores include Family Dollar, ACE Cash Express, Reasor’s Food and [more](#).

PIKEPASS holders can use PayNearMe in three easy steps:

1. Visit <http://paynearme.com/pikepass> and follow the instructions to receive a PayNearMe payment code on their mobile phone or via email.
2. Choose from a list of retail locations closest to them.
3. Visit the store and hand both the PayNearMe payment code and cash payment to the cashier.

The whole transaction in store takes less than one minute and cash payments made through PayNearMe are posted to the PIKEPASS account in less than one hour. There is a convenience fee of \$1.99 per transaction.

OTA receives approximately \$2 million in cash payments per month. Prior to implementation of PayNearMe, PIKEPASS users who did not wish to load their accounts with credit or debit cards had two options: mail a check or money order which typically required 5-7 business days before the funds appeared in the PIKEPASS user’s account, or pay in person at a PIKEPASS store during business hours.

According to the [2015 FDIC National Survey of Unbanked and Underbanked Households](#), more than 37 percent of households in Oklahoma are unbanked or underbanked, meaning they have no bank account or have a bank account and rely on alternative financial services.

“The addition of this convenient payment option through PayNearMe helps us literally and figuratively move Oklahomans forward,” said OTA Executive Director Tim Gatz. “We are continually looking to improve the service we provide to turnpike drivers and this type of investment in technological innovation is another way to do that with no interruptions to their daily commute or schedule.”

With pre-paid tolls on PIKEPASS accounts, drivers can travel easily through all 10 toll roads operated by OTA, totaling 605 miles in the state of Oklahoma. The transponder is also interoperable with the North Texas Toll Authority (NTTA), enabling PIKEPASS users to travel within North Texas.

“There are a large number of people who prefer to take care of bills after work,” said Christian Solomine, PayNearMe’s Senior Vice President of Enterprise and Government. “We’ve found that 38 percent of PayNearMe payments are made between the hours of 6 p.m. and 8 a.m. and on the weekends. Using cash should not require jumping through extra hoops, so we are proud to support OTA’s commitment to providing cash users with accessible payment options that allow them to pay in their own neighborhoods, on their own schedule.”
