<u>Discussion, review and possible action on Chapter 11 of the 2021/2024 International Plumbing Code® (IPC®)</u>

Presentation by Mr. Tom Wallace on secondary draining systems for roofs.

Mr. Wallace greeted the committee and reviewed his different options for updating the 2024 IBC and IPC code language to address secondary drainage requirements. The committee and Mr. Wallace discussed different rainfall rates in Oklahoma; that the current language could be interpreted to only allow the use of scuppers; and using the gallon per minute rate to design for secondary rainfall. They discussed the language Mr. Wallace was proposing for the 2024 code and why the language related to horizontally projected roof area was struck in his new recommendations; if the rate of rainfall should go from 10.5 inches per hour to 12 inches per hour using the 15-minute rainfall intensity durations. There was further discussion on which data sources Mr. Wallace was using to justify his rainfall rates and other numbers; and that the 2024 IBC language required the use of a new data source by location, that dealt with rainfall intensity, in Section 1611.1, based on which risk category the structure would fall under. The committee and Mr. Wallace discussed the breakdown of building risk categories; ways to modify the language; how often roofs designed to the current code, collapsed; and that rainfall rates in Oklahoma have increased 10 to 20 percent. There was further discussion on the options within his proposed changes; aligning the IBC and IPC codes; scuppers; and the OUBCC's mandate to adopt the minimum code for the state. At the end of the discussion the committee thanked Mr. Wallace for his time and input. Committee consensus was to table the item for further review.

<u>Discussion, review, and possible action on Chapter 4 of the 2021/2024 International Plumbing</u> Code® (IPC®)

<u>Discussion and possible action on comment forms FGMP-30, FGMP-50, and FGMP-51, relating</u> to Section 410.4 Substitution

Ms. Hehnly explained FGMP-30 was the language currently in the agency's rules, FGMP-50 was submitted by Mr. Durham, but it didn't address the existing language, and FGMP-51 was submitted by Mr. Favata and Ms. Armstrong as a proposal to replace the agency's existing language to the section. The committee discussed Mr. Durham's change was in addition to the language in FGMP-30, but didn't allow for a substitution; that FGMP-51 was shown to the BEBF committee at their meeting and they had proposed two slight changes; that per the BEBF committee per the IBC, a Group A with less than 50 people was considered a Group B, with a Group A use and the change in FGMP-50 was not needed. There was further discussion on the other recommendation from the BEBF committee, which was to spell out in the code that if a restaurant provided water, containers for that water would need to be provided free of charge or the restaurant would be required to provide a drinking fountain; that the change addressed the permanency of the other water source being tied to the potable water distribution and draining systems and that it couldn't be portable. They discussed it would only be for

small facilities with an occupant load of 50 or fewer to address the space taken up by the drinking fountains; removal of existing fountains after COVID; if the change was a reasonable compromise; that containers may not be available to hold water where a fountain would have been required; and that jurisdictions did not proactively go out looking to see if drinking fountains have been removed. There was further discussion on the costs and square footage the drinking fountains take up and the change was created to provide some relief to those costs and space; that there was no interest at the national level to provide anything other than drinking fountains; and that there was a need for both a high and low fountains because there were people with different disabilities beyond just people in a wheelchair. The committee discussed that a bottle filler or sink would need to be installed at specific heights that meet ADA compliance, that small facilities didn't want to put restrooms or drinking fountains in an area available to the public; different ways to modify the proposed language; issues with the current language in the OUBCC rules and what could be approved based on that language; and on the differences between the Group A occupancy and Group B occupancy with Group A use.
