423.1 General. This section applies to the design and construction of <u>above or below</u> <u>ground</u> storm shelters constructed as separate detached buildings or constructed as rooms or spaces within buildings for the purpose of providing protection from tornadoes hurricanes and other severe windstorms during the storm. This section specifies where storm shelters are required to provide requirements for the design and construction of storm shelters. Any room or structure, as may be used as a place of refuge during a severe windstorm event, shall not be defined as a storm shelter unless specifically designed to the requirements as listed in Section 423. Design of facilities for use as emergency shelters after the storm are outside the scope of ICC 500 and shall comply with Table 1604.5 as a Risk Category IV Structure.

This comment form is to incorporate the new language of the 2024 IBC along with the intent of Staff Comment Form BEBF 8.

The language was originally added to clarify that storm shelters can be both above or below ground and to prevent people from using the term "storm shelter" if a space was not designed and constructed in accordance with ICC-500.
