#### CERTIFIED MANUFACTURED HOME INSPECTOR INSTRUCTION SHEET

Applications for license are presented to the Commission Board for consideration the second Tuesday of each month. The below requirements must be submitted eleven days prior to that meeting. **Applications that are incomplete will delay the application process.** The license will be issued only after all of the requirements have been met. Submitting an application does **NOT** authorize you to conduct any business as a Certified Manufactured Home Inspector.

#### **Qualifications and Education Requirements**

- 1. Applicant must be licensed as an installer in the State of Oklahoma for a minimum of 1 year or be in the industry for a minimum of 3 years or other equivalent professional qualifications that must be approved by the Manufactured Housing Advisory Committee.
- 2. Education shall include a minimum (8) hours of training in a classroom setting, visual/picture test, and four hours of on-site training that has been approved by our office.

Note: If any test is failed, it can be retaken in 90 days. If the second test is failed the test can be retaken in 12 months from original test date.

#### **Application Requirements**

- 1. Initial Application completed in full.
- 2. OSBI Report. All applicants are required to submit a current report from the Oklahoma State Bureau of Investigations (OSBI Report). The report must include all three searches: Name Based, Sex Offender and Violent Offender. You may contact OSBI at (405)848-6724 or visit their website at https://www.ok.gov/osbi/. Felony Applicants: Felony Applicants must submit copies of the Judgment and Sentencing documents for all convictions. Felony applicants are required to make a personal appearance before the Manufactured Home Advisory Committee and the Board of Commissioners. All documentation must be in our office BEFORE your appearance will be scheduled.
- 3. Copy of Current Driver's License.
- 4. Copy of 8-hour training Certificate.
- 5. Copy of visual/picture test results.
