C. Executive Director's Report:

As of the 14th of January, we are at 143% normal rainfall statewide, and every climate region is normal or wetter for the last 30 days. West Central OK is wettest at 236% normal rainfall. According to NOAA's seasonal drought outlook, most of Southwest and South-Central Oklahoma, as well as a large area in Northeast Oklahoma along the Kansas border, will see persistent drought through March. Crop Moisture Index shows normal to moist conditions statewide, which will be enhanced by snowmelt when we thaw out.

Out of over 2,800 companies participating, OWRB was one of only 2 state agencies that was named to The Oklahoman's list of top 100 companies. Staff from across the agency attended the awards ceremony. We were thrilled to see employee participation in the survey reached a record, 89.8% for 2023. Companies are ranked on survey answers from an anonymous employee satisfaction survey administered by a 3rd party.

2023 Legislative Session:

Bill: 1331 (S. Bullard) Water Infrastructure Investment Revolving Fund and Grant/Loan program. \$250million. Senator Bullard has asked for our help to craft language that would roll our budget requests for funding to leverage our existing loan programs and fund the REAP grant program. Our ROI estimate is showing a dollar for dollar return on state investment, with an estimated \$508 million in funds available through federal dollars, bond proceeds, and local match.

Bill: SB 1391 (Rogers) Oklahoma Water Resources Board; creating the Arkansas River Levee Improvement revolving fund; making an appropriation.

Bill: SB 1352 Authors: Bullard. Reservoirs; creating the Reservoir Capital Investment Fund and the Water Sustainability Revolving Fund for purposes of reservoir construction; authorizing a fee for water used for growing commercial marijuana.

Bill: SB 1580 Authors: Woods, Tom Summary: Requires a board of county commissioners to intervene when rural water districts face certain emergency issues and authorizes the commissioners to direct a study by the Water Resources Board on sustainability.

HB 8941 (Rep. Newton) well spacing HB 8942 (Rep. Newton) Metering Hb 8943 (Rep. Newton) Critical GW Mgmt. Areas

Bill: SB 1341 Authors: Howard Water and water rights; establishing requirements for basins within a critical groundwater management area.

D. Financial Update

Mr. Cleve pierce, Chief Administrative Services Division, presents the budget report for the period ending December 2023. Mr. Pierce reports the agency has spent 51 % of it appropriated budget leaving 49 %; spent 29% of its revolving budget, leaving 71%; has spent 14% of its federal budget, leaving 86 %. Overall, the total budget remaining is 72% with 52% of the year remaining.

2. FINANCIAL ASSISTANCE DIVISION

A. Consideration of and Possible Action on a Proposed Order Approving State Loan Program Revenue Bond Loan Funding Application for the Minco Municipal Authority, Grady County, Oklahoma. Recommended for Approval.

This is a \$7,635,000 loan request from the Minco municipal authority located in Grady County. They are requesting the loan for transforming their existing wastewater lagoon system into a seasonal discharge and land application process consisting of an irrigation system with center pivot irrigation. The loan will also fund the replacement of old cast iron water mains which will assist in reducing water loss and improve the reliability of their water supply. The loan will be funded through the fap revenue bond loan program with a fixed interest rate and will have a maturity not to exceed thirty years. The loan will be secured with a lien on Minco's water and sewer system revenues, a 3-cent sales tax, and a mortgage. Their debt coverage ratio stands at 1.84 times. Staff recommends approval.

B. Consideration of and Possible Action on a Proposed Order Approving State Loan Program Revenue Bond Loan Funding Application for Muskogee Municipal Authority, Muskogee County, Oklahoma. Recommended for Approval.

This is a \$82 million loan request from the Muskogee municipal authority. They are requesting the loan for major improvements to their wastewater treatment plant, rehabilitate a sewage pump station, flow equalization basins, and headwork facilities, and demolish facilities that are no longer

in service. The loan will be funded through the fap revenue bond loan program with a fixed interest rate and will have a maturity not to exceed 30 years. We will secure the loan with a lien on Muskogee's water and sewer system revenues and a half cent sales tax. Muskogee has been a long-time good loan customer of the board's and they currently have five outstanding loans with you with a combined balance of approximately \$48.7 million. Their debt coverage ratio stands at 1.5 times. Staff recommends approval.

*Public comments were made by two meeting attendees. Their comments are below:

- 1.) Will Archer: "I am Will Archer, and I am the manager for the Mountain Park Master Conservancy District that is over Tom Steed Revisor, and we provide water to Altus, Fredrick, and Snider, I want you to know these aren't just rules, 40,0000 people in SW Oklahoma count on this water on a daily basis. Most of them rely on it 100% with no alternative for other water sources. So, I want you to know these rules came from, ah, you know the basin study? The Red River Basin Study that started with the SW action plan. The SW action plan started with Altus Airforce Base being voted the worst military installation in the United States due to lack of water. So, I think that's a big deal, that that military base was at risk, and this wasn't voted by SW Oklahoma, the Pentagon said that Altus Airforce base was the worst military installation in the country due to lack of water. And so, these rules come in not only to protect the 40,000 people but protect things such as Altus Airforce Base and the Department of Defense investment in that. And so, this rule is a step in a long journey, this a step in the right direction. I believe that these rules are legacy work and I believe its something that provides resilience for SW Oklahoma, it provides reliability for my kids and my grandkids, and these are things that we have to do, because what we saw prior to these rules, was we saw Altus, Altus Airforce Base, Fredrick, Oklahoma, reduce their usage by 40% of their normal everyday use and upstream users never had to reduce in 2011, not 1%. And we held a senior water right in SW Oklahoma, and those cities had to reduce, we had to shut businesses down right in Altus, Oklahoma, we weren't able to open business due to lack of water. You had upstream users never had to reduce one single percent. You know, these rules are a step in the right direction, I do believe it's a journey, I do believe it's a process. But I want you to understand these aren't just rules, this is protection for SW Oklahoma, this is protection for Department of Defense, this is protection for a military installation that is vital to the survival of Altus, Oklahoma. So, as a Mountain Park Conservancy District and the manager there, I've never managed anything but a drought it seems like and I've been there 12 years, so I want you to know that we're excited about these rules, that these rules are legacy work and their based, not on our opinion, not on the Boards opinion, but these rules are based on the science. And what we found through a great partnership and the Red River Basin Study where we saw the districts Lugert Altus, Tom Steed Revisor, Oklahoma Water Resources Board and the Bureau of Reclamation and we got in this and we said Hey, let's see what the science says and let's do what's best for SW Oklahoma and I believe these rules are the first step in a long journey protecting water for SW Oklahoma."
- 2.) Duane Smith: "Good morning, my name is Duane Smith, I'm a consultant for the Mountain Park Master Conservancy District and I want to talk just a little bit about the question of those permits upstream. So, back when the drought hit, so back when Tom Steed Reservoir was built, the articles in the newspaper were we solved our water problems forever in SW Oklahoma. And so what we do in our water law is we issue water rights for a reservoir and a community purchases that reservoir and builds that reservoir so that it will have water during the worst drought of record. Then we issue water rights upstream of that reservoir for the average annual flow in the reservoir and that is what's happened all across Oklahoma and so what we found in the study that we did with the Bureau of Reclamation, which was \$3 Million dollars and over eight years, I don't think there's any way the State or certainly the district could have of afforded the technical work that was done here. But what we found is that if we continue to issue those water rights upstream with those reservoirs, it diminishes the yield of that reservoir, so what that means to Tom Steed, as we issue more water rights upstream, it diminishes the percentage of time that the City of Altus could have water during the worst drought of record. So this, this is a huge step forward. I think Julie, probably the biggest step toward sustainability in a long long time in Oklahoma water law and I think Chris, your staff and Chris did such an important piece, he's been to numerous meetings, he's worked with Reclamation technical staff, and they've come up with this rule that follow that upper Red River Basin accordingly. And as Will said, there's other things in that report that are recommended, so this is one step, this one step in the right direction. And we want to thank staff of the Water board, we want to thank the Board for considering the rule, and would hope that you approve this rule and send it on to the legislature and the Governor. Thank you."
