Background

- As early as 2007 communities and rural water districts in Delaware and Adair Counties began conversations about creating a regional water system
- In 2012, meetings began in earnest with 4 towns and 2 rural water districts which all operated independent water systems
 - West Siloam Springs, Colcord, Kansas, Watts, Delaware #11 and the Flint Ridge RWD.
 - Watts was included in the original feasibility study but elected not to participate in the original project.
- In November 2013, the South Delaware County Regional Water Authority was formed with Delaware County as its beneficiary.
 - Members included representatives from each of the 5 remaining communities and rural water districts
- Authority and Cherokee Nation commissioned the feasibility study with HUB Engineers.



The Project and its benefits

- Flint Ridge Site
 - New intake structure on Illinois River
 - Replacement and Expansion of the existing water treatment plant within Flint Ridge
 - 2MGD capacity to serve projected 3185 customers
 - 2 pump stations and water distribution line to WSS
 - 2 water storage tanks for pressure
 - New clearwell
- Delaware #11
 - New distribution line to Colcord
- Consolidated 4 independent systems into one wholesale system
 - Eliminated 2 active consent orders
- Saves each entity money in water production cost

Challenges to Process

- Seed funding for initial study
 - Cherokee Nation really came through to provide initial dollars to determine if the project was feasible
- Structuring Challenges
 - Creating new Title 60 public trust
 - Dissolving existing RWD
 - Lease of ground from private entity for new WTP
 - ROW and site acquisition for towers, lines, pump stations, etc.
- Economic
 - Could we really provide a wholesale water rate that was less expensive than each entity could provide for themselves
 - Commitment to initial water rate of \$3.60 a gallon or less
- Logistic
 - Approved by each town authority and rwd participant
 - Staying ahead of the education process



Advantages to Water Customers

- Safe, clean, affordable drinking water
 - Secured long-term low interest loans through DWSRF and RUS
 - DWSRF Regionalization Principal Forgiveness
 - \$1,700,000
 - RUS Grants
 - \$3,866,000
 - IHS Grant
 - \$1,629,000
- Each member entity maintains their own internal system after the master meter
- Each member entity has a say in the setting of the water rates since they have a seat at the table

Timeline to Project Commissioning

- Summer 2012 Organizational Meeting
- November 2013 creation of South Delaware County Regional Water Authority
- Summer 2014 Engineering Feasibility Report Completed
- 2014/2015 Negotiation of Water Purchase Contract with member Entities
- 2016 Plans and Specifications
- Late 2016 final permitting and loan approvals
- Loan Closing May 2017
- December 2019 plant commissioned and water service begins

2025 Updates

- Added additional water systems as wholesale customers
 - Watts, Chewey, and Cookson Hills
 - Authority now serves 9 independent water systems with future expansions planned
- ARPA Tribal Match Expansion in 2023 (Cherokee Nation)
 - Additional water line expansion and road/river bores
- Phase II ARPA Expansion (\$12M with Tribal Match)
 - Additional treatment capacity to serve water systems
 - Expands capacity to 3 MGD
 - New 1MG water tower
 - Dedicated water supply lines to 2 towers from the water plant

Real Cost Savings

- Regionalization would not have been possible without our partners at the Cherokee Nation, RUS, OWRB, and DEQ
- Estimated savings to communities so far of over \$30M in interest and infrastructure costs

SDCRWA has greatly benefited our town by allowing Oklahoma communities to purchase water produced within the state, rather than buying from a neighboring city located out of state. This shift has reduced costs and helped us keep rates affordable for our residents.
