2022 EXAMINATION INFORMATION

Applicants for *Initial Licensure* for Professional Engineers and Professional Land Surveyors are **NOT** required to file an application with this office until such time as they have completed all education, examination, and experience requirements.

All FE, PE, FS and LS exam registration is done through NCEES and all candidates must create a MyNCEES account at https://ncees.org/ to register for the exam(s) and to create an NCEES Record.

Once all requirements have been met (education, examinations, and experience), all initial Professional Engineer applicants will be required to submit a NCEES Record through their MyNCEES account.

PRINCIPLES & PRACTICE OF ENGINEERING (PE) EXAM

All PE Exams (other than Structural Vertical Forces and Structural Lateral Forces) are now computer-based tests (CBT) administered at NCEES approved Pearson VUE Testing Centers. The list of available testing centers can be found when you register for the exam through your MyNCEES account.

FUNDAMENTALS OF ENGINEERING (FE) EXAM & FUNDAMENTALS OF SURVEYING (FS) EXAM

• The FE Exam and FS Exam are administered by NCEES using Computer Based Testing (CBT) and offered year-round. No prior approval or application is required to register with NCEES for these exams. You may apply to the Board for certification as an Engineer Intern or Land Surveyor Intern following completion of your education and examination requirements at www.pels.ok.gov.

PRINCIPLES & PRACTICE OF SURVEYING (PS) EXAM & OKLA. LAW & SURVEYING (OLS) EXAM

- The PS Exam is administered using CBT and is offered year-round.
- You must have your Application approved by the Board prior to sitting for the OLS Exam. You should submit your Application to the Board at least one month prior to the next regularly scheduled Board Meeting. 2022 OLS Exam dates are: January 20, March 31, July 14 and October 20.
