**I. Call to Order –Chairman Richard Miller** – On Wednesday, November 5, Chairman Richard Miller called the special meeting of the Pardon and Parole Board (PPB) to order at 9:00 a.m.

**II. Action Item: Clemency Hearing for Tremane Wood**

Chairman Richard Miller explained that the purpose of the day's meeting was to hold a clemency hearing for **Tremaine Wood, DOC # 271967**

Chairman Richard Miller briefly went over the order of events for the hearing.

Amanda Bass Castro Alves, Brooklynn Wood, and Cindy Birdwell, presented on behalf of Mr. Wood for 35 minutes, having reserved 5 minutes for rebuttal.

The meeting recessed at 9:54 AM and reconvened at 10:00 AM.

Oklahoma Attorney General Genter Drummond, and Assistant Attorneys General Christina Burns, Samantha Baggett, and George Burnett made a 40-minute presentation to the Board in opposition of clemency for Mr. Wood. The State waived its 5-minute summation period.

There was no presentation by victims or victim's representatives.

The meeting recessed at 10:55 AM and reconvened at 11:06 AM.

Tremane Wood appeared and provided a statement to the Board by video via Zoom.

Mr. Wood's legal counsel provided a 5-minute rebuttal and answered questions from the Board.

The meeting recessed at 11:24 A.M and reconvened at 11:34 A.M.

Chairman Richard Miller called for a vote on clemency for Tremane Wood, and the vote was 3-2 to recommend clemency.

The final action of the Board was to recommend clemency for Tremane Wood.

The Clemency Hearing was adjourned at 11:36 A.M. on **November 5, 2025**.
