The Chairperson may interrupt and/or terminate any presentation during public comment which does not conform to the procedures outlined under this Section. The Chairperson reserves and retains the right to limit the comment time available to ensure efficiency of the meeting and to interrupt, terminate, or postpone public comment as necessary to effectuate the management of the public meeting. Board members will not respond to public comments at this time. Nonetheless, to effectuate the meeting, the Chairperson may at his or her discretion remove the public comment agenda item from any agenda.*
