## Instructions for completing Oklahoma Nonresident Royalty Withholding Tax Return

<p style="text-align: center;"><b>When to File</b></p> <p>Withholding amounts are due on or before the 30th day of the month following the end of each calendar quarter for payments made to nonresident royalty interest owners. Reports must be postmarked on or before such date.</p> <p style="text-align: center;"><b>Electronically</b></p> <p>File and pay electronically by using OkTAP, located at <a href="http://tax.ok.gov">tax.ok.gov</a>.</p> <p style="text-align: center;"><b>Paper</b></p> <p>If filing by paper, make checks or money orders payable to the Oklahoma Tax Commission and mail with your report to: <b>(This address is for payments ONLY.)</b></p> <p><b>Oklahoma Tax Commission PO Box 26860 Oklahoma City, OK 73126-0860</b></p> <p>Do <b>NOT</b> mail correspondence to the address above.</p>	<p>If you must contact us in writing, include your name and account number, and mail your correspondence to:</p> <p><b>Oklahoma Tax Commission Oklahoma City, OK 73194</b></p> <p style="text-align: center;"><b>Specific Item Instructions</b></p> <p>ITEM E. (Address Change) - Check Box E to notify us of address change. Write new address in section E.</p> <p>ITEM F. (Out of Business) - If this is your last return as a remitter, check Box F and give the Date Out of Business.</p> <p>ITEM G. (Amended Report) - Check to correct a previously filed return. In Item B include the reporting period you are amending. Enter total corrected amounts on lines 1, 2 and 5 of the return and not the amount of the adjustment.</p> <p>ITEM H. (Number of Nonresident Royalty Owners) - Enter the number of nonresident royalty interest owners as of your last quarter.</p>	<p style="text-align: center;"><b>Specific Line Instructions</b></p> <p>LINE 1. (Royalty Interest) - enter total Oklahoma royalty interest paid to nonresident royalty owners from which withholding was required this period.</p> <p>LINE 2. (Tax Withheld).</p> <p>LINE 3. (Interest) - if this return and remittance is filed after the due date, multiply the amount on line 2 by 1.25% for each month, from the due date until paid.</p> <p>LINE 4. (Penalty) - If this return and remittance is filed after the last day of the month when due, multiply the amount on line 2 by 10%.</p> <p>LINE 5. (Total Due) - Total the amounts on lines 2 through 4.</p>
