Oklahoma Tax Commission Regular Meeting Minutes August 14, 2018

- 1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 1:30 p.m., on the above date, in the Oklahoma City office. Notice of said meeting and the agenda therefor were posted in prominent public view at the Commission's principal office in Oklahoma City from and after 1:30 p.m., on August 13, 2018.
 - Chairman Burrage called the meeting to order. Other members present were Vice-Chairman Jolley and Secretary-Member Kemp. Also present was Lee Pugh, General Counsel.

INTEROFFICE MEMORANDUM

SUBJECT: EL RENO TAG AGENCY APPOINTMENT

This memorandum was written in response to the allegations regarding my recommendation for a new motor license agent in El Reno and an explanation of my actions regarding the recommendation.

The Motor Vehicle Division conducted interviews of all 21 applicants for a tag agency in El Reno. After completion of the interviews and background checks, the Division sent me a recommendation to appoint Ryan Steinbruck. I reviewed the application and identified a couple of concerns.

My first concern was that Mr. Steinbruck's father-in-law is a tag agent in Mustang. I had already instructed the division that I would not accept a recommendation for the spouse of another existing agent. The statutes provide that a motor license agent is permitted to only operate a motor license agency at a single location and is prohibited from operating subagencies or branch agencies.

My second concern was that Mr. Steinbruck had applied for the appointment in conjunction with another individual, Miranda Davis. Apparently both were applying for the appointment separately but if one received the appointment they intended to operate the agency as a partnership.

In recent years, we have experienced agents questioning the accuracy of the 1099s issued based on the fees that the agent received. I recently experienced an agent claiming that the earnings were not hers but that of a corporation. As you know, the Commission only appoints individuals as motor license agents and not any other legal entity and a contract is signed with the appointee.

Also, some agents have blamed employees or office managers in their offices for problems that have arisen. I was concerned about an appointee not taking full responsibility for all issues that may arise in an agency.

I met with the Division Director to discuss these concerns. She explained to me that after conducting all her interviews that she had identified 5 top candidates. The five top candidates were Mr. Steinbruck, Ashley Abshire, Susan Schwarz, Patricia Hobson, and Ms. Davis. The Director asked a committee in her office to review the applications from these five and make a recommendation. The committee recommended Mr.

Steinbruck. Based on that and despite my misgivings, I asked that Mr. Steinbruck be placed on the agenda.

After the agenda came out, Chairman Burrage told me that he had concerns with the recommendation and that his concerns were identical to mine (relationship to an existing agent and the proposal to operate the agency as a partnership). Chairman Burrage stated that if I was confident in my recommendation that he would not object but that he did not believe that he could vote in favor to appoint Mr. Steinbruck.

Having my misgivings confirmed by the Chairman, I asked him to remove the recommendation from the agenda. I told him that I would place the divisions "next best candidate" on the agenda the following week. I did not identify the next candidate to the Chairman. At the next Commission meeting (August 7, 2018), Ms. Abshire was placed on the agenda for the Commission's consideration.

Mr. Steinbruck called my office to inquire why he was not appointed by the Commission. I returned his call and explained that the Commission did not reject him but that I had asked that he be removed from consideration. I explained my concerns about his intent to operate the agency as a partnership. He explained that he wanted someone he could trust to run the agency when he was not present. I stated that I understood that, but based on recent experiences that I was not comfortable in recommending him. He stated that he did not agree with my decision but that he understood.

Since that call, Mr. Steinbruck sent an email attacking my veracity and accusing the Chairman of unduly influencing the appointment. I resent his accusations and absolutely deny his fabrication of events leading up to the recommendation.

At no time, did Chairman Burrage instruct me or attempt to influence me to recommend a specific individual for appointment. Chairman Burrage simply voiced his concerns as any Commissioner has a right and obligation to do.
