## Oklahoma Tax Commission Regular Meeting Minutes November 5, 2019

1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 1:30 p.m., on the above date, in the Oklahoma City office. Notice of said meeting and the agenda therefor were posted in prominent public view at the Commission's principal office in Oklahoma City from and after 1:30 p.m., on November 4, 2019.

Vice-Chairman Jolley called the meeting to order. Other member present was Vice-Chairman Jolley. Also present were Ernest Short, Counsel to the Commissioners and Joseph Gappa, General Counsel.

- 2. Vice-Chairman Jolley moved to approve the minutes of the regular commission meeting on October 29, 2019. Secretary-Member Burrage seconded the motion. Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.
- 3. Executive Director's Report Stigler Tag Agent passed away. Executive Director is sending an Oklahoma Tax Commission employee to run the agency in the interim and opening the position to accept applications.

## Personnel Transactions:

Vice-Chairman Jolley moved to approve personnel transaction 3499. Secretary-Member Burrage seconded the motion. Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.

4. Vice-Chairman Jolley moved that the Commission resolve into Executive Session for the purpose of discussing confidential taxpayer matters and proceedings. Secretary-Member Burrage seconded the motion. Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.

An executive session was held, after which the Commission returned to open meeting.
