Oklahoma Tax Commission Regular Meeting Minutes December 10, 2019

- 1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 1:30 p.m., on the above date, in the Oklahoma City office. Notice of said meeting and the agenda therefor were posted in prominent public view at the Commission's principal office in Oklahoma City from and after 1:30 p.m., on December 9, 2019.
 - Vice-Chairman Jolley called the meeting to order. Other member present was Secretary-Member Burrage. Also present were Ernest Short, Counsel to the Commissioners and Joseph Gappa, General Counsel..
- 2. Vice-Chairman Jolley moved to approve the minutes of the regular commission meeting on December 3, 2019. Secretary-Member Burrage seconded the motion. Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.
- 3. Executive Director's Report; Personnel Transactions: Vice-Chairman Jolley moved that the Commission approve personnel transactions 3544 and 3545. Secretary-Member Burrage seconded the motion. Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.
