## Oklahoma Tax Commission Meeting Minutes June 30, 2020

1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 1:30 p.m., on the above date, virtually. Notice of said meeting and the agenda therefor were posted in prominent public view at the Commission's principal office in Oklahoma City from and after 1:30 p.m. on June 29, 2020.

Chairman Prater called the meeting to order. Other members present were Vice-Chairman Jolley and Secretary-Member Burrage. Also present were Ernest Short, Counsel to the Commissioners and Joseph Gappa, General Counsel. (All members attending virtually.)

2. Vice-Chairman Jolley moved to approve the minutes of the regular commission meeting on June 16, 2020. Secretary-Member Burrage seconded the motion. Chairman, aye; Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.

## 3. Executive Director's Report:

Executive Director advised we are accepting applications for three new tag agents; In the future the Executive Director is to only bring the tag agent making the cut to the Commissioners for approval and appointment.

  Counsel to the Commissioners to obtain record of proceedings to review and report back to the Commissioners.
- 6) IT Infrastructure Audit and Vulnerability Assessment -2019 was presented to the Commissioners. Secretary-Member Burrage moved to accept the report. Vice-Chairman Jolley seconded the motion. Chairman, aye; Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.
