Oklahoma Tax Commission Meeting Minutes August 18, 2020

- 1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 10:00 a.m., on the above date, virtually. Notice of said meeting and the agenda therefor were posted online and in prominent public view at the Commission's principal office in Oklahoma City from and after 10:00 a.m. on August 17, 2020.
 - Chairman Prater called the meeting to order. Other members present were Vice-Chairman Jolley and Secretary-Member Burrage. Also present were Ernest Short, Counsel to the Commissioners and Elizabeth Field, Interim General Counsel. (All members attending virtually.)
- 2. Vice-Chairman Jolley moved to approve the minutes of the regular commission meeting on August 11, 2020. Secretary-Member Burrage seconded the motion. Chairman, aye; Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.
- 3. There was no report from the Executive Director.
