 - Chairman Prater called the meeting to order. Other members present were Vice-Chairman Jolley and Secretary-Member Burrage. Also present was Ernest Short, Counsel to the Commissioners. (All members attending virtually).
- 2. Vice-Chairman Jolley moved to continue the meeting to 1:30 P.M. on Friday, February 19, 2021, due to the weather and rolling blackouts. Secretary-Member Burrage seconded the motion. Chairman, aye; Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.

- 3. The regularly scheduled meeting of the Oklahoma Tax Commission was continued from Tuesday, February 16, 2021.

- 12. Commissioners discussed a review by Internal Audit of the processing of claims for refunds on original and/or amended returns.
- 13. Commissioners discussed Agency Operations, Communications and Management. Chairman Prater will compile a list of companies to complete an operations audit and enterprise risk assessment.
