INVESTMENT CONSULTING SERVICES AGREEMENT

This Investment Consulting Services Agreement is entered into between the Board of Investors of the Oklahoma Tobacco Settlement Endowment Trust Fund (the "Board") and _____ ("Consultant") on this ____ day of _____, 2025.

WHEREAS, the Board is statutorily authorized and empowered to retain investment consultants necessary and prudent to manage the Oklahoma Tobacco Settlement Endowment Trust Fund ("Fund") pursuant to 62 O.S., § 2306 of Oklahoma Statutes; and,

WHEREAS, the Board desires Consultant to act as an investment consultant; and,

WHEREAS, the Board issued a Request for Proposals for Investment Consulting Services dated _____ ("RFP"); and,

WHEREAS, the Consultant is willing to accept the duties and responsibilities of an investment consultant to the Oklahoma Tobacco Settlement Endowment Trust Fund;

NOW, THEREFORE, in consideration of the mutual considerations provided in this Agreement, the Board and Consultant agree as follows:

1. Appointment. Consultant will act as investment consultant with respect to the investments of the Fund for which the Board appoints it as investment consultant.

2. Compensation. Fees for investment consulting services provided by Consultant to the Board shall consist of a retainer based fee on all services but does not include development or implementation of alternative investment assets and strategies.

The annual retainer based fee shall be:

The fees detailed above shall be reduced as specified in the following instances:

All fees will be billed quarterly, in arrears, in equal installments by Consultant to the Board.

3. Term. This contract is an annual contract and can be renewed annually for up to four years at the discretion of the Board, provided there are no material changes to the terms of the contract.

4. Consulting Services. Consultant shall perform all of the services described in Section V of the Board's RFP. Consultant shall perform these services consistent with

Consultant's proposal in response to the Board's RFP. The RFP and Consultant's proposal dated _____ are both specifically incorporated herein by reference.

5. Fiduciary Status of Consultant. The Consultant agrees to act as a "fiduciary" with respect to the Board within the meaning of Section 3(21)(A) of the Employee Retirement Income Security Act of 1974 ("ERISA") and observe the standards applicable to a "fiduciary" within the meaning of ERISA.

6. Confidentiality. All work and activities by Consultant for the Board shall be strictly confidential, and Consultant shall in no instance discuss the Board's account with the press or any other affiliated parties unless expressly authorized by the Board.

7. Delivery of Form ADV, Part II. Consultant is registered as an investment adviser under the Investment Advisers Act of 1940, as amended. Pursuant to such act, Consultant has delivered with this Agreement a true and complete copy of Part II of its Form ADV to the Board. The Board acknowledges: (1) receipt of a copy of Part II of Consultant's Form ADV; (2) that delivery of Part II of Form ADV does not imply that the U.S. Securities and Exchange Commission has made any recommendation of Consultant; and (3) the Board has the right to terminate this Agreement, without penalty, within ten (10) days of the date of the Agreement.

8. Compliance with Legal and Ethical Requirements. The Consultant shall comply with all applicable foreign, international, federal, state, county and local laws, regulations, ordinances, registrations, filings, approvals, authorizations, consents and examinations and ethical requirements ("Legal Requirements"), and all provisions required by such Legal Requirements to be included in this Agreement are hereby incorporated by reference.

9. Replacement of Consultant's Agents. Upon demand by the Board, the Consultant shall replace any agent assigned to perform services under this Agreement who the Board determines is unable to effectively execute the responsibilities required by this Agreement.

10. Liability. Notwithstanding any provision to the contrary in this Agreement, in the RFP, or in Consultant's proposal, nothing shall be construed to limit either party's liability either party's remedies at law or in equity, or either party's legal defenses in the event of a material breach of this Agreement.

11. Audit or Examination of Records.

- (1) The Consultant agrees that any authorized representative of the Board or other authorized state officials shall have access to and the right to examine, audit, excerpt and transcribe any directly pertinent books, documents, paper, and records of the Consultant relating to this contract.
- (2) All records relating to this contract, with the exception of custodian statements and records, shall be retained for seven (7) years following the date of final payment or completion of any required audit, whichever is later. Matters involving litigation shall be kept for one (1) year following the termination of litigation, including all appeals.

- (3) Compliance with the clause does not relieve the Consultant from retaining any records required by other laws or regulations of federal, state or local government units.

12. Certification Clause. The parties to this contract certify that no person who has been involved in any manner in the development of this contract while employed by the State of Oklahoma will be employed to fulfill any of the services provided for under said contract. Furthermore, Consultant nor anyone subject to the Consultant's direction or control has offered or given any gift, money or anything of value or any promise for future reward or compensation to any officer or employee of the State of Oklahoma, either directly or indirectly, in procuring this contract.

13. Effective Date. This Agreement shall be effective the _____ day of _____ 2025.

14. Termination and Assignment. This Agreement shall continue in effect until terminated by either party by giving to the other party notice in writing at least thirty (30) days prior to the effective date of termination. This Agreement and any obligations hereunder shall not be assignable by either party without the consent of the other party. After the effective date of termination, the parties' respective obligations hereunder shall cease, provided, however, that a termination shall not affect the parties' rights and obligations arising prior to the date of termination. Final billing by Consultant shall be prorated to the effective date of termination.

15. Waiver. Waiver by the Board of any breach of any provision in this Agreement shall not be a waiver of any prior or subsequent breach. Any waiver shall be in writing and any forbearance or indulgence in any other form or manner by the Board shall not constitute a waiver.

16. Modification of Agreement. This Agreement may be amended only by a written instrument signed by the Board and Consultant.

17. Notices. All notices, requests, demands or other communications required or desired to be given hereunder or under any law now or hereafter in effect shall be in writing. Such notices shall be deemed to have been given if delivered by facsimile with telephone confirmation of receipt, or by overnight courier, or if mailed by first class registered or certified mail, postage prepaid, and addressed as follows (or to such other address as either party from time to time may specify in writing to the other party in accordance with this notice provision):

If to Consultant:

18. Governing Laws and Venue. This Agreement shall be construed in accordance with the laws of the State of Oklahoma (without regard to the legislative or judicial conflict of laws rules of any state), except to the extent superseded by Federal law. Should either party initiate a lawsuit or other dispute resolution proceeding over any matter relating to or arising out of this Agreement, such lawsuit or other proceeding shall be filed in and conducted in Oklahoma County, Oklahoma.

19. Entire Agreement. This Agreement, the Request for Proposal, any proposal or other information submitted in response to the request for proposal and any and all Exhibits, Schedules and Appendices attached hereto, contain the entire and exclusive statement of the terms of the agreement between the parties pertaining to the subject matter of this Agreement, and supersedes all previous oral and written agreements or understandings, and all contemporaneous oral and written negotiations, commitments, understandings and communications between the parties relating to the subject matter of this Agreement. No party has been induced to enter into this Agreement by, nor is any party relying on, any representation or warranty outside those expressly set forth in this Agreement. This Agreement shall control over any conflicting provision in the RFP, and the RFP shall control over any conflicting provision in Consultant's proposal.

20. Exhibits, Schedules and Appendices. The Exhibits, Schedules and Appendices attached hereto are incorporated in and made a part of this Agreement by reference. If any conflicts, inconsistencies or ambiguities should arise between or among this Agreement and the incorporated documents, the following precedence shall be used to interpret the requirements of this Agreement:

(1) The terms of this Agreement; and (2) the terms of the Exhibits, Schedules and Appendices according to the order in which they appear.

21. Execution in Counterparts. This Agreement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

22. Severability. The terms and provisions of this Agreement shall be deemed to be severable one from the other, and determination at law or in a court of equity that one term or provision is unenforceable shall not operate so as to void the enforcement of the remaining terms and provisions of the entire Agreement, or any one of them, in accordance with the intent and purpose of the parties hereto.
