#### To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the December monthly investment performance report. I trust you will find it thorough and in keeping with my commitment to provide disclosure of the economic environment and portfolio results. As always, my staff and I are available to answer any questions.

#### **Market Conditions**

The treasury curve remained steady during December, with the benchmark 10-year ending the month at 1.91% in comparison to 1.77% at the end of November. The 1-year treasury was at 1.58% and the 2-year was slightly flatter at 1.57%. The 5-year was at a 1.69% and the 30-year at 2.39%.

The stock market ended the year strong with all three major indexes reaching highs during the month. The S&P 500 ended the year at 3,230 with earnings of 29% for 2019, reflecting the highest return since 2013. The Dow Jones was at 28,538 and the Nasdaq finished 8,972, earning respectively for the year 22% and 35%.

The Federal Open Market Committee (FOMC) decided in December to make no increases to its benchmark rate, after lowering rates at the last three meetings. According to the Wall Street Journal, "Fed officials' new projections showed most officials believe rates are low enough to stimulate growth. They expect that if their economic outlook holds, they can keep rates steady through 2020".

#### **Economic Developments**

The November non-farm payroll numbers beat expectations coming in at 266,000. The robust payroll number was attributed to the end of the GM strike, which increased employment by 41,300. According to CNBC "September's estimate went up 13,000 to 193,000 and the initial October count increased by 28,000 to 156,000. Those changes added 41,000 to the previous tallies and brought the 2019 monthly average to 180,000, compared with 223,000 in 2018". The unemployment rate also declined to 3.5%, which was again at the lowest jobless rate since 1969.

The Labor Department reported the consumer price index (CPI) rose 0.3% for the month of November and 2.1% from twelve months before. Core CPI, which excludes volatile food and energy costs, gained 0.2% for the month and 2.3% from November 2018. According to Bloomberg News, "energy and shelter were the primary factors boosting November inflation. Energy prices rose 0.8% from the prior month on the back of higher gasoline and fuel oil costs. Shelter costs, which make up about a third of total CPI, accelerated, rising 0.3% last month after a 0.1% gain in October". The producer price index (PPI) and core PPI were unchanged from October's numbers. The flat PPI was attributed to a decline in the cost of services, which offset increases in food and gasoline prices. The ISM manufacturing index was below expectations at 48.1, in comparison to the previous month's reading of 48.3. The index gauges the activities of goods producers, and any reading below 50 represents a contraction in monthly manufacturing.

The Commerce Department reported that discretionary spending declined during the month, rising only 0.2%, but retail sales for October was upwardly revised by 0.1% to 0.4%. Core retail sales, which exclude automobiles,

gasoline, building materials and food services, gained 0.1% in comparison to 0.3% the previous month. Declines in retail sales were reported at clothing stores, book stores, hobby and musical instrument stores, and at restaurants and bars. Sales gains were found in vehicle purchases, online and mail orders, electronics, appliance and furniture stores.

Low mortgage rates, a low unemployment rate and wage gains were attributed to the rise in new home sales during the month. The sales pace of single-family homes were at an annualized 719,000, reflecting an increase of 1.3%. According to Bloomberg News, "Sales of new U.S. homes in November, capping the best three months for demand since 2007 and reflecting sustained momentum in residential real estate market that's helping to underpin the economy".

The last estimate for the third quarter gross domestic product (GDP) was unchanged at 2.1%. This was in comparison to 2.0% for the second quarter. The Bureau of Economic Analysis said "upward revisions to personal consumption expenditures and nonresidential fixed investment were offset by a downward revision to private inventory investment".

#### Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer's portfolio yielded 2.47% in December with a weighted average maturity of 882 days. The total assets under management by the treasurer was \$7.9 billion, in comparison to \$6.3 billion a year ago. The portfolio's diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 25% of the portfolio and mortgage-backed securities were 42%. U.S. treasuries represented 23% of assets, money market mutual funds were 7% and Certificates of Deposits were 2%. State bond issues, foreign bonds and municipals totaled 1% and comprised the balance of funds invested. In keeping with the state's statutory investment objectives, the portfolio strategy continues to be seeking safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and with regard to the likelihood of stable interest rates.

#### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

#### Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the treasurer and the master custodian bank on securities lending income.

#### **Total Funds Invested**

Funds available for investment, at market value, include the State Treasurer's investments at \$5,256,728,276 and State Agency balances in OK Invest at \$2,670,638,464 for a total of \$7,927,366,740.





In December 2019, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2020. The amount estimated was \$105,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

The following page presents market rates of return on the Securities portion of the General Account and the State's aggregated State Agency Accounts. These figures, which are dollar-weighted and time-weighted where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month.

To ensure the integrity of data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are held with the custodian bank Northern Trust Company.



#### Securities Lending Program

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$3,263. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

#### Northern Trust Custody Fees

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for the first two quarters was \$22,500.
