To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the January monthly investment performance report. I trust you will find it thorough and in keeping with my commitment to provide disclosure of the economic environment and portfolio results. As always, my staff and I are available to answer any questions.

Market Conditions

The treasury market reflected an inverted yield curve at the end of January, with the 10-year treasury yielding a 1.50% and the 3-month coming in at 1.54%. In addition, the 30-year hit an all-time low of 2.00%. Investors moved assets from the equity markets into treasuries amid fears of a global growth slowdown.

All three major indexes ended the month on a sour note with Dow coming in at 28,256, the S&P at 3,225 and the NASDAQ at a 9,150. According to the Wall Street Journal, "Anxiety swept through the stock, bond and commodities markets on uncertainty about the scope of the economic impact of the coronavirus in China".

The Federal Open Market Committee (FOMC) voted unanimously to keep the fed-funds rate in a range between 1.50% and 1.75%. Fed officials said they "will continue to monitor the implications of incoming information for the economic outlook, including global developments and muted inflation pressures".

Economic Developments

The jobs report was lackluster in December with non-farm payrolls coming in below expectations at 145,000. November and October non-farm payrolls were downwardly revised by 10,000 and 4,000. The monthly average for 2019 payrolls was 176,000 which reflected the smallest job creation since 2011. Average hourly earnings were disappointing rising to 2.9%. According to CNBC, "December marked the first time that wage gains were below 3% on a year-over-year basis since July 2018". Unemployment remained steady 3.5%.

The consumer price index (CPI) increased 0.2% in December compared to 0.3% in the previous month. Marketwatch reported that "The increase in the cost of living in the past 12 months rose a few ticks to 2.3%, matching the highest level since October 2018. Consumer inflation for all of 2019, also touched 2.3% and hit the highest mark since a 3% increase in 2011. Yet inflation is still quite low by historical standards". The producer price index (PPI) rose for the month by 0.1% and for 2019 it gained 1.3%, which was the smallest increase since 2015. In 2018 the PPI was 2.6%.

Retail sales in December gained 0.3% and November sales were upwardly revised by 0.1% to 0.3%. On an annualized basis, retail sales increased 5.8% and was reported to be slightly higher than the average for the past 30 years. According to Marketwatch, "Sales were solid at stores that sell electronics, clothing and sporting goods. Sales also edged up at bars and restaurants, pharmacies and grocers. Sales at gas stations rose 2.8% to lead the way in December, but the increase largely reflected higher prices at the pump. Home centers also registered a robust 1.4% in store receipts".

The seasonally-adjusted annual rate of total existing-home sales, which include completed transactions of single-

family, townhomes, condominiums and co-ops, was reported at 5.54 million for December in comparison to \$5 million twelve months before. The chief economist for the National Association of Realtors said “Home sellers are positioned well, but prospective buyers aren’t as fortunate. Low inventory remains a problem, with first-time buyers affected the most”. The median existing-home price for all housing types rose 7.8% to \$274,500 from December 2018.

The first estimate of the fourth quarter gross domestic product (GDP) was unchanged from the previous quarter coming in at 2.1%. In 2019 the economy expanded at 2.3% in comparison to 2.9% for 2018. The Wall Street Journal said “Two volatile categories, trade and inventories, had an outsize impact on fourth-quarter growth. Overall private-sector inventories subtracted 1.1 percentage point from the fourth quarter’s growth rate. A decline in retail inventories, notably at motor-vehicle dealers, came as the United Autoworkers union at nationwide strike at General Motors Co. ran through most of October. Meantime, next exports added 1.48 percentage point to the quarter’s 2.1 growth rate, the largest contribution since the second quarter of 2009. Exports rose at a 1.4% annual rate and imports dropped at an 8.7% pace”.

#### Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer’s portfolio yielded 2.42% in January with a weighted average maturity of 898 days. The total assets under management by the treasurer was \$8.27 billion, in comparison to \$6.74 billion a year ago. The portfolio’s diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 22% of the portfolio and mortgage-backed securities were 38%. U.S. treasuries represented 30% of assets, money market mutual funds were 7% and Certificates of Deposits were 2%. State bond issues, foreign bonds and municipals totaled 1% and comprised the balance of funds invested. In keeping with the state’s statutory investment objectives, the portfolio strategy continues to be seeking safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and with regard to the likelihood of stable interest rates.

#### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

#### Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the treasurer and the master custodian bank on securities lending income.

#### Total Funds Invested

Funds available for investment, at market value, include the State Treasurer’s investments at \$5,448,933,902 and State Agency balances in OK Invest at \$2,830,815,251 for a total of \$8,279,749,153.

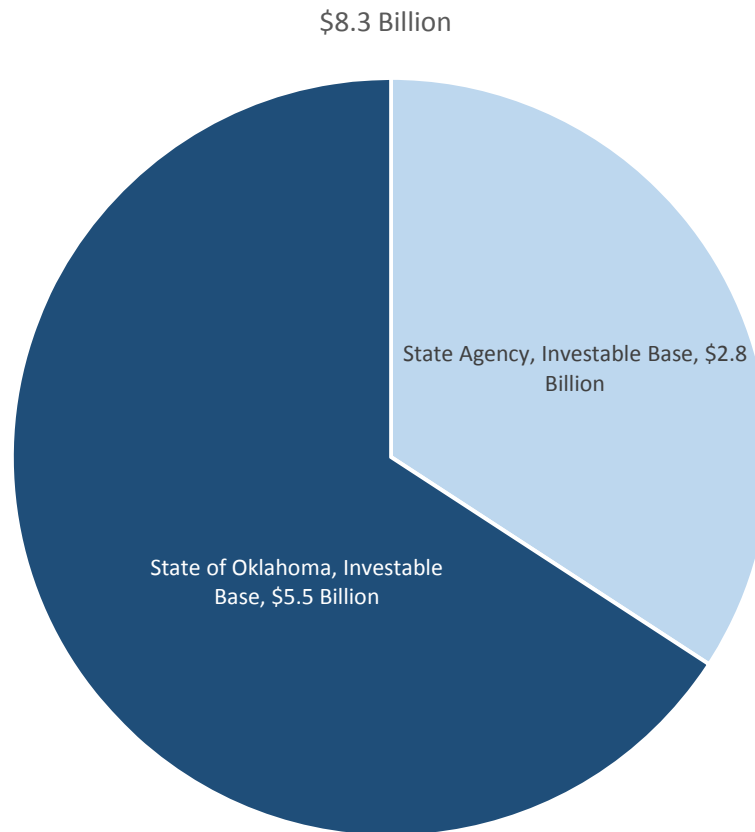

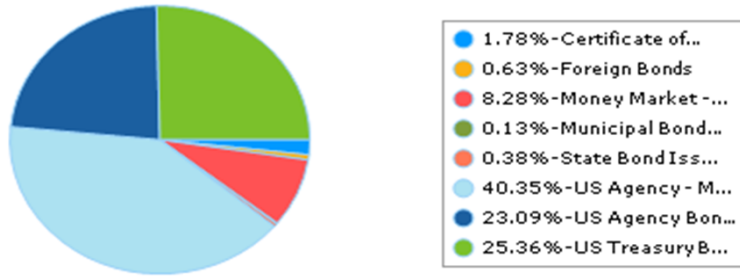

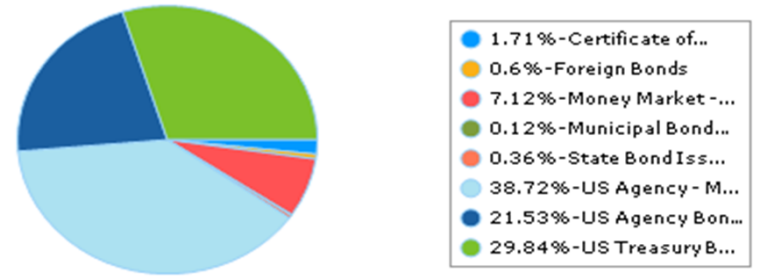

**Portfolio Holdings as of 1/31/2020**

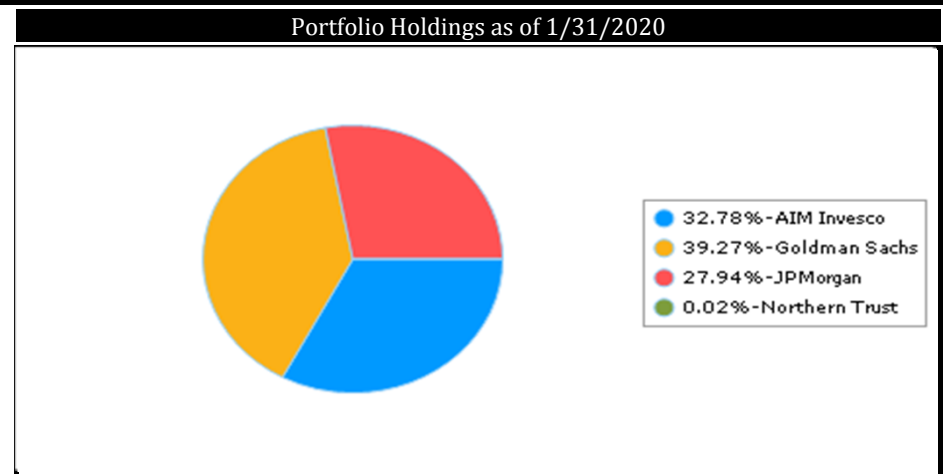
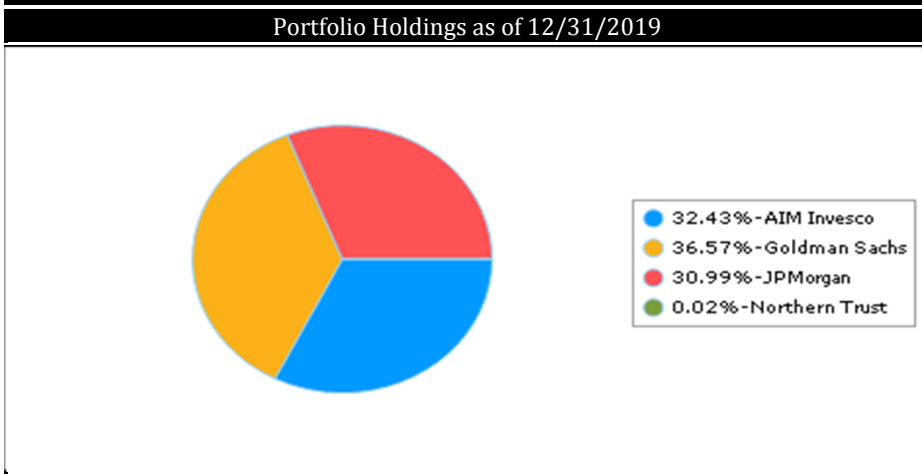

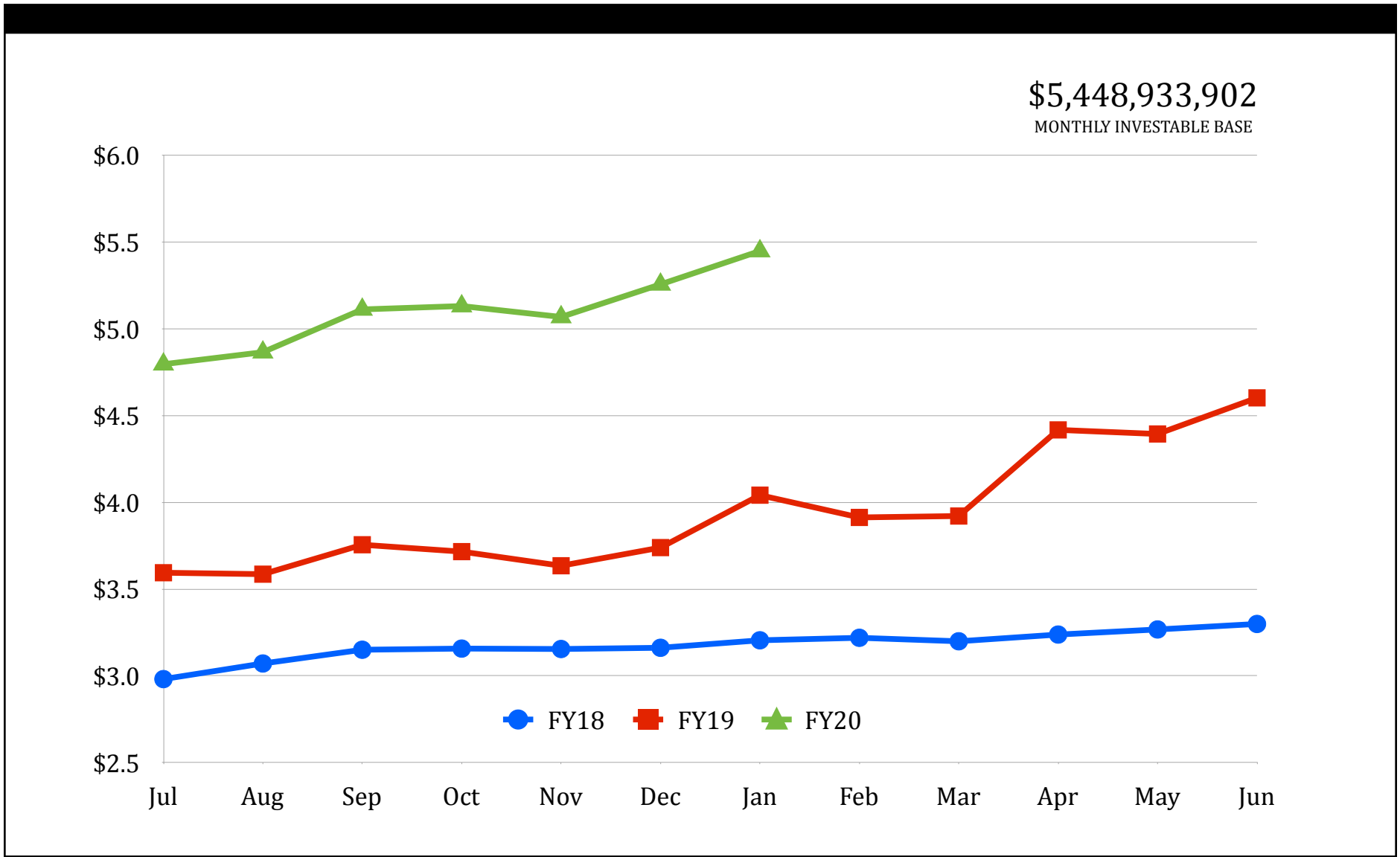

**Securities Lending Program**

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$3,884. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

**Northern Trust Custody Fees**

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for the first two quarters was \$22,500.
