To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the September monthly investment performance report. I trust you will find it thorough and in keeping with my commitment to provide disclosure of the economic environment and portfolio results. As always, my staff and I are available to answer any questions.

Market Conditions

Yields on the short-end of the treasury curve continued to be higher than longer maturities during the month. The yield for the 10-year treasury benchmark was 1.67% in comparison to 1.82% for the 3-month treasury and 1.76% for the 1-year. The 30-year earned 2.11%, which yielded 0.15% higher than the previous month.

According to The Wall Street Journal, the S&P 500 Index “rallied nearly 19% this year- its best performance in the first three quarters of a year since 1997”. The Dow Jones returned 15% and the Nasdaq was at 21% for the year. At the end of September the S&P was at 2,976 and the Dow and Nasdaq were at 26,916 and 7,999 respectively. Gains in technology and in the healthcare sectors were attributed to the rise in stocks.

The Federal Reserve lowered its benchmark rate by 0.25% to 1.75%, in addition to the 0.25% rate cut that was implemented in July. The vote of the Federal Open Market Committee (FOMC) was not unanimous with the Fed chiefs of Kansas City and Boston dissenting against the rate cut and the St. Louis Fed chief voting for a half-point cut. The FOMC said “although household spending has been rising at a strong pace, business fixed investment and exports have weakened” and “it will continue to monitor the implications of incoming information for the economic outlook and will act as appropriate to sustain the expansion”.

Economic Developments

The unemployment rate in August held static at 3.7%. The nonfarm payroll number came in below forecasts at 130,000 and downward revisions of 20,000 jobs were made to the prior two months. The disappointing payroll numbers were attributed to trade uncertainty and slower global growth. According to Bloomberg News, “the payroll figures showed weakness in several sectors. Manufacturing added an anemic 3,000 jobs, retailers cut positions for a seventh straight month and education and health serviced hired the fewest people since February. Industries with solid gains included construction at 14,000 and professional and business services at 37,000”.

The consumer price index (CPI) increased by 0.1%, which was 0.2% less than the previous month and was due to lower energy costs. Over the last year, CPI rose a diminutive 1.7%. Excluding volatile food and energy costs, core CPI advanced 0.3% in August which reflected no change from the previous two months. Core CPI gained 2.4% year-over-year, its largest twelve-month increase since July 2018. The Bureau of Labor Statistics reported the August producer price index (PPI) for final demand increased 0.1% on a seasonally adjusted basis and rose 1.8% on a year-over-year basis.

The Commerce Department said retail sales dropped from 0.8% in July to 0.4% in August. Purchases of automobiles by consumers helped boost over-all retail sales. Internet sales continued to be strong coming in at 1.6% for the month. On the other hand, department stores, clothing retailers, restaurants and gas stations all reflected sales declines of approximately 1%. Sales also declined at home-furnishing and grocery stores. According to CNBC, “The modest slowdown follows

signs that consumer confidence, while still strong, has slipped a bit as the U.S.-China trade war has intensified. U.S. businesses have cut back on their investment and expansion plans amid the trade war's uncertainty and exports have declined. That has left consumers as a key source of growth".

Existing home sales increased in August by 1.3% to a seasonally adjusted annual rate of 5.49 million, reflecting a year-over-year gain of 2.6%. Declining mortgage rates were attributed to improved existing home sales. On an annualized basis, median existing-home prices were up 4.7% for all housing types and the median price home price in August was \$278,000.

The gross domestic product (GDP) grew at an annual rate of 2%, with no change from the previous estimate. According to the Bureau of Economic Analysis, "the increase in real GDP in the second quarter reflected positive contributions from personal consumption expenditures (PCE), federal government spending, and state and local government spending that were partly offset by negative contributions from private inventory, exports, nonresidential fixed investment, and residential fixed investment".

#### Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer's portfolio yielded 2.56% in September with a weighted average maturity of 818 days. The total assets under management by the treasurer was \$7.8 billion, in comparison to \$6.0 billion a year ago. The portfolio's diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 27% of the portfolio and mortgage-backed securities were 42%. U.S. treasuries represented 22% of assets, money market mutual funds were 6% and Certificates of Deposits were 2%. State bond issues, foreign bonds and municipals totaled 1% and comprised the balance of funds invested. In keeping with the state's statutory investment objectives, the portfolio strategy continues to be seeking safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and with regard to the likelihood of stable interest rates.

#### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

#### Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the treasurer and the master custodian bank on securities lending income.

#### Total Funds Invested

Funds available for investment, at market value, include the State Treasurer's investments at \$5,112,277,882 and State Agency balances in OK Invest at \$2,759,104,275 for a total of \$7,871,382,157.

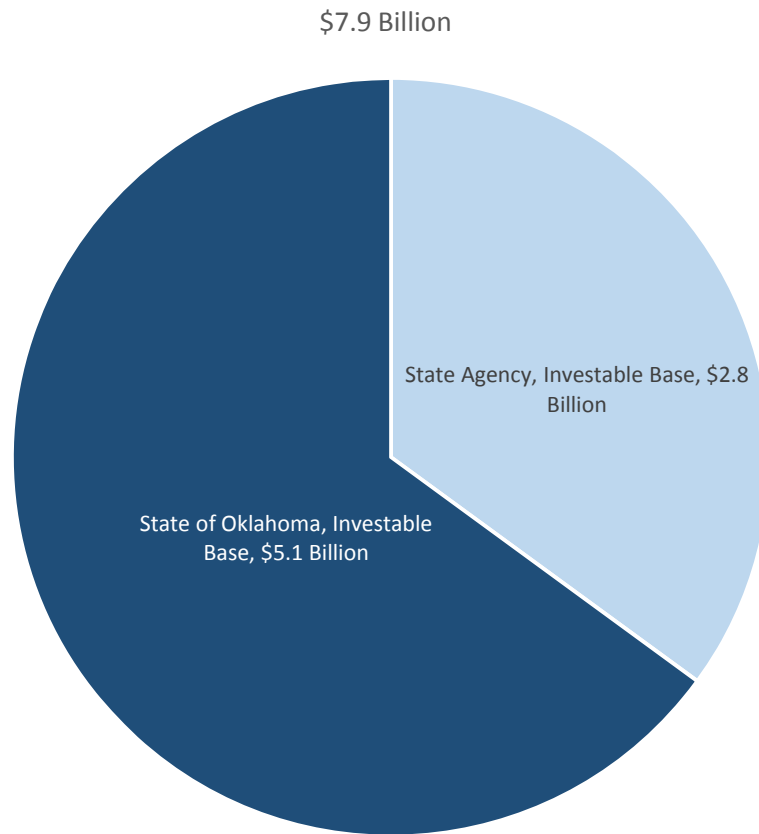

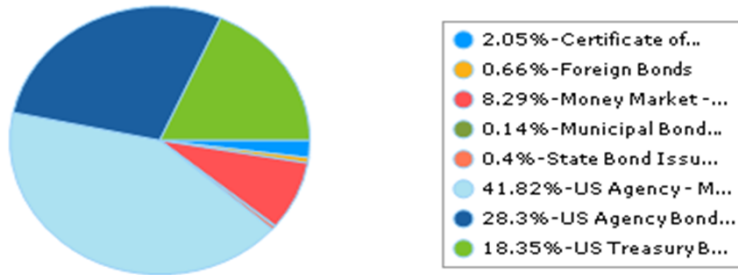

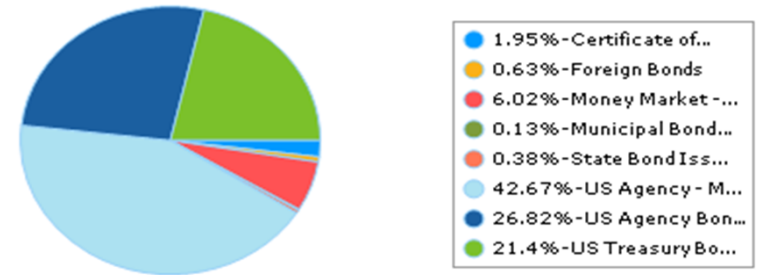

**Portfolio Holdings as of 9/30/2019**

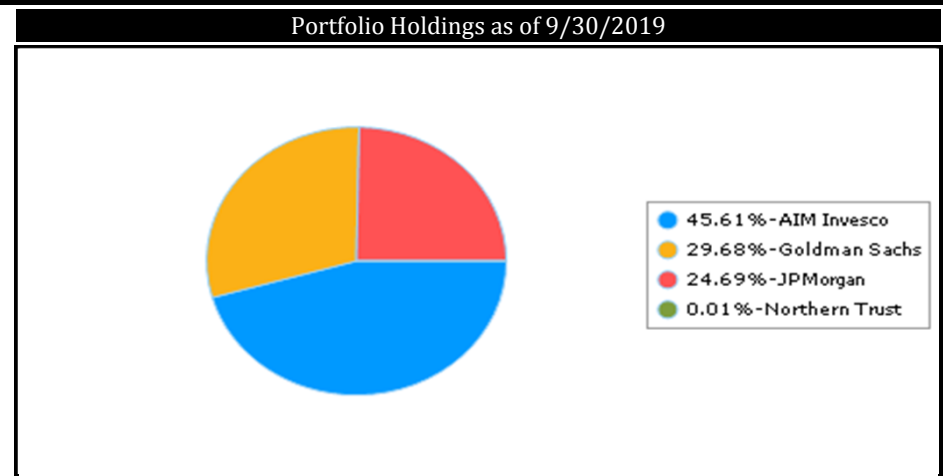
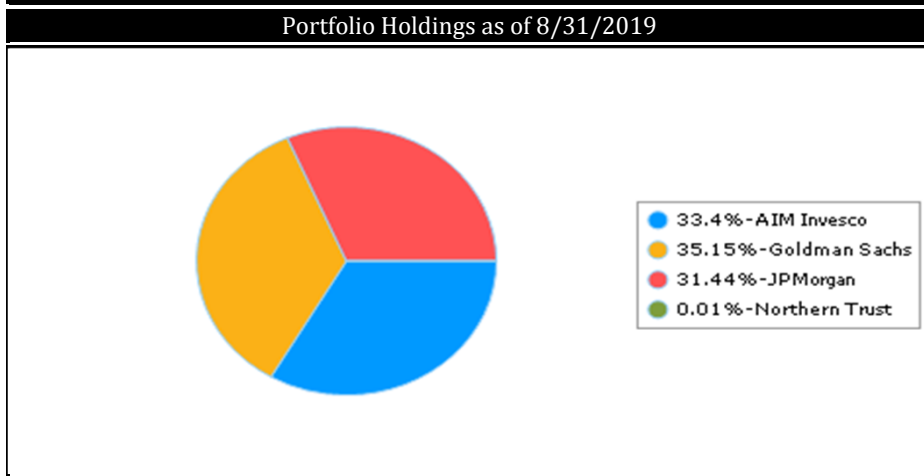

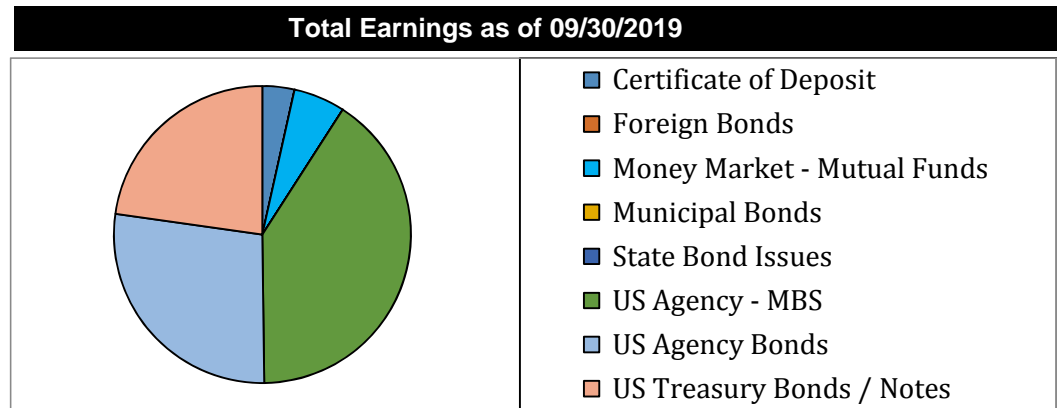

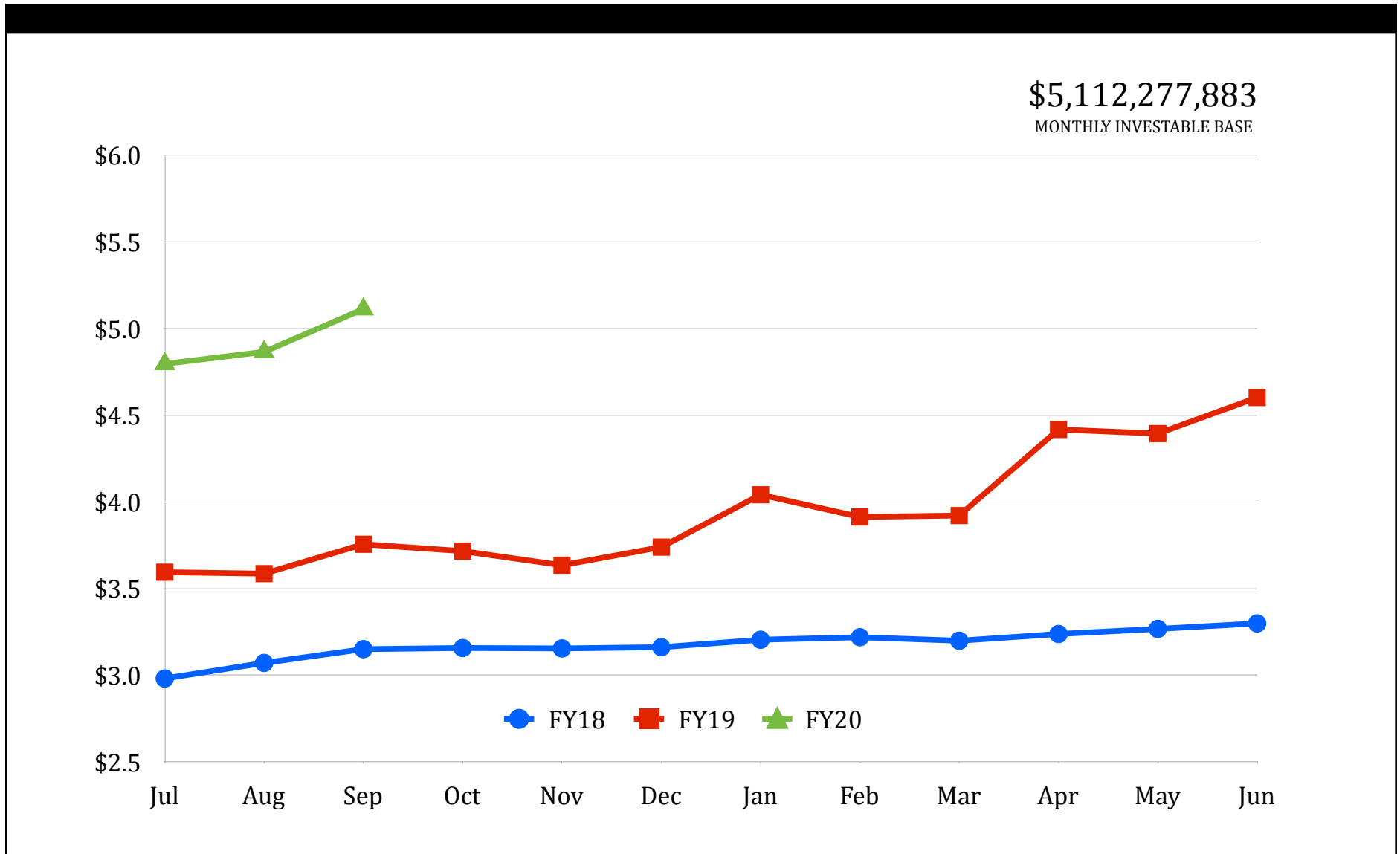

**Securities Lending Program**

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$2,242. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

**Northern Trust Custody Fees**

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for the first quarter was \$11,250.
