To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the July monthly investment performance report. I trust you will find it thorough and in keeping with my commitment to provide disclosure of the economic environment and portfolio results. As always, my staff and I are available to answer any questions.

Market Conditions

The treasury market continued to reflect declining yields during the month. The benchmark 10-year treasury was 0.53% and the 30-year was at 1.19%, reflecting yield decreases from the previous month of 0.13% and 0.22%. The 2-year came in at 0.11%, which was the lowest yield on record.

The month of July continued to reflect positively for the Dow Jones Industrial Average, the S&P 500 and the Nasdaq with gains of 2.38%, 5.51% and 6.82% respectively. On a year-to-date basis the Dow was in the red at (7.39%) in comparison to 1.25% for the S&P and 19.76% for the Nasdaq.

The Federal Open Market Committee (FOMC) left interest rates unchanged at their July meeting. Fed Chairman Jerome Powell said "We are committed to using our full range of tools to support our economy in this challenging environment". Since the middle of June, the Fed continued to purchase \$80 billion in Treasuries and \$40 billion in mortgage-backed debt per month. According to CNBC, the FOMC kept its interest rate targeted between 0%-0.25%, where it last was during the Great Recession. The Fed statement said the rate would stay there until officials are "confident that the economy has weathered recent events and is on track to achieve its maximum employment and price stability goals".

Economic Developments

The June unemployment rate dropped to 11.1% from 13.3% in May. Job gains came in higher than projected at 4.8 million, in comparison to the expected 2.9 million. Job growth in June reflected the continued reopening from the coronavirus pandemic and was the largest single-month gain in U.S. history. The leisure and hospitality sector accounted for the largest job increases of 2.1 million, approximately 40% of the gain. Temporary layoffs also declined by 4.8 million, after dropping 2.7 million in May. On the negative side, permanent job losses increased to 2.883 million reflecting an increase of 588,000 which was the highest level in more than 6 years.

The Bureau of Labor Statistics (BLS) reported the headline Consumer Price Index (CPI) increased 0.6% in June on a seasonally adjusted basis after falling 0.1% in May. Core CPI increased 0.2%, its first monthly increase since February, according to the BLS. Trading Economics reported that "producer prices for final demand in the U.S. fell 0.2% month-over-month in June of 2020, following a 0.4% increase in May. Year-on-year producer prices declined 0.8%, the same as in May. The core index which excludes food and energy fell 0.3% month-over-month, following a 0.1% drop in the previous month".

As more stores continued to open from the coronavirus lockdown, retail sales in June grew by a seasonally adjusted 7.5%. The Commerce Department reported that sales were \$524.3 billion, which was an increase of \$36.6 million from May and reflected nearly pre-pandemic sales levels. According to the Wall Street Journal,

“June’s increase in retail sales was driven by a pickup in sales of autos, furniture, clothing and electronics as consumers visited stores following reopenings”. There is concern that once the \$600 a week in federal unemployment benefits ends on July 31 that retailers could be negatively affected. The Wall Street Journal stated that “spending on gasoline increased 15.3% from the prior month. Receipts at bars and restaurants also jumped 20% from May”.

The National Association of Realtors reported that “Existing-home sales rebounded at a record pace in June, showing strong signs of a market turnaround after three straight months of sales declines cause by the ongoing pandemic. Total existing-home sales, completed transactions that include single-family homes, townhomes, condominiums and co-ops, jumped 20.7% from May to a seasonally-adjusted annual rate of 4.72 million in June. Sales overall, however, dipped year-over-year, down 11.3% from a year ago”.

The U.S. Commerce Department reported that the decline Gross Domestic Product (GDP) from April, reflected the worst quarterly drop since 1921. According to CNBC “Sharp contractions in personal consumption, exports, inventories, investment and spending by state and local governments converged to bring down GDP. Personal consumption, which historically has accounted for about two-thirds of all activity in the U.S., subtracted 25% from the Q2 total, with services accounting for nearly all that drop”.

Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer’s portfolio yielded 1.93% in July with a weighted average maturity of 690 days. The total assets under management by the treasurer was \$8.6 billion, in comparison to \$7.4 billion a year ago. The portfolio’s diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 25% of the portfolio and mortgage-backed securities were 32%. U.S. treasuries represented 31% of assets, money market mutual funds were 9% and Certificates of Deposits were 1%. State bond issues, foreign bonds and municipals totaled 2% and comprised the balance of funds invested. In keeping with the state’s statutory investment objectives, the portfolio strategy continues to be seeking safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and consideration of current low interest rates.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at market value, include the State Treasurer’s investments at \$5,939,506,462 and State Agency balances in OK Invest at \$2,675,022,867 for a total of \$8,614,529,329.

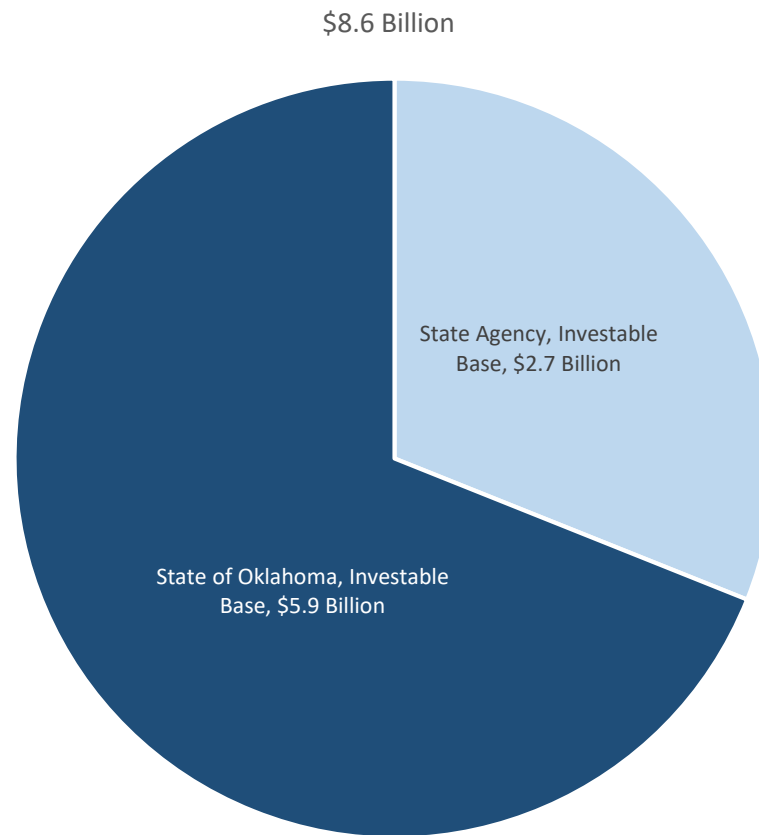

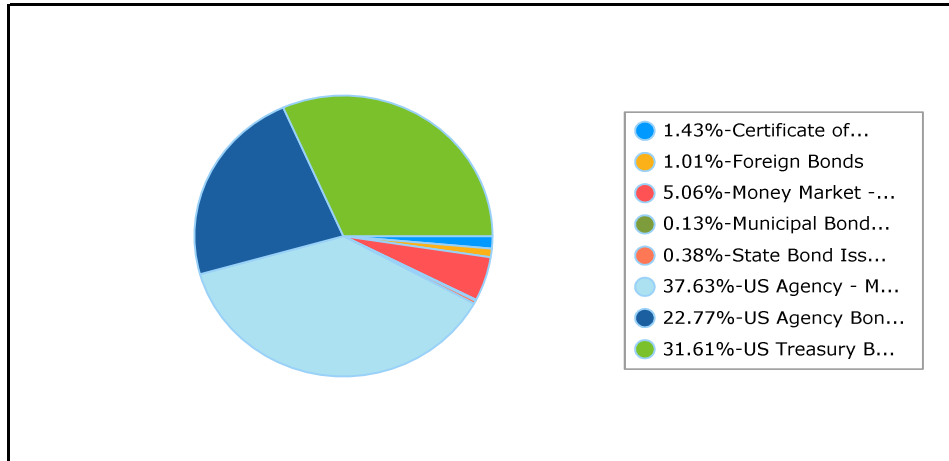

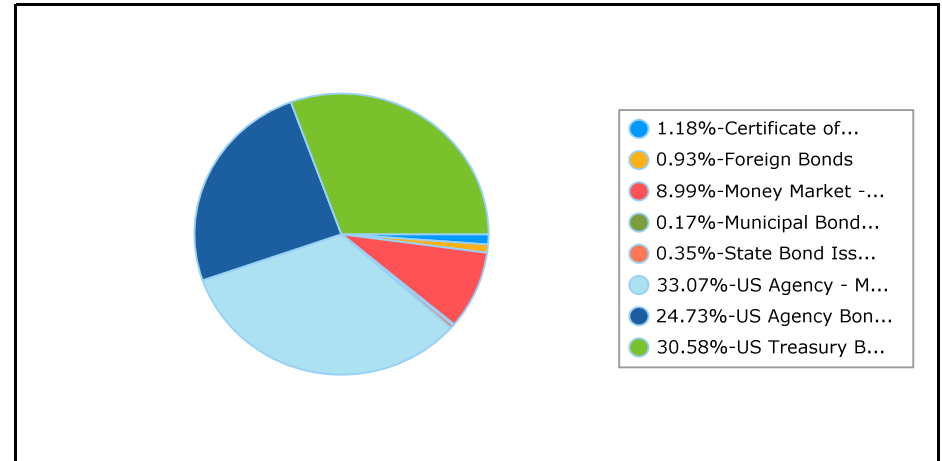

Portfolio Holdings as of 7/31/2020

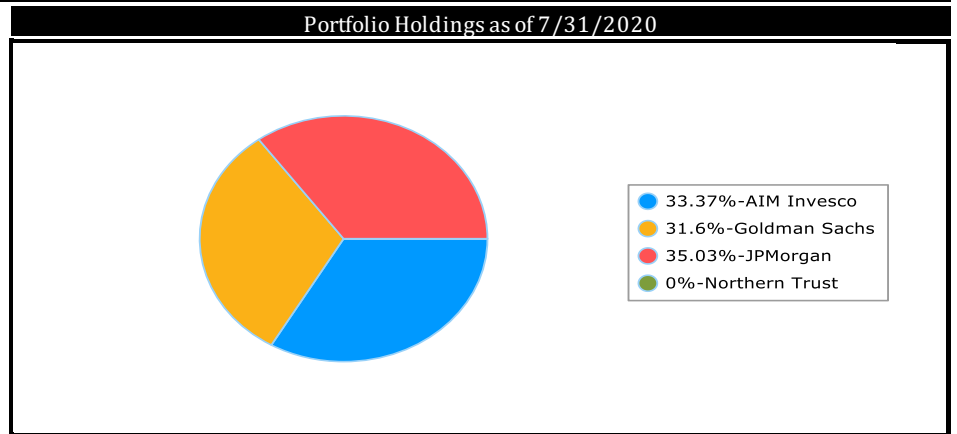
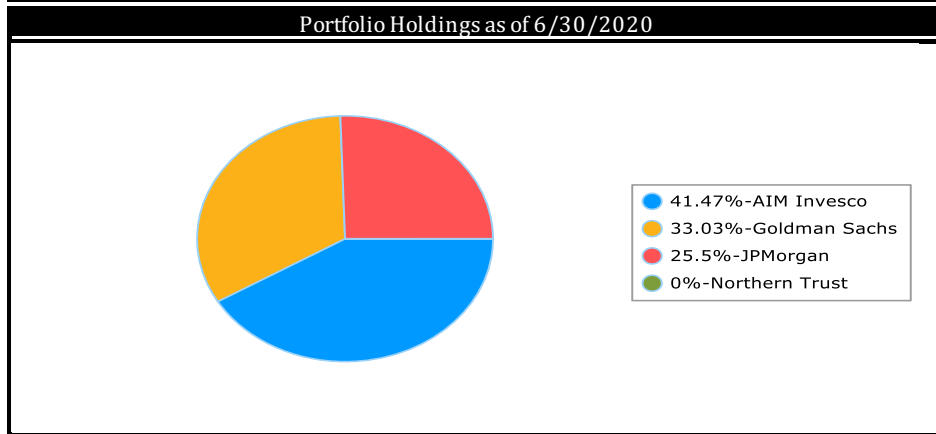

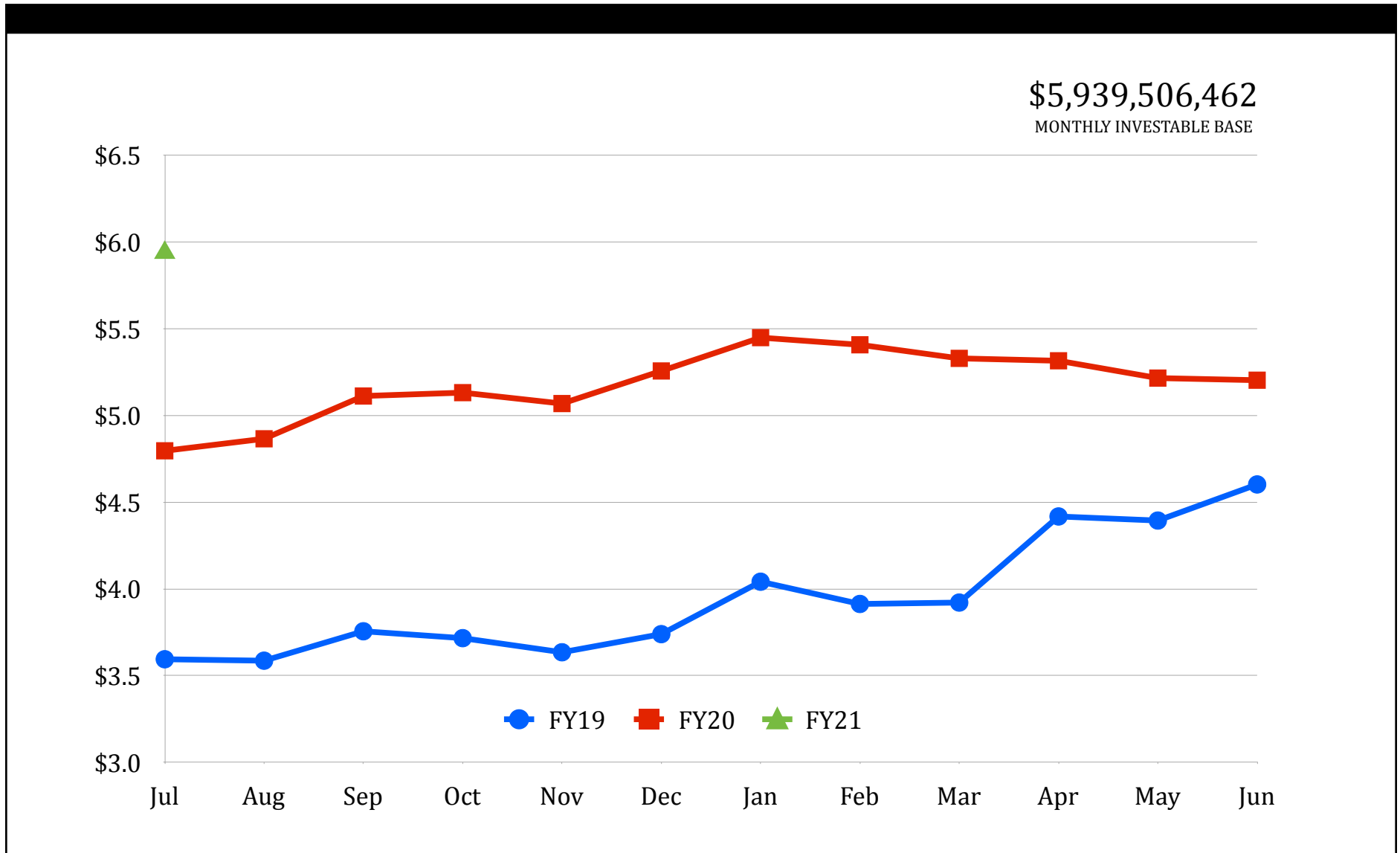
Represents dollar-weighted and time-weighted rates of return

Securities Lending Program

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$4,672. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

Northern Trust Custody Fees

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for first quarter FY2020 was \$0.
