To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the October monthly investment performance report. I trust you will find it thorough, upholding my commitment to provide disclosure of the economic environment and portfolio results. As always, my staff and I are available to answer any questions.

Market Conditions

The treasury curve reflected higher yields from the 2-year to 30-year treasuries, in comparison to the end of September. The 10-year treasury benchmark had the largest gain in one-month yield since September 2018, coming in at 0.875%. The 2-year was at 0.155% and the 30-year ended October at 1.66%.

The equity markets struggled during October with the Dow Jones having its worst month since March down -4.6% for the month and down -7.1% year-to-date. The S&P 500 index was at -2.7% for the month and 1.2% for the year and the Nasdaq at -2.3% and 22.6%, respectively. The Wall Street Journal (WSJ) stated that "Investors have been spooked by a record high in coronavirus infections in the U.S., fresh lockdowns in Europe that threaten economic growth and a mixed bag of earnings reports from big technology companies." In addition, the WSJ said "After a remarkable run since late March, stocks peaked in early September- only to tumble on worries the market had run too far, too fast."

The Federal Open Market Committee (FOMC) continued with the fed funds target range of zero to 0.25%. According to the minutes released from the Sep 15-16 FOMC meeting, "The path of the economy will depend significantly on the course of the virus. The ongoing public health crisis will continue to weigh on economic activity, employment, and inflation in the near term, and poses considerable risks to the economic outlook over the medium term."

Economic Developments

The Bureau of Labor Statistics (BLS) reported the unemployment rate in September declined to 7.9% from 8.4%, as 661,000 jobs were created during the month. There were job gains of 318,000 in leisure and hospitality, specifically increasing in food and drinking service places. Retail trade jobs increased by 142,000 and health care and social assistance by 108,000. The government sector experienced a loss of 216,000 positions, according to the BLS report.

"The Consumer Price Index increased 1.4% over the 12 months ending in September 2020. Food prices increased 3.9% over this period, while energy prices declined 7.7%. Prices for all items other than food and energy rose 1.7% over the past year," according to the BLS. The producer price index (PPI) gained 0.1% and came in at 0.4% in September. As reported by Trading Economics, "The core index which excludes food and energy went up 0.4% month-over-month, the same as in August."

Retail sales came in higher than expected in September at 1.9% month-over-month, beating the previous month by 1.3% and reflecting a large rise for the last three months. Retail sales gained 5.4% on a year-over-year basis. The industries with the largest sales increases included clothing stores at 11%, department stores at 9.7%, sporting

goods at 5.7% and auto dealers with a 4% gain. This was in comparison to a sales decline of -1.6% in electronics and appliance stores.

The National Association of Realtors (NARS) reported that existing-homes sales increased 9.4% from the previous month, reaching a seasonally adjusted annual rate of 6.54 million homes sold in September. On a year-over-year basis existing homes advanced 21%. Regarding inventory levels, NARS reported “September’s inventory figures fell by 1.3% from last month standing at 1.47 million homes for sale. Compared with September of 2019, inventory levels dropped 19.2%. This would mark 16 straight months of year-over-year declines. It will take 2.7 months to move the current level of inventory at the current sales pace.”

The gross domestic product (GDP), which is a measure of total goods and services produced, came in at an annualized pace of 33.1% for the third quarter. This was in comparison to a decrease of 31.4% in the previous quarter. According to CNBC, “Increased consumption along with solid gains in business and residential investment as well as exports fueled the third-quarter rebound. Decreases in government spending following the expiration of the CARES Act rescue funding subtracted from GDP.”

Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer’s portfolio yielded 1.71% in October with a weighted average maturity of 711 days. The total assets under management by the treasurer was \$8.7 billion, in comparison to \$7.9 billion a year ago. The portfolio’s diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 32% of the portfolio and mortgage-backed securities were 29%. U.S. treasuries represented 31% of assets, money market mutual funds were 5% and Certificates of Deposits were 1%. State bond issues, foreign bonds and municipals totaled 2% and comprised the balance of funds invested. In keeping with the state’s statutory investment objectives, the portfolio strategy continues to be seeking safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and consideration of continued low interest rates.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at market value, include the State Treasurer’s investments at \$6,145,229,036 and State Agency balances in OK Invest at \$2,555,165,254 for a total of \$8,700,394,290.

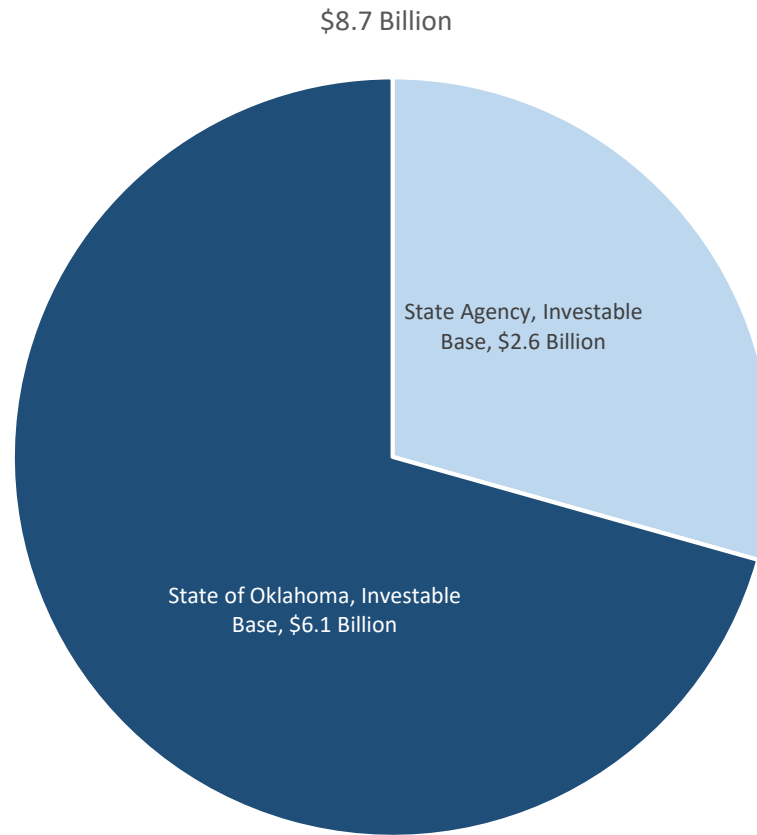

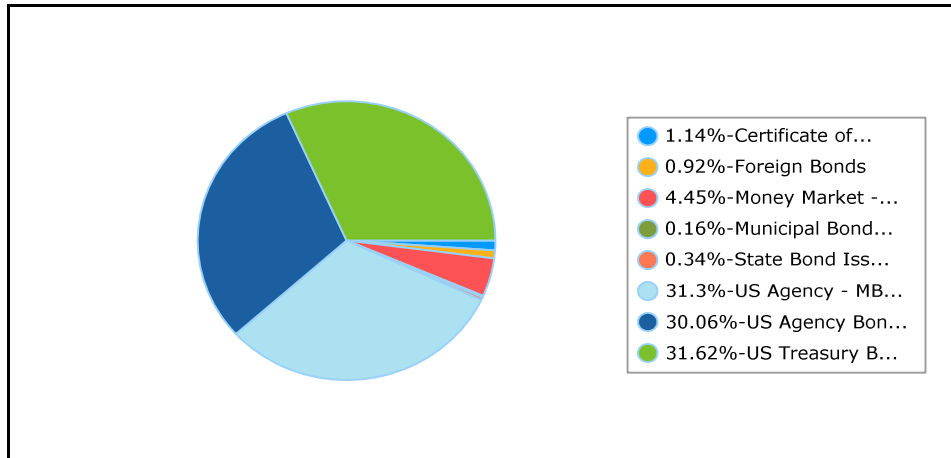

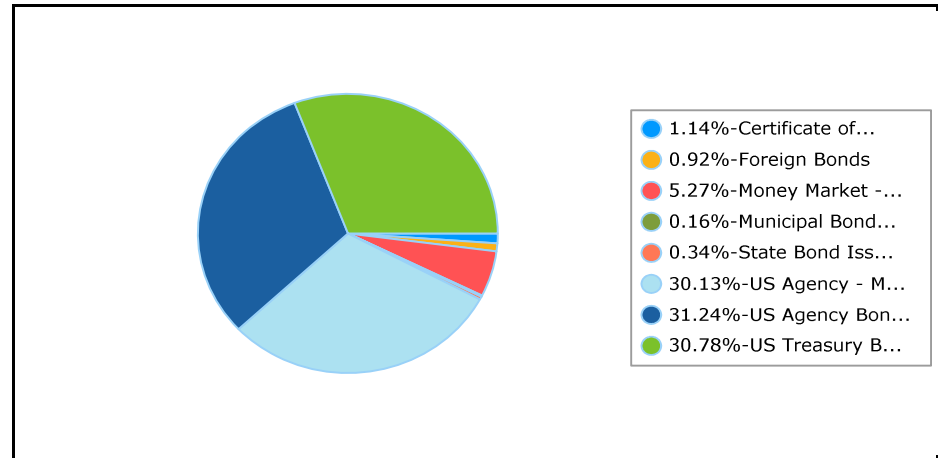

Portfolio Holdings as of 10/31/2020



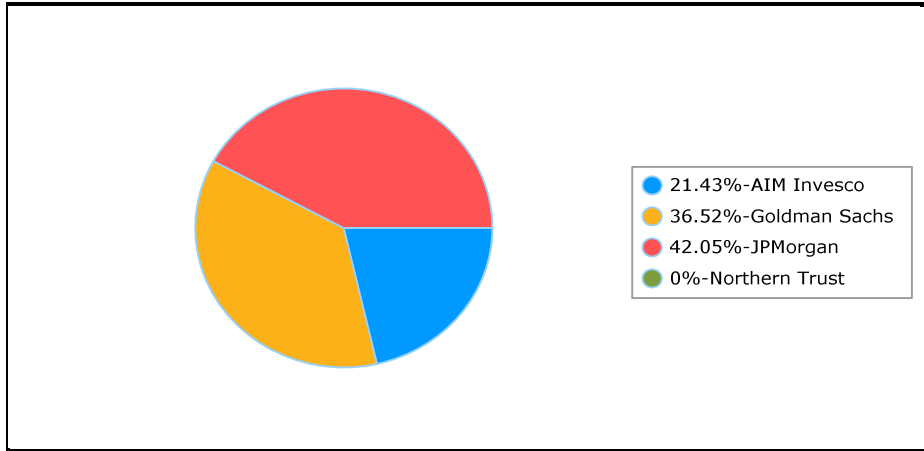

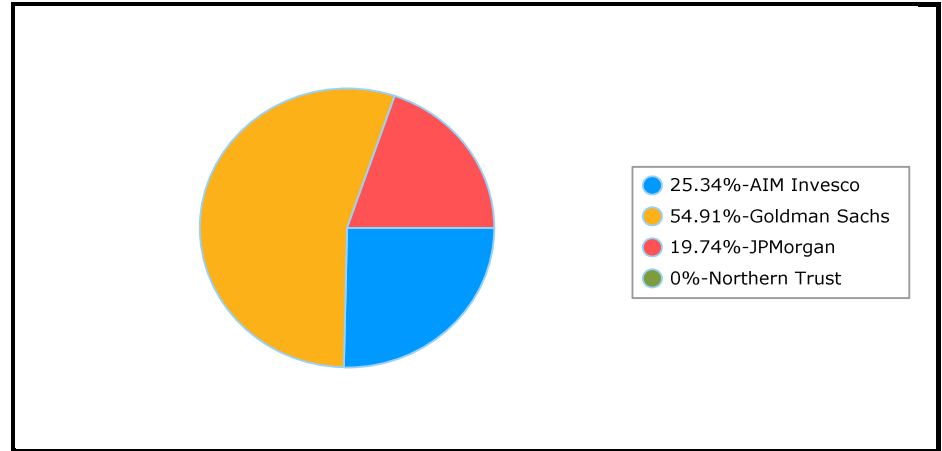

Portfolio Holdings as of 9/30/2020



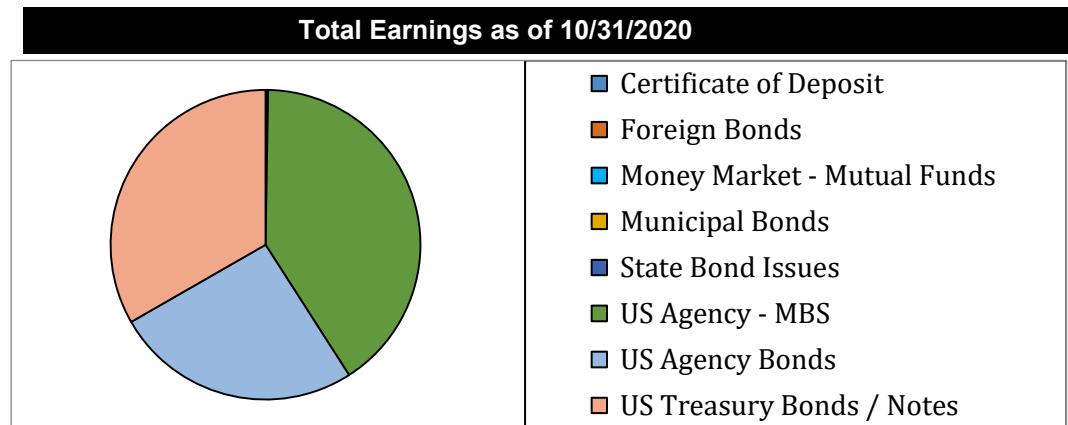
Portfolio Holdings as of 10/31/2020

These figures, which are dollar-weighted and time-weighted where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month.

To ensure the integrity of data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are held with the custodian bank Northern Trust Company.

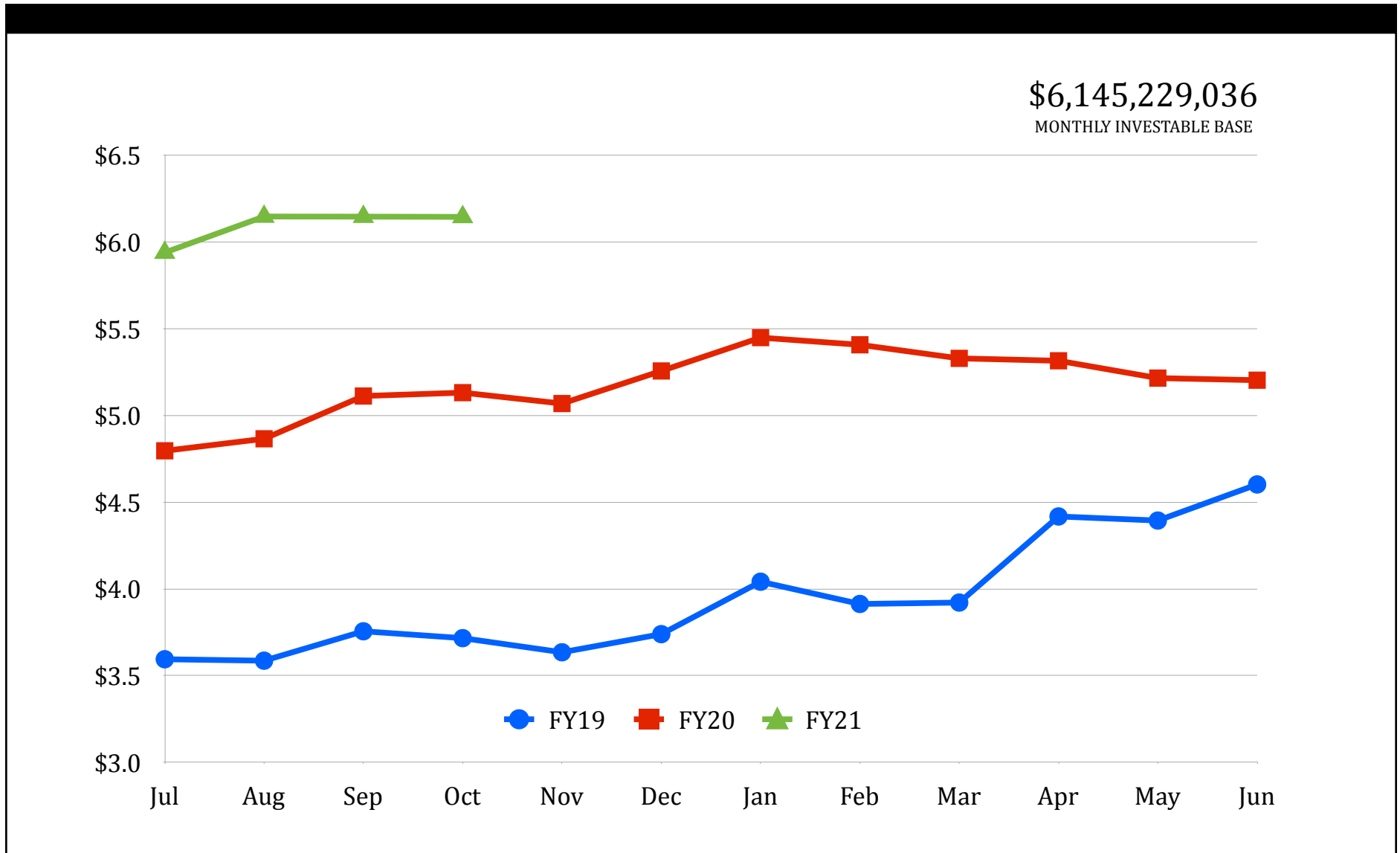

Note: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported are shown at the contracted rate.

Securities Lending Program

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$1,195. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

Northern Trust Custody Fees

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for first quarter FY2020 was \$11,250.
