

## ORGANIZATIONAL STRUCTURE & LEADERSHIP

### BOARD OF DIRECTORS

A seven-member Board of Directors invests the Tobacco Settlement Endowment Trust's earnings in programs to improve the health and well-being of all Oklahomans. By design, the board is bipartisan and representative of each of the state's five congressional districts. As required by the Oklahoma Constitution, no more than four appointees may be from any one political party. At least one member must be appointed from each congressional district, and no more than two members may be appointed from any single congressional district. All appointees must have demonstrated expertise in public or private health care or programs related to or for the benefit of children or senior adults. Members serve seven-year terms.

### BOARD OF INVESTORS

A five-member Board of Investors oversees the investment of all funds directed to the Tobacco Settlement Endowment Trust. As required by the Oklahoma Constitution, the State Treasurer chairs the Board of Investors and the remaining four members are appointed by specific elected officials. No more than two appointees may be appointed from any single congressional district. All appointed members must have demonstrated expertise in public or private investment funds management. Members serve four-year terms. Per board policy, no funds are invested in tobacco stocks.
