## **Oklahoma State Veterans Cemetery Eligibility Information**

Veterans who desire burial in an Oklahoma Veterans Cemetery may request that eligibility be determined for themselves and their eligible dependents prior to burial need. While this will not reserve a specific grave site, it will lessen the burden on surviving family members at the time of the veteran's / dependent's death and allow immediate scheduling of burial by cemetery staff. In situations where no pre-certification has been made, burial will not be scheduled until eligibility has been established.

## **Service Verification**

Veterans requesting a pre-determination of eligibility for themselves, and their dependents should provide a copy of their DD214 and/or Military Discharge showing the character of discharge and dates of service.

# **Marriage Documentation**

Veterans who desire their spouse to be buried with them must provide a copy of their Marriage Certificate.

# **Birth Documentation**

In some cases, the Veteran's children may be eligible for burial with the veteran. Please contact a Cemetery Representative for more information about a dependent child's eligibility.

# Residency

No residency requirement needed for an Oklahoma Veterans' Cemetery.

To obtain more information about specific Oklahoma Veterans' Cemeteries, please contact a Cemetery Representative.

Forward all documentation along with a completed Pre-Certification Application to the Oklahoma State Veterans' Cemetery where burial is desired. Upon verification of burial eligibility, the Veteran will be provided a letter stating that his or her eligibility has been confirmed. That letter should be kept with important papers or provided to the Veterans' funeral director if a funeral plan has been established. The Veterans' Cemetery Program will maintain a file copy of the letter and other pertinent documentation so that interment can be scheduled immediately upon notification of death.
