Secretary Nash gave an update on work he and Senator Stanley are doing to fill vacant Commission seats. Cites lack of response from veteran groups DAV, VFW, and PVA. Secretary Nash anticipates response from DAV, however he has not heard from the other organizations. Commissioner

Martin states he has reached out to PVA and VFW, and has not received any response.

Secretary Nash gave update on trip to Choctaw and Mid-Del City with Senator Stanley. He will be traveling to Washington D.C. to discuss federal funding for public schools and military programs such as JROTC.

Director Slavonic states this past month he has traveled to Sallisaw and Clinton with Commissioner Ellington.

Director Slavonic states that Commissioner Martin will represent the Commission on the Veterans Suicide Task Force and ODVA will be represented by Alfonso Garza.

Director Slavonic states that Rob Teel has been appointed and will represent ODVA as the AI and GenAI expert.

Director Slavonic advised that he is working with Nicole Miller to research appropriate candidates for selection of ODVA Legislative Liaison.

Director Slavonic states the selection of a CPA firm to conduct agreed upon procedures to validate the financials of the ODVA will be discussed at the next Commission meeting.

Director Salvonic states SB415 ramifications to Oklahoma Veterans that are 100% disabled will be discussed at the next Commission meeting. Senator Stanley has scheduled a meeting with Secretary Nash and representatives from the OTC and ODVA for October 30, 2023 to discuss SB415.
