The Oklahoma Veterans Commission is requested to authorize the ODVA Executive Director to execute the Benham Design, LLC, Change Order described below. This Change Order was submitted on December 21, 2023.

Amendment #2 – CAP# 000358AE – Benham Design, LLC - \$621,012.00 + CAP Fee \$43,470.84 – 175 Bed Replacement Sallisaw Veteran Home – Due to funding constraints, the A/E contract was separated into two (2) phases as they completed the necessary corrections related to the design deficiencies from the previous A/E. The 2nd half of the contract is due which is \$395,609.00; plus an additional \$225,403.00 for an extension of time and services to complete this project past the original estimated 20 months. A copy of the documents included with this Change Order has been provided in the Commissioner's packets.

Change #001- CAP# 000526 - \$00.00 + CAP Fee \$00.00— Saker Mechanical, Inc. — Claremore Veteran Home — COVID HVAC Upgrade (FAI:40-071 Grant Project) — This is a zero-cost change order. Additional days were requested by the contractor to add the selected alternate work to the original project substantial completion date. A copy of the documents included with this Change Order has been provided in the Commissioner's packets.

C. Request for Ratification of Emergency Declaration – Boiler Repair – Clinton State Veterans Home.

The Oklahoma Veterans Commission is requested to ratify the February 15, 2024, Declaration of the existence of an Emergency at the Clinton State Veterans Home regarding the failure of the domestic hot water boiler of the SW Towers and SA Wing Heat Exchanger. The Center was running with one boiler that had already required repairs. It was determined that it was more cost effective to replace the older boiler that had failed than to try to repair it. This is considered to be a life safety issue for residents and staff of the Clinton State Veterans Home.

ODVA staff has requested a quote and repair estimate from Atlantic Fabrications, Inc. The estimated cost for the boiler replacement is \$85,698.00.

In compliance with Title Okl.St.Ann. § 130, the Office of Management and Enterprise Services was notified by letter dated February 16, 2024, of the factual details which described the Emergency situation the Clinton State Veterans Home had suffered as a result of the equipment failure described above and the proposed boiler replacement costs.
