2. COMMISSIONER BRETT MARTIN:

1. OKLAHOMA SECRETARY OF VETERANS AFFAIRS AND MILITARY: JOHNATHAN NASH, DISCUSSION WITH POSSIBLE ACTION:

Secretary Nash did not attend in person and no report was presented.

2. ODVA: ADMIRAL GREG SLAVONIC, EXECUTIVE DIRECTOR, DISCUSSION WITH POSSIBLE ACTION:

Director Slavonic states he traveled to the Lawton Veterans Home with Secretary Nash and the visit went well. Director Slavonic invited the Commissioners and recommended they visit the Veterans Homes across the state.

Director Slavonic discussed SB 1707 and stated that ODVA is incurring costs monthly maintaining the Talihina property.

Director Slavonic discussed SB 1215 and states that if the bill is signed by the Governor ODVA will need to get the word out and provide information to lawmakers so they can address veterans' questions. Directory Slavonic also discussed the media effort i.e., radio, billboard, newspaper advertising and multi-platform social media efforts planned to publicize the signing of the bill,.

Director Slavonic discussed SB 1384 and states it has strong support in Senate and House.

Director Slavonic discussed SB 3060 and states the bill did not make it out of Committee and is dead.

3. ODVA: NISHA YOUNG, CONSTRUCTION PROGRAMS ADMINISTRATOR, UPDATES, DISCUSSION AND POSSIBLE ACTION:

Ms. Young gave updates on Ardmore New Veterans Home Project, Sallisaw Veterans Home construction, Talihina Veterans Home security and maintenance, and Union Soldiers Cemetery. The construction documents and design effort for the new Ardmore facility is over 90% complete. Sallisaw construction is approximately 73% complete and on schedule. Scott Hammerstedt, Senior Researcher, with the Oklahoma Archeological Survey of the University of Oklahoma performed a survey of the Union Soldiers Cemetery to locate any unmarked graves

before construction begins. A digital copy of this presentation is available as an attachment to these minutes.

i. Pursuant to 61 O.S. Section 121 (F), the following Change Orders over the authority of the Executive Director since the last meeting of the Oklahoma Veterans Commission meeting were considered: Amendment #2 CAP# 000358AE – Benham Design, LLC - \$621,012.00 + CAP Fee \$43,470.84 175 Bed Replacement Sallisaw Veteran Home - Due to funding constraints, the A/E contract was separated into two (2) phases as they completed the necessary corrections related to the design deficiencies from the previous A/E. The 2nd half of the contract is due which is \$395,609.00; plus an additional \$225,403.00 for an extension of time and services to complete this project past the original estimated 20 months.
