2. Complete the enclosed affidavit.
3. Send in the affidavit and a self-addressed stamped envelope and wait for an acknowledgment from this office.
4. After you receive our acknowledgment, you may purchase the parent-taught online driver education with the provider you selected.
5. Complete the entire parent-taught driver education program.

Once the training is completed, the provider will supply the completion certificate as verification for driver education.
