## Introduction

Dear Service Oklahoma Partner:

Service Oklahoma is pleased to provide you with the May 2026 update for the Service Oklahoma Traffic Violation Code Book (VCB). The VCB contains information compiled by Service Oklahoma pertaining to Oklahoma traffic violation offenses.

The purpose of the VCB is to promote uniformity in the citation and coding of Oklahoma traffic violations for inclusion on a Driver Record. The information provided is intended to address Oklahoma traffic offenses and is furnished as a reference tool to assist court clerks, court reporting vendors, and law enforcement personnel in the accurate and consistent reporting of Oklahoma citations and related court actions.

The VCB is actively maintained by Service Oklahoma. It is subject to revision to reflect statutory changes, policy updates, system enhancements, and clarification needs. Updates will be made as needed and, at a minimum, on an annual basis to ensure the information remains current and is consistent with applicable requirements.

## Collision Reporting

As you know, effective January 16, 2026, Service Oklahoma no longer accepts or processes paper collision reports. This change was necessary, in advance of our new operating system "BOOST" coming online, because the new system does not support manual entry of collision data. Please coordinate with the Oklahoma Highway Safety Office (OHSO) regarding access and use of the Oklahoma Collision Electronic Records System (OCERS) for electronic submission of reports. ## Masking Convictions

Masking convictions refers to any action by a court or state to hide a violation or prevent a conviction from appearing on a driver's record. Accurate and timely reporting of CDL convictions to Service Oklahoma is essential for compliance and roadway safety. Federal law ([49 CFR 384.226](#)) prohibits any action that alters, conceals, or reduces CDL-related violations. A driver's record must fully reflect their conviction history to maintain the integrity of CDL enforcement.

Masking Examples: Deferred judgments or diversion programs that erase violations, failure to transmit out-of-state convictions, reducing serious violations to lesser offenses, and plea agreements that dismiss charges after courses or conditions are completed are considered "masking" and are not permitted.

## Code Changes and Updates

- **New:** Codes made effective after the publication of the previous VCB in 2022.
- **Retired:** Codes no longer statutorily supported and cited as of the retired date.
- **Updated or Corrected:** Codes that have been corrected or changed, i.e. statutory changes.

- MVR (Motor Vehicle Record):** An asterisk [\*] indicates the violation will appear on a printed MVR.
- PTS (Points Assessed for Violation):** Indicates the number of points, if any, assessed for the violation. Accumulated points will appear on the printed MVR. Ten or more points result in automatic suspension of the person's driving privilege.
- VC (Violation Code):** Provides the three-character violation code assigned by Service Oklahoma.
- ACD (AAMVA Code Dictionary):** **For use by Service Oklahoma Only.** This indicates the three-character code used nationwide in messages sent over the AAMVA Net to identify (a) the type of conviction, or (b) the reason for a withdrawal.
- S (Court-ordered Suspension):** Shows the applicable suspension abbreviation:
  - P Violation qualifies for a Failure to Pay (FTP) suspension.
  - AP Violation qualifies for both Failure to Appear (FTA) and Failure to Pay (FTP) suspensions.
- Violation Description:** Provides a brief narrative description of the violation.
- Violation Citation:** Indicates the statutory citation for the violation.
