Charitable Organization License Plate Application Instructions

Qualifications: Applicant must be a 501(c)(3) charitable organization, and be listed as such by the Oklahoma Secretary of State.

Limitations: No more than 8 plates may be issued to a given charitable organization at any time.

Payments: Payment must accompany the application. Make checks payable to Service Oklahoma. The charitable organization number (if any) must appear on the check. A \$50.00 penalty will be assessed for any dishonored check.

Replacement Plates and/or Decals: If any plates and/or decals have been lost or stolen you must make a police report of the incident. You must include a copy of the police report with your application. List the missing plates and the decal numbers that are on missing plates on the front of this application or on an additional sheet of paper. Damaged plates must be returned with your application. If you have lost/stolen decals only, please contact Service Oklahoma.

Renewals: If you have damaged plates or plates you are not renewing, the plates must be returned with your application. Your renewal application cannot be processed until you have accounted for all plates in your possession.

Penalty Fees: The license is non-assignable and expires December 31st of each year. If not renewed by that date, the

applicant will become subject to a penalty of \$0.25 per plate per day for a period of 31 days. After January

31st, the penalty will be \$10.00 per plate.

Mail Fees: \$6.15 per plate, \$1.66 per 5 decals (1-5 decals = \$1.66; 6-10 decals = \$3.32, etc.)

AGREEMENT

It is hereby agreed by and between the applicant and Service Oklahoma that:

- Charitable organization plates will be revoked if the applicant has violated or violates any provisions of the laws of this state.
- 2. The applicant will not use charitable organization plates issued in connection with this license on any vehicle that is used as a service/loaner car, is used for hire, or is for private use.
- 3. Any person with consent of the applicant may operate a motor vehicle with a charitable organization plate affixed while contemplating purchase.

Submission of this application implies agreement to comply with all terms and conditions listed.
