John currently serves as the State Opioid Treatment Authority (SOTA) for the State of Oregon, and is the manager of the Healthcare Professionals Service Program (HPSP). He received his doctorate in Counselor Education/Mental Health Counseling from Florida Atlantic University, in Boca Raton, FL. He is a Licensed Mental Health Counselor, has several years of direct clinical experience in treating patients with alcohol and drug disorders, and was the former Director of Assessment and Education and Associate Director of Research at a large substance abuse treatment facility for several years, where he played a key role in developing assessment and evaluation procedures, interpreting psychometric instruments and integrating their findings into the treatment planning process, as well as supervising the internship program. He has also worked as a consultant in the areas of education, assessment and research in the substance abuse field. John has coordinated research studies on addiction, co-morbid disorders, family systems, spirituality and mood disorders, has authored and co-authored numerous peer-reviewed articles and book chapters, and has been a frequent presenter at national conferences and symposiums.
