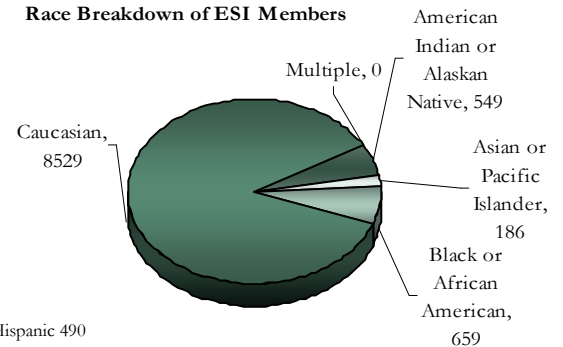

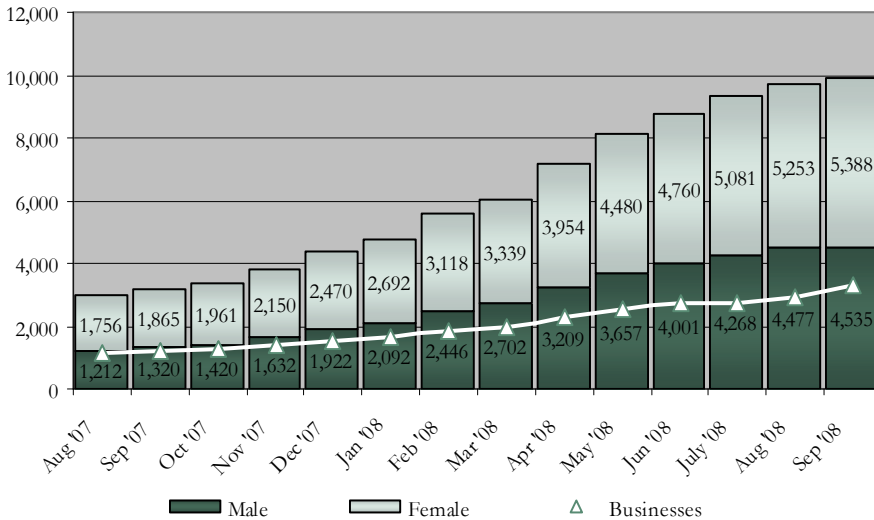

Race Breakdown of ESI Members

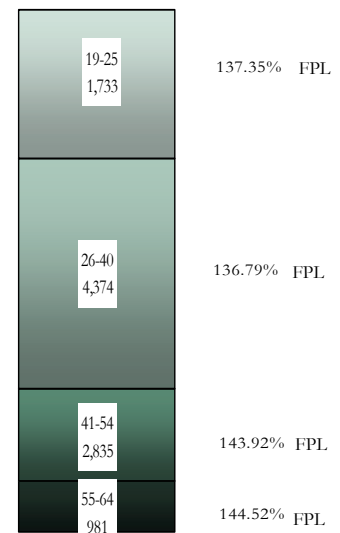

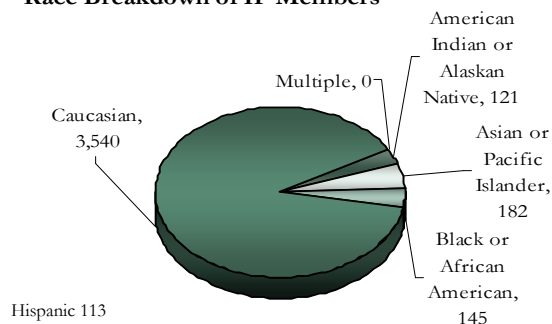

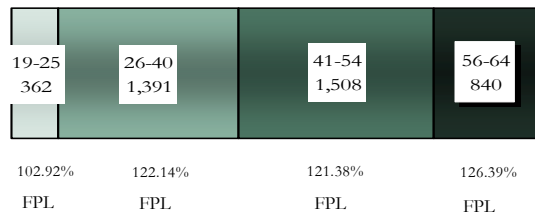

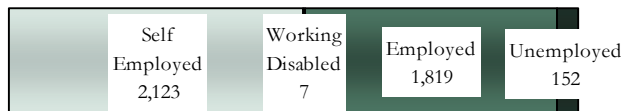

IP Age Breakdown with Average Federal Poverty Level for each group.



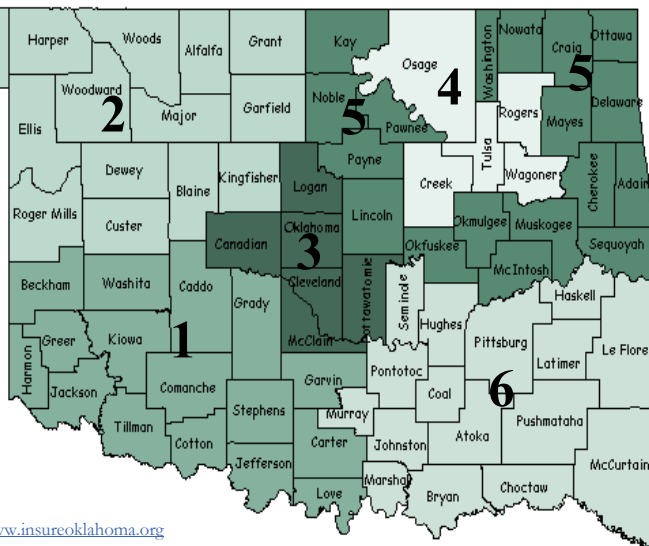
IP Application Type Breakdown
